TOPIC #1	Legislative Update
PRESENTER	Ed Bartlett, City Lobbyist
NOTES/OUTCOME	

- Ed Bartlett: session winding down. Still have to pass a budget. HB 473 passed Senate, returned to House. On House floor on Wed. or Thurs. Lowered tax increase and phases them in. Bonding and infrastructure – no action on either.
- Tina Volek, City: present to Council on May 1? Yes.
- Yakawich: HB134 status? Another study bill being presented. Juneteenth bill passed? On the agenda last week, not sure of status.
- Mayor: HB133 details? Brent Brooks, City Attorney, decriminalizing and eliminating jail time for disorderly conduct. Made some amendments to restore some portions.
- Brewster: 473 raise vehicle registration fees? Yes.
- Bruce McCandless, Assistant City Administrator: HB158 (Juneteenth) passed both houses.

PRESENTER	Joe Gilpan, Alta Planning and Design
NOTES/OUTCOME	

- Lora Mattox: introduction
- Joe Gilpan: will brief the introductory parts; existing conditions; public involvement; implementation strategies; programs and policies for construction and maintenance.
- Cromley: Lewis Ave residents don't like the bike lane, any provisions to move it to less busy street? Mumford: elks club to 24th section – residents asked how to reduce speed. Riders wanted to feel safer.

- Brewster: regulatory document? Mattox: not regulatory, use for grants when reviewing building plans. Bike access on 4th and 6th? 10' trail programmed in FY 18.
- Friedel: Lewis residents don't like route. Dangerous; statement, not a question.
- Swanson: law requiring helmets? Only below certain age.
- Yakawich: can this plan address practicality? Think it does and provides options.
- Yakawich: lane markings will need to be painted, costs unknown.
- Friedel: licensing and education important.
- McFadden: \$20k/mile; considered too expensive
- Hanel: thanks, good report and plan.
- Yakawich: question to Mumford about expense to maintain bike lanes. Paint arterials every year, more obscure areas not as often.

PRESENTER	Jennifer Duray, PW Finance Manager
NOTES/OUTCOME	

- Duray: brief presentation. Explains increases.
- Brewster: complaints from heights residents about conservation rates. City could increase base amount and reduce the highest tiers.
- Mumford: smaller user pays higher rate so higher user could pay lower rate.
- Brown: \$5 charge to call customers to let them know their payment is late? Approximately 16 hours per week dedicated to managing collections.
- Yakawich: support increase without residential included.
- Volek: consultant recommended increase. Billings is in the middle of cities rates.

- Tim Goodridge: answer questions and invite Council members to annual meeting on Wed. April 19 at 11:30 am. Notify media.
- Greg Krueger, Downtown Billings Alliance: presentation. Upcoming projects that Council will see – pocket park, MT Ave lighting, strategic plan, battle of the plans and CLDI bldg. improvements. Strategic plan developed in 1997: \$84,516 contract with Thomas Miller. Pocket park – 34 years old, plans drawn, ready to bid, up to \$200,000, need new agreement with the church.
- Cromley: pocket park up to \$200,000, who has approved? DBP Board, will come before Council. OBSC questions –
- Yakawich: like the pocket park, who will maintain? BID will maintain.
- Steve Zier, South Billings Urban Renewal: Tom Ruschkewicz died Tuesday, Shawn Hanser, stroke, in hospital, will remain on board for now. Optimist Park plan and SBURD wants to develop a north parking lot. Midland Rd at 30% design and will come to Council. Ponderosa School will ask for \$ for a south property fence/security.
- Yakawich: Tom Ruschkewicz asset to south side. Hallowell improvements being planned? Board has discussed Hallowell but no funding yet.
