CLG Training

On Thursday, September 27, WHC attended the dual CLG/Educators' workshop at the Montana History Conference. The workshop explored ways CLG projects can aide educators in teaching preservation concepts to their students.

National Register Nomination Research

WHC was able to secure snapshot reference images of the J.G. Link plans for the Billings Mausoleum from the archive in Bozeman.

Ann Kooistra-Manning continues to research and gather the necessary information. Her additional hours have added more information on the Billings Mausoleum at Mountview Cemetery and Riverside Park in Laurel.

Community Work
