Just another step

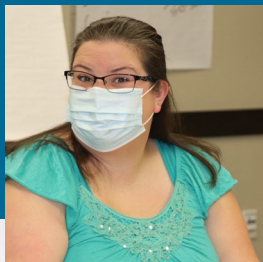

Walk With Ease report

Walking is good exercise, but how much difference can it really make? **Keely Ehmman**, prevention health specialist, found answers by analyzing data from the Walk With Ease program.

Sixty-eight RiverStone Health employees started the six-week program last fall and 48 completed. Upon completion, participants reported decreased levels of pain and fatigue on a scale of 1-10. For example, participants with arthritis reported an average pain level of 4.2 before the walking program and a level of 3.6 after.

Billings library staff volunteers for public health

For the past six months, Billings Public Library staff members have been redeployed to support our contact tracing and case investigation efforts at RiverStone Health. This was made possible by Library Director Gavin Woltjer with approval from the city.

On January 18, library staff teamed up with RiverStone Health contact tracers to finish filing thousands of hard copy COVID 19 case files. Our case investigation team and information support had devised an innovative computer-based information system in the midst of pandemic backlogs. The CIS tremendously increased speed and efficiency in contact tracing and made paperwork obsolete. But after transitioning to the CIS, we still had 11, 042 COVID-19 cases on paper, all of which have to be filed and preserved. That paperwork filled 81 volumes in two floor-to-ceiling

cabinets. Law requires these records to be preserved for several years.

Library employee Mary Leichner took the lead on this project and ensured that the data was correctly filed. Every case had to be indexed so reports can be located by name and number.

This big paper project was accomplished with the help of Billings Public Library employees **Victoria Coassou, Mary Leichner** and **Brenda Reiland**, and RiverStone Health employees **Cathy Grott, Danny Hawbaker, Mack Kautzman, Sydney Kern, Morgan Maus, Jana Richter** and **Christine Walker**.

In addition to working on the filing project, Mary Leichner and Victoria Coassou have been working part time on weekends doing case investigation and contact tracing. Library employees **Barbara Riebe, Carla Nordlund, Vanessa Justice** and **Tammie Peterson** also have assisted



with contact tracing.

Thanks to all the Billings Public Library employees who aided our community pandemic response.

TAX ABATEMENT PROGRAM

YELLOWSTONE COUNTY | CITY OF BILLINGS

In 1988 the State of Montana gave local governments authority to implement tax abatement programs. Since then, Yellowstone County and the City of Billings have successfully used the program to attract new businesses and grow existing businesses.

- **October 1994** | The 10-year incentive (MCA 15-24-1401/1402) was adopted in by the Yellowstone County Commissioners. **December 2005** | the City of Billings adopted the 10-year program
- **August 2002** | Yellowstone County Commissioners adopted the five-year tax incentive for remodel, expansion, and reconstruction (MCA 15-24-1501). **December 2005** | The City of Billings adopted the program.

TAX ABATEMENT PROGRAMS

5-YEAR PROGRAM

- Allows **tax reductions** on remodeling, reconstruction, and/or expansion of existing real property when a project makes improvements exceeding \$500,000 to the property.
- **Tax relief** is received only on the incremental increase in taxable valuation of the existing property.
- Under the Remodeling, Reconstruction or Expansion Tax Incentive Program, the property taxes levied on the value of the improvements may be **reduced by 100%** for the first 5 years of the project.
- After the 5th year, the property would return to its **full taxable value**.
- A **leased building** is typically not eligible for this tax incentive program as the owner of the property typically applies.

1st Year Following Construction: 0% Taxable Value
(100% Savings)

2nd Year Following Construction: 0% Taxable Value
(100% Savings)

3rd Year Following Construction: 0% Taxable Value
(100% Savings)

4th Year Following Construction: 0% Taxable Value
(100% Savings)

TAX ABATEMENT PROGRAMS

10 YEAR PROGRAM

Allows tax reductions under the New & Expanding Industry Tax Incentive Program, the taxable value of the real property can be reduced by 50% in the first 5 years. In years 6-10, the tax obligation gradually increases and the savings decreases until the full 100% liability is required and the abatement expires in year 10. Increase in years 6-10 is 10%. The 2017 MT Legislature passed House Bill 226 providing discretion to governing bodies to increase the application of tax savings regarding the 10-year program. Taxable value of the incremental increase in valuation can be reduced by 75% in years 1-5, then increased by 15% years 6-10. As with the 5-year program, this is for businesses owning the building as the owner applies. There are certain criteria; primarily that 50% of the company's revenues are generated from out of state. Job creation is also strongly encouraged for both programs.
