- 1. Legislative Update** – Tuesday evening I attended, and the City was one of roughly a dozen sponsors of the Senate Judiciary Committee dinner. Aimee attended the House Judiciary Dinner Wednesday evening. Both committees were instrumental in passing HB578. I suspect we will need to work closely with them during upcoming legislative sessions.
 - SB 385 – I testified in opposition to the bill Tuesday morning. As currently written, PD1 will sunset in 2024 unless the voters extend the district for another 13 years. We will need to reconsider a mill levy vs PD1.
 - HB 701 – this is one of the marijuana bills that will be heavily debated during the final days of the session.
 - SB 388 – causes problems with the Lockwood TEDD and any future TEDD.
 - See Crowley Fleck update
- 2. 2022 Proposed Budget** – much of the week was spent balancing the budget.
- 3. Quarterly Reports** – Attached are the quarterly reports for Fire, Police, PCSD, Public Works, SBURA, DBP and council initiatives.

Quarterly Report (January – March, 2021)

FIRE ADMINISTRATION

Quarter 1 of 2021 saw a bit of a reprieve from all of the COVID related issues. While some of the policies are still in place, the sick calls related to COVID have dramatically fallen off. Budget season started for the BFD around early February and while there is a bit of lull in the action, administration is still working with finance to fine tune the FY22 Preliminary Budget. We hope to receive three new full-time positions that we feel will help to alleviate a substantial amount of overtime and have the potential to generate revenue. Administration has also been in daily contact with our 911 Center in regards to SOGs, policy revision and implementation. The Fire Prevention Bureau (FPB) was able to use Cares Act funds to procure a new software platform that will modernize our way of doing business inspections. They have been diligently working with MobilEyz and the vendor to workout issues, integrate with our New World system and have the deputy fire marshals (DFM) up and running by May. If everything runs smoothly with the deputy fire marshals then we will roll the program out and train the suppression crews. Billings Fire received a generous donation from ACE hardware in the way of four new Traeger grills.

The 2021 Annual Report included several weeks of data analysis, article writing, and page design due to the incredible teamwork of Administration, Training, Operations, City/County 911 Center, and Fire Prevention Bureau. The report was published for public view on February 26th through the City Administrator's weekly report and is available on the Fire Department's website. The final product demonstrates the inspiring hard work of the men and women who contribute many unique and powerful skills to the Fire Department and City.

The administration's familiarization and use of the Decision Support System (DSS) have expanded reporting capabilities. The DSS extracts data from the New World database, providing large arrays of information gained by investigating specific data fields. One of many projects, administrative assistant Patrick Landry has developed is an interactive map overlay to identify the first responding units in fire station areas. Current projects include understanding 2020's first responding units within Station 6 and Station 7 areas. The map overlay illustrates all 2020 incidents in those specific areas. This mapping helps exemplify all responding units to filter and exclude the areas' respective unit, i.e., excluding Engine 6 from the analysis.

In another ongoing project, Patrick continues to develop planning for AMR response time analysis. Using the DSS, he has gained insight into shortfalls of standards in responses to EMS calls by AMR due to anomalies within New World and CAD.

Patrick presented his research to Executive leadership by giving examples of past reports and communication issues between 911's CAD and AMR's CAD. This research contributed to a vital part of the 2020 Annual Report goals, to continue evaluating EMS service delivery to ensure best practices utilization.

Patrick assisted Training Chief Biggins with instruction on National Fire Incidents Reporting System standards and New World navigation to the Officer Development Program. Patrick instructed the seven ODP candidates on general and specific coding topics to aid the candidates' future reporting when serving as Captain. Instruction included PowerPoint presentation, walk-through of New World, and incident reporting practice through the test server.

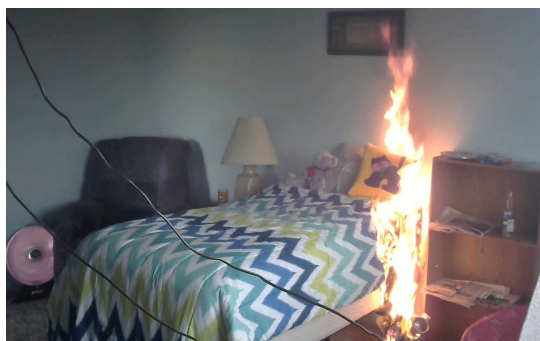
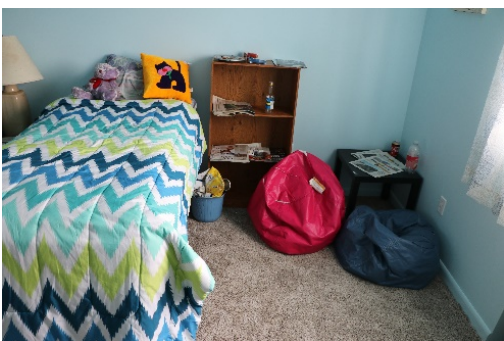

FIRE PREVENTION BUREAU

During the first quarter of 2021, the Fire Prevention Bureau (FPB) remained very busy and conducted 36 fire origin and cause investigations. In a typical year, this milestone would be met in July, not March. Unfortunately, it appears the trend of increased fires during the pandemic has continued into this year. Annual school inspections began in February. All public and private K-12 schools are inspected by the FPB as required by state law. During the end of March, the FPB conducted a test burn in the training facility burn cell at the airport. The burn replicated a typical single room fire that entered the post flashover state. This was done as a training exercise for the Officer Development Program (ODP). The ODP candidates investigated the fire using the origin matrix method. This training was well received by the group of upcoming company officers and will surely benefit them in the future. The following are a few photos of the burn:

OPERATIONS / TRAINING

The operations division of the Billings Fire Department has had very busy quarter as we continue to implement the recently updated Standard Operating Guidelines (SOGs) that were finalized last year. We are also working on expanding on the current SOG's and broaden the spectrum of operational responses they cover.

Keeping up with the COVID-19 Pandemic continues to be very challenging as well as it has taken a lot of resources normally dedicated to other operations and training duties and shifted them to helping keep our employees healthy as well as continuing to keep training in the forefront. We have been diligently adapting to the "new normal". Remaining prepared has been the ultimate goal amongst these very challenging times.

The Department continues to stay busy completing the long list of deferred maintenance projects such as:

- Completion of a new Stand-By Generator installation at Station 5
- Completion of major exterior repairs to the exterior of Station 6 due to damage sustained in past hailstorms
- Preparation for exterior repairs to be competed at Station 4 this spring and summer.
- Preparation for exterior repairs to be competed at Station 7 this summer.

During the pandemic of 2020, multi-company training in the BFD became almost nonexistent due to the need to socially distance, giving the organization the best possible chance to keep our members healthy. In 2021, our focus has developed into refreshing our members on topics that we missed in 2020 and refining ways to deliver training through other platforms.

In January 2021, the first two weeks of the year kicked off with Neo-natal Resuscitation Practices (NRP) offered via the Life-Size Cloud platform. This platform is similar to zoom and provided our first responders access to Billings Clinic L&D staff, also providing access to the most up to date science, which improves the quality of our training. The next few weeks of January was spent conducting the fit and flow tests on all 113 suppression firefighters. These tests are required annually and refreshes our members on the self-contained breathing apparatus (SCBA) which is used while entering IDLH (immediately dangerous to life and Health) environments.

February of this year kicked off with a refresher of Left Ventricular Assist Devices (LVAD). Billings has roughly half a dozen citizens that are on a heart transplant list and utilize the LVAD to keep their failing heart pumping. The BFD teamed up with the University of Utah to provide this training to our members.

The second half of the month was filled with the OSHA required refresher training on hazardous materials operations. Our department through the utilization of our BFD Hazmat Technicians provided this training. The BFD hazardous materials team has members inside the team that serve as toxicological paramedics. These members are required every two (2) years to re-certify the license to practice as such and this was completed in February as well.

March kicked off with continued training for the BFD/State-wide Hazardous Materials Team Response Team. This training was provided by a few subject matter experts that were brought into Billings through a homeland security grant that was secured by the team to train on Rapid Threat Identification.

March 15th kicked off our Officer Development Program. During this four-week training, we assign upcoming officers to five (5) eight-hour days allowing the training division to provide department specific training to upcoming officers that will soon be filling the company officer seat on the fire apparatus. The information provided, provides a refresher and new training on incident command techniques, firefighting tactics/strategies, policies and procedures, writing skills, leadership skills and much more.

The firefighters that remained on shift during this time refreshed their skills on structural fire apparatus response to aircraft incidents. This training was offered to our organization through the Aircraft Rescue Department at the Billings Logan International Airport.

HAZARDOUS MATERIALS TEAM

This quarter, the fire department's hazmat team had two callouts, including a mutual-aid request to Lockwood for a severely damaged trailer likely due to a drug-related explosion. While on-scene, BFD hazmat technicians performed air monitoring, scene safety and used their advanced chemical analysis equipment to identify unknown products at the site. The hazmat team also participated in a grant-funded training opportunity with hazmat technicians from Bozeman, Great Falls, and Missoula fire departments and members of the Montana National Guard. This hands-on training focused on determining the nature of unknown substances through a series of tests and the application of hazmat chemistry. Three of our hazmat technicians were featured speakers at the Montana Narcotics Officers Association (MNOA) annual conference. The result of this training is improved collaboration between fire and law enforcement officers and enhanced officer safety. Members of the hazmat team continue to pursue our grant-funded hazmat Unmanned Aerial System project funded by Montana Disaster and Emergency Services and the U.S. Department of Homeland Security.

Billings City-County Emergency Communications Center

A Division of the City of Billings Fire Department

Quarterly Report April, 2021

The Billings City/County Emergency Communications Center (COMMCENTER) continues its 24/7/365 mission of connecting the public with their emergency responder functions.

Mission Scoping

Under new leadership, the COMMCENTER is in the beginning stages of entertaining a series of scoping sessions to create thoughtful time to consider the most appropriate role for the Center in the ever-changing world of emergency services and the public's growing need.

This includes time to review existing mission statements, policies, and protocols, and have constructive conversation related to the orientation of the Center. These conversations encompass employees, supervisors, management, and a vast array of emergency response organizations, numbering more than 30, which rely upon the COMMCENTER to initiate and facilitate varying degrees of their responder functions.

In just short time, it is apparent that the traditional role of the Center must change and become better positioned and more adaptable to increase its scope and color of assignment. The Center is currently working on constructing a vision and its implications to expand from a simpler call-taking and deployment model to also include a dedicated level of focus upon the coordination of resources and facilitation of rapidly emerging events in order to better allocate and utilize existing resources and become a force multiplier for the panel of different agency commanders which exist.

In simple form, the COMMCENTER is focused upon becoming a "one-stop shopping" resource for the needs of the Commanders of our Police and Fire Departments to complement their and better support their on-scene efforts.

9-1-1 Center Technology

The COMMCENTER is in the process of both reviewing our existing technologies capacity to adequately carry us into the future, and considering the implementation of several form of newer technology.

PHONES-The City of Billings was awarded a “911 Fund” grant by the State of Montana to upgrade its entire telephone system from analog operating mode to a more capable IP-based and digital “EsiNet” system. Planning has begun and requires continual coordination with numerous vendors and will eventually conclude with the installation of hardware within the Center and finally a “flash” rollover to the IP system. This will allow for an expanded caller profile to be sent to operator consoles complete with accurate and momentary updates to caller location, stored emergency medical information, and will sustain a connection under pre-emptive circumstances when prompted. In literal form, this will allow our operators and responders both to have an accurate (within 3 meters) and timely (updated every 5 seconds) profile of each caller. When you think of the Rims and/or the River, this is especially important information that would now be available to responders.

RADIOS-The City of Billings’ 800 MHZ, Phase I Trunking, is coming to the end of life in in the Spring of 2023. This means that the entire city radio network used by the varying departments will no longer be supported by a maintenance contract, essentially meaning that it is “out of warranty”. Additionally, many integral parts of that radio system will no longer be technologically supported. Significant planning is underway to understand what options may exist to replace our current system, and what capacity the City would require for the next 10-15 years in a radio system. Ultimately, this will result in each and every radio user in the City being required to purchase new portable and mobile radios at the least. In addition, as the footprint of the City expands, a new system must be designed to provide radio coverage in areas such as Ironwood Estates, or the Alkali Creek and Billings Inner Belt-Loop areas, where now there exists little if any coverage.

COMPUTER AIDED DISPATCH: Or “CAD” is the software system which records, deploys, and provides commonality to all responder forces directly with their dispatcher. In addition to CAD, the varying responder agencies employ a number of 3rd party applications for deployment of resources, organization of personnel, and varying degrees of notification. Our current software system is fully capable of delivering the same with lesser costs associated and more robust control of the delivery mechanisms. Efforts are underway to begin utilizing our existing system, a top-of-the-line product, to a higher level of functionality in order to reduce the need of replication by responder agencies to do the same.

OPERATIONAL PLANNING w/ RESPONDER AGENCIES

As a facet of increasing the COMMCENTER's utility to responder agencies, and better serving the public, and in line with its future mission scope, the Center has begun a review of its dispatching protocols and available tools to include the use of expanded modules of its current CAD system to begin functioning more robustly in support of rapidly emerging incidents.

This process includes an evaluation of dispatching methodologies, cataloging resources, and reviewing responses plans associated with certain incidents types to enable CAD to bring forward organized lists of available resources and assets for deployment. Eventually, this function will support on-scene Commanders and Emergency Management personnel by displaying pre-planned assets and resources without further thought or manual deployment. As the City grows, acquires more resources, and experiences the changing needs of the public, this tool will allow both the Center and its responders to perform relative resources management techniques without question.

RECRUITMENT AND RETENTION

This subject is the #1 priority and area of concern for the Center Management

Recruitment of new employees and the retention of existing employees continues to be the single most complicating factor for the COMMCENTER. With an allocation of 31.5 operators within the bargaining unit, our current roster is holding steady at 24-26. This means that each week the Center is experiencing 20-30 extra (overtime) shifts per week with most employees working 80-100 hr. work weeks including 4-12/hr. days and 1-16/hr. day. The burn out rate is a concern, and the process intricate to the Center for hiring and training new employees is cumbersome at best.

Additionally, the current Collective Bargaining Agreement articles create rather tough circumstances for new employees which are nearly absurd. Combined with low pay, no career path, little to no continuing education, and workplace conditions commonly associated with this career, the retention of employees remains a limited prospect.

Without a considerable reconfiguration of our existing workforce and the cooperation of a willing bargaining unit, this single factor alone will create the most challenge to bringing the COMMCENTER to the place where it needs to be.

As the scoping and planning for the Center progresses, the Management continues to work with the Union in matter of configuration of existing staff and policies in order that it not impede the needs of the Center to fulfill the necessary role within the community.

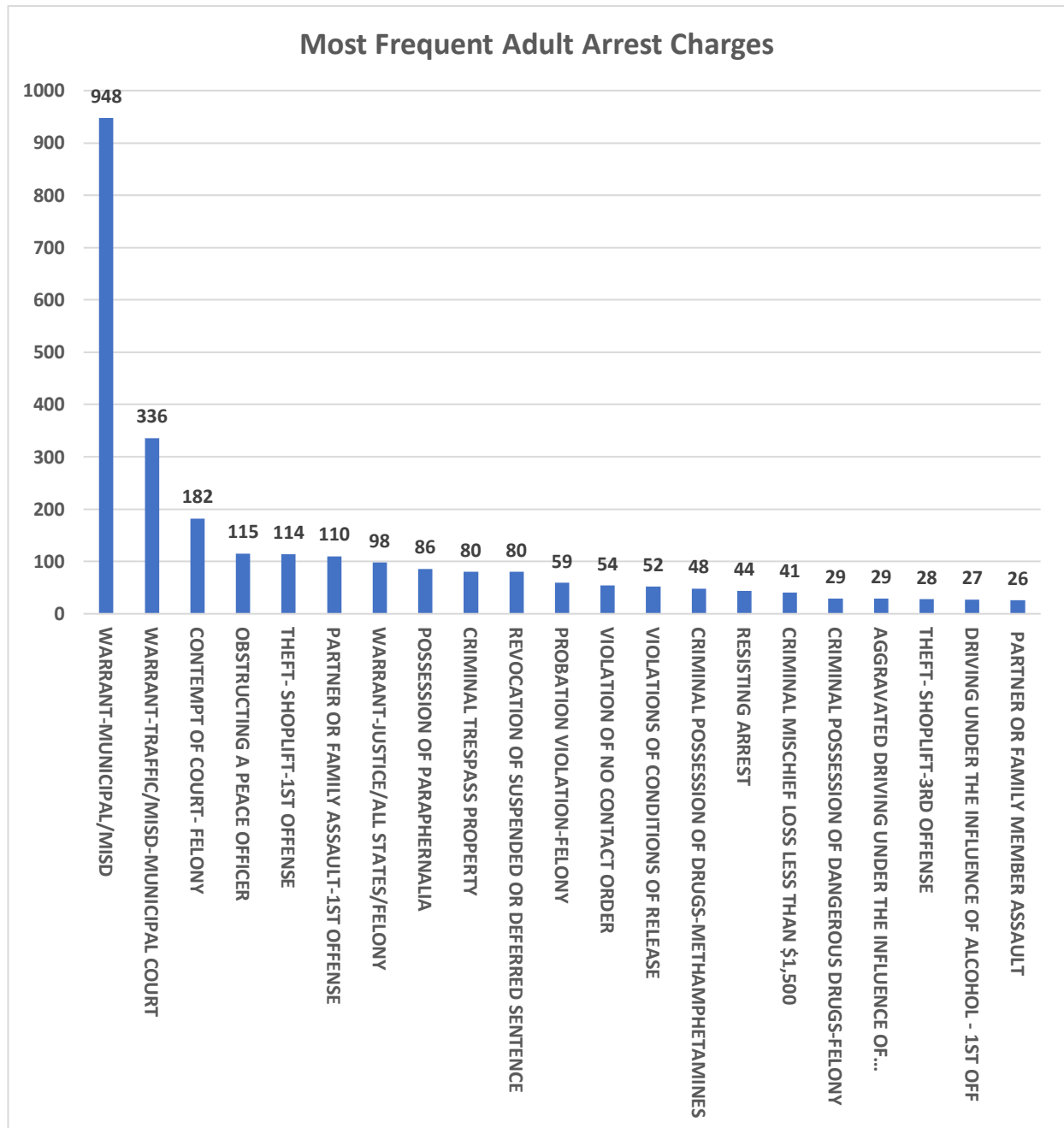


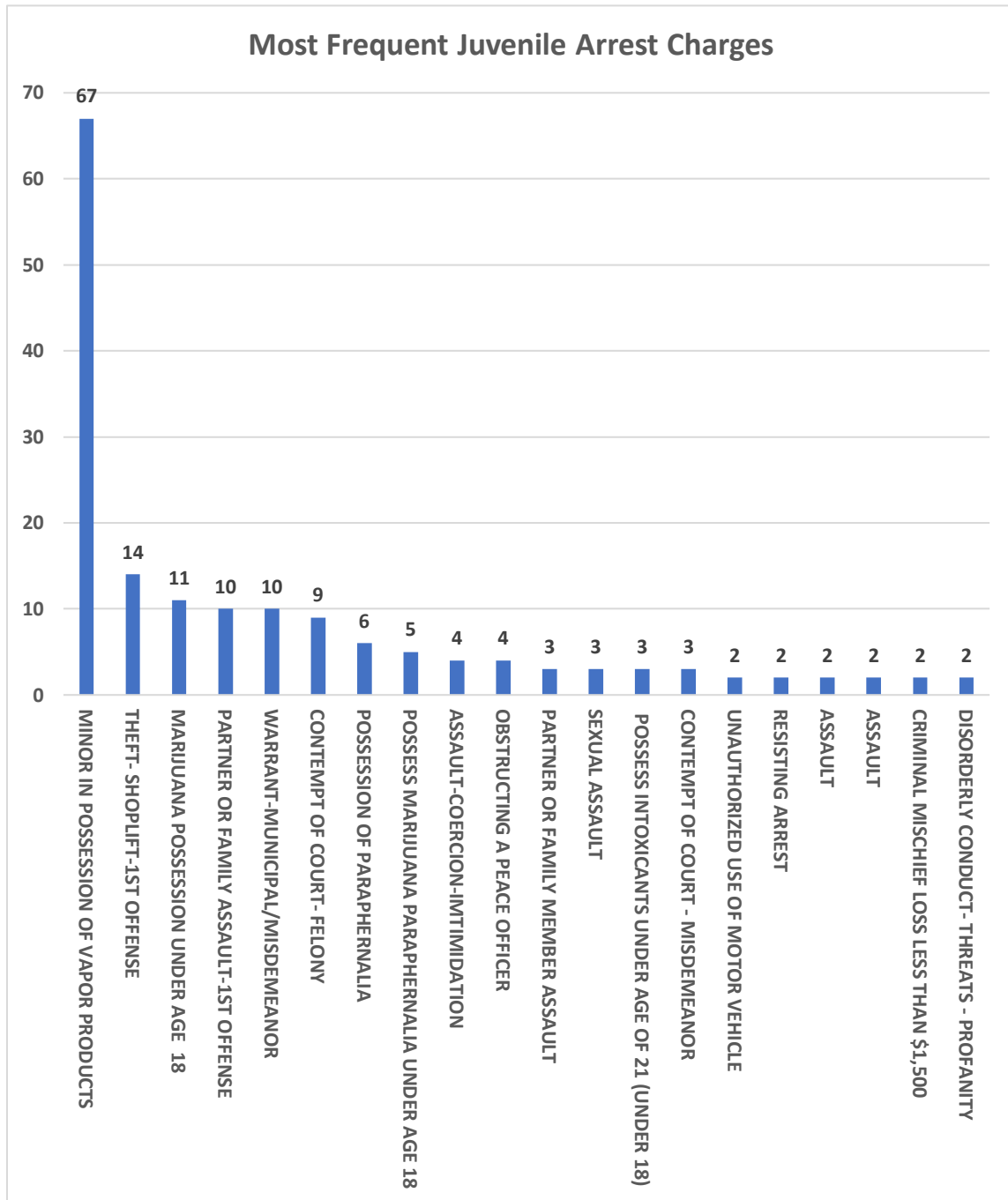
Calls For Service are created when officers are dispatched to, or locate, an incident.

These numbers represent the contacts and calls for service created during the overtime details throughout the month focusing on pro-active policing and crime prevention throughout the City. The details this month were as follows:

Downtown Patrol: This detail was created to coincide with the presence and enforcement action taken by the DBA Officers. These shifts are scheduled to start at the end of the DBA Officers shift in an effort to extend the amount of coverage the downtown area receives. The Officers are asked to focus on quality of life issues such as open container, trespassing, jaywalking, ect.

Proactive Theft Patrol: This detail is city wide and focuses on putting Officers in both residential and commercial areas of the City with the goal of having a presence and deterring theft, recovering stolen property, and/or making arrests of suspects engaged in this behavior. Officers are encouraged to utilize street crimes and crime mapping to determine areas to focus on.

Traffic detail: This detail is city wide and was created to focus on targeted traffic enforcement specifically at and around the ten (10) intersections within the city which have the highest traffic collisions. Officers are asked to pick times with high traffic flow.

Domestic Violence follow-up: This detail is to assist the department's Domestic Violence Investigator in conducting essential follow-up on already charged cases. This follow-up focuses on keeping the victims safe after the initial arrest and holding defendants accountable to victim intimidation and violations of no contact orders.

Planning Implements Electronic Review of Certificates of Surveys and Subdivision

As of April 5th the Planning Division implemented the use of Electronic Plan Review (EPR). This has been a service the division has been working hard to achieve over the course of the last three years. This is a new technology that many users across the City and County will need to get used to. The ultimate goal in implementing this technology is to speed up the review times for our customers submitting Certificates of Surveys and Subdivision Plats. Until this point, our review process has included a physical routing process that can take weeks and only allows for sequential reviews. The addition of EPR allows for concurrent digital review. The initial rollout of EPR only focuses on COS's. Once our users and customers have mastered this we will move towards implementing this process for subdivision. The Division is offering this service in coordination with the Building Division as they are utilizing the same software to serve customers by digitally reviewing building plans.

MLK – Food Box VISTAs

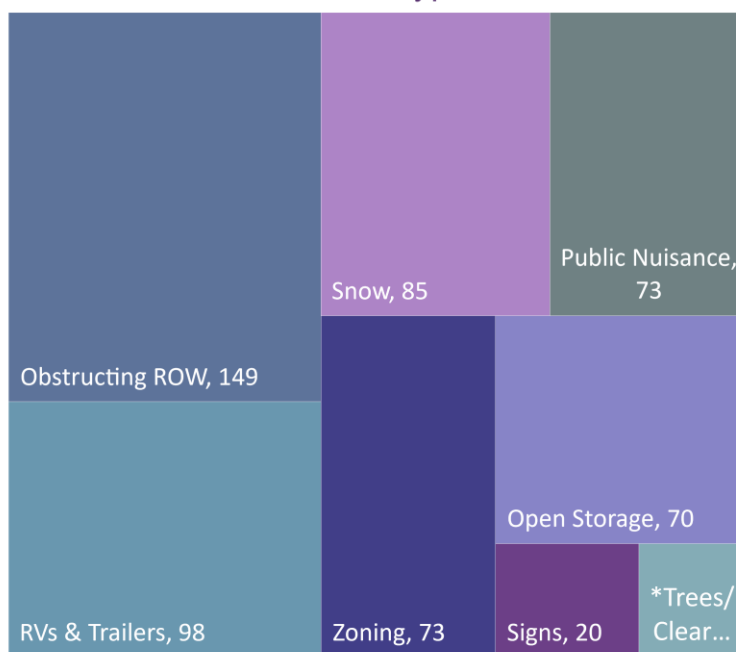

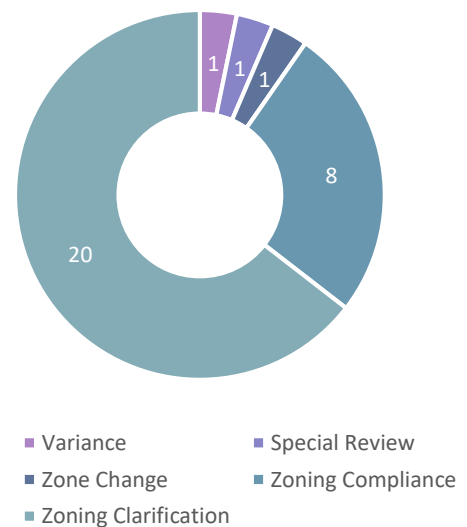

Public Works has had a lot of retirements over the last year and while we are struggling to fill many positions, we have been lucky to get some very talented people on board. Within the management team, we have a new City Engineer and a new Street/Traffic Superintendent. Hopefully by the time this goes to print, we will have a new Solid Waste Superintendent as well. With a team of eight, having three new managers gives us a lot of new energy and ideas!

In our Distribution/Collection division, we have over 80% of the people on the crews that have been hired within the last 5 years. It may take a bit of time to get the crews trained to the level of expertise that we lost over the last few years, but once that is done, we will be a force to be reckoned with! Our Environmental Division has had a 75% turnover this year. Again, we sure miss the expertise we had in our retirees, but we have been able to hire some amazing replacements. We have not been as lucky in our seasonal hires. The fact is, most of what we do requires people and we have not come even close to filling our seasonal vacancies. Last year, we hired 1 out of 10 for Street/Traffic, 4 out of 6 in Distribution/Collection, and 8 out of 13 in Solid Waste. If we can't find qualified people, we can't provide the service we want to provide so please encourage people to apply for these positions if you know anyone!

Since starting this position last year, I have been able to spend time with each division and I will tell you that this city is fortunate to have the expertise, dedication, and talent that we have in PW. I wish the entire city could see how hard everyone works in often thankless jobs. Public Works week is May 16-22 and if you see a city employee out working hard, think about stopping (in a safe place) and telling them thank you. Help Keep Billings Ditches Beautiful and Healthy



As a resident of Billings driving through town, you have likely crossed an open ditch to get to your destination. Some may be dry depending on the time of year, while others may have water year round. These ditches have several benefits such as providing water from the Yellowstone River for irrigation needs, recharging the area aquifer, and providing groundwater and agricultural discharge. Another crucial role is providing a discharge for rainwater and snowmelt collected on our City streets. Because the ditches provide these benefits, it is critical they are free of debris to remain flowing, which will minimize potential flooding and reduce impacts to the Yellowstone River water quality.

The City, in cooperation with the ditch companies, would like your help to maintain ditch sections through or adjacent to your property. Because of the interconnection between the ditches and the City stormwater system, dumping of debris violates Section 28 of the City Code and State Law 75-5-605 - Prohibitive Activity. Water from the ditches discharge into the City's stormwater system at several locations before eventually releasing into the Yellowstone River. This discharge is currently not treated by the City; unlike the sanitary sewer system which is treated at the Water Reclamation Facility (WRF) before discharging into the river. Homeowners and landscaping crews working near or adjacent to these ditches should not dump or throw anything into them. Any dumping of yard wastes, chemicals, pet waste, trash or even loose dirt on either the ditch bank or within the ditch, can potentially cause water quality issues. Another major concern is blockages in the City stormwater system, which can increase the potential for flooding, causing the ditch banks to overflow.

The ditches and drains are controlled and maintained either through ditch easements or prescriptive rights by private ditch companies. Please remember permission from the ditch companies is required to divert or alter the course of the ditches, construct ditch crossings (i.e. fences and bridges), discharge stormwater, and to use ditch water. In most cases, the City of Billings does not have any ownership or maintenance responsibility relating to the ditch system, other than repair and replacement of street culvert crossings.

Things you can do as a homeowner or landscaping crew working adjacent to a ditch:

1. Keep ditch easement area free of yard waste and grass clippings
2. Do not divert the water in any way unless you have confirmed permission
3. Only remove water from of a ditch if you have rights or shares in a ditch that allow such
4. Remember that owners of a ditch have right-of-way that are relevant to cleaning & repairing the ditch
5. Avoid building permanent structures near ditches for ease of maintenance

WORKING SMART DURING THE PANDEMIC

For most of the Public Works Department it was 'business as usual' during the pandemic. However, COVID-19 posed some challenges when trying to limit unnecessary contact and potential exposures to staff and the public while still maintaining service and efficiency levels.

Our spirit of Innovation kicked-in to high gear, a prime example was made by our Distribution & Collection Division's Meter Service work-group. Faced with the inability to continue the replacement plan for aging meters, a task which in most cases requires entry to homes, they shifted their focus to updating meters in meter-boxes. There are 400 meter boxes and vaults in service and about 250 have been inspected already, with repairs or replacements taking place as needed.



Additional work addressed included curb box and curb valve location and condition assessment.

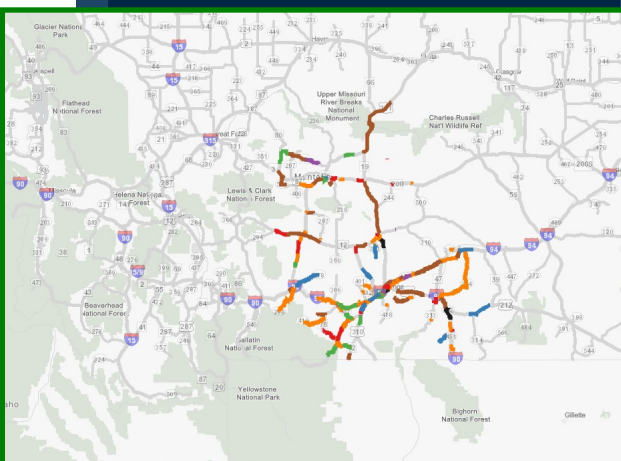

CONSTRUCTION SEASON

Some of the projects you will see around town this summer will be managed by the Montana Department of Transportation (MDT). Information and updates are available through their website at mdt.mt.gov.

- **Main Street:** This project will resurface Main Street located in the Billings heights between 1st Ave N and Pemberton lane. Additional work will include replacement of the raised median, upgrades to the traffic signals, new ADA compliant sidewalk corners, and LED heads installed on the existing street lights. Electrical work has already started and the concrete work will begin mid-April. The paving will start in July and be completed in the fall.
- There will be some cleanup work on S. and N. 27th Street West this summer.



Annual Spring and Summer Paver Program

The Paver Program identifies and provides necessary asphalt repairs to streets throughout the City. The City uses three methods to repair paving: crack seal, chip seal, and overlay. In addition, some spot damage is repaired by digging out the poor soil, adding gravel, and re-paving. The method used is based on the degree of damage being addressed.

The crack seal process prevents additional cracks in the street surface. The cracks are caused as asphalt ages and the freeze/thaw cycle occurs, leaving hairline cracks which can spread and deepen allowing water to infiltrate and freeze. The crack seal process fills narrow cracks in previously overlaid streets. Filling a few cracks now with molten rubber will ensure that the surface is sealed and help to extend the serviceable life of the pavement. In addition to the hot rubber application, the City will be using a mastic product to fill some of the larger cracks, potholes, and low spots. The mastic product adds a structural element back to the road, which a traditional crack seal cannot provide to streets. The City will be using mastic on sections of Moon Valley Road, Ironwood Subdivision, Lampman Subdivision, and St. Andres Drive.

The chip seal process actually begins with “dig-outs”, which are areas of a street that have failed, have sinking sections, or large pot holes. Crews dig up part of the street and then replace the section with 2 -3 inches of asphalt depending on the road type. The City identifies failed sections of roadway every year.



The overlay process replaces deteriorated asphalt surfaces with new asphalt. Generally, the top two inches of the road is milled out, but if problem areas are exposed, another few inches of asphalt is milled and the area is repaired. The surface is prepared and a new layer of asphalt paving is placed.



This year, the City will be overlaying King Avenue West from 31st Street West to Shiloh Road, Rimrock Road from 27th Street to Virginia, 4th avenue North from Division to 27th Street, and South Billings Boulevard from King Avenue East to Underpass. Each location will typically take about a week to complete the pavement overlay, weather permitting.

CONSTRUCTION SEASON - 2021 SUMMER PROJECTS

The following projects will be undertaken by the City this year:

- **New street construction** of Songbird Drive, a local commercial street, to allow additional connectivity from Josephine Crossing Subdivision and Riverfront Pointe Subdivision to Midland Road.
- **Reconstruction** of Hallowell Lane from State Avenue to King Avenue East, to add parking, sidewalk, storm improvement, and water main replacement. This project is slated to begin in May and be completed in September.
- **Reconstruction** to about 1,000 feet of Harrow Drive including water main replacement north of Rimrock Road.
- **Reconstruction** of Park Lane, Highwood Drive from Rimrock Road to Poly Drive, Highland Park Place, Circle Drive, and Highwood Circle, for widening, replacement of deteriorating roadways, and water main replacement.
- **Reconstruction** of 32nd Street West from King Avenue to Gabel Road. This important connector road will be widened to increased traffic capacity and provide safety improvements.
- **Reconstruction** of Wicks Lane includes widening from Bench Boulevard to Hawthorne Lane, and on-street bike lanes on each side. Other improvements are new curb and gutter, sidewalk on both sides, driveway approaches, ADA ramps, and storm drain improvements. Work will generally start around June 7 and be complete by September 1, 2021. The street will be under a full road closure, with residential access being maintained. The Kiwanis Trail will remain open.
- **Annual Lead Services Replacement Project.** In combination with the annual water replacement project, this project will remove approximately 145 lead services from the system. This project will occur along Lewis Street from Division to 8th Street West, Clark Avenue from Division to 7th Street West, the College Streets from Wisconsin to 13th Street West, North 15th and 16th Street north of 6th Avenue, Avenue B from 1st Street to 3rd Street West, and a portion of Burlington at 7th Street West.

- **Annual Water Replacement Project.** Aging water mains will be replaced in the Pioneer Park area along the following streets:
 - 1) 2nd Street West from Grand Ave to Burlington Ave.,
 - 2) Burlington Ave. from 2nd Street West to Division Street, 3) Avenues B through E, from 3rd Street West to North 32nd Street,
 - 4) 1st Street West from Avenue C to Grand Avenue.

In addition, a section of water main within 12th Avenue from 27th Street east to North 22nd Street will be replaced, budget allowing. This annual project will replace up to 8800 lineal feet of water main, 92 lead services, and will take much of the summer to complete. Residential homes will have temporary water connected to continue water service while the water pipe is being replaced.

- **A new traffic signal** is planned for the intersection of Virginia Land and Rimrock Road, and is expected to be completed by the end of summer 2021.

- **Water mains** will be replaced in the vicinity of Normal Avenue and Rimrock Road over the period of about a month, west of the MSU-Billings campus, starting at the end of May.

- **A new 60-inch diameter sewer interceptor** pipe will be constructed parallel to the Yellowstone River on the eastern side of the Metra Park facility to expand sewage flow capacity and redundancy.

- **A new sewage lift station** will be constructed on the west side of Alkali Creek to improve the efficiency of the Wastewater Reclamation Facility. This project will also improve flow characteristics by reducing sedimentation and back-up within the existing sanitary sewer system.

- **The Annual Missing Sidewalk and Miscellaneous Sidewalk Program** will replace and complete sidewalk throughout the City. The three main work areas include 24th Street West from Grand to Broadwater, 11th Avenue North from N. 22nd to N. 27th, and Aronson Avenue from Nutter to Governors. Work has started and is close to being finished on 11th Street, and will then proceed to Aronson Avenue, with an estimated time of 4 weeks to complete. The remainder of the project will be completed by October 31st.

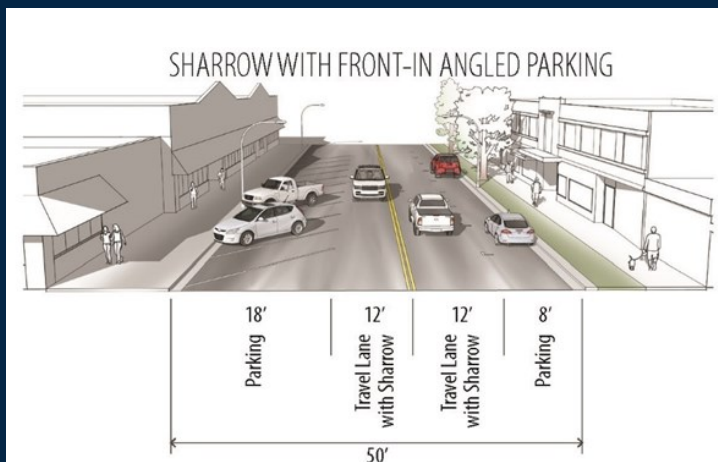

Downtown Two-Way Conversion

A City project to convert North 29th Street and North 30th Street from one-way to two-way traffic is anticipated to start the week of April 12, 2021. Contractors will work to modify traffic signals at 12 intersections to accommodate the change, as well as resigning and restriping the corridors from Montana Ave. to 6th Ave. N. The project has generated positive feedback from both the public and businesses, and will provide numerous benefits to the downtown commercial corridors.

- Two-way streets offer important advantages in commercial corridors:
 - They facilitate an appropriate amount of traffic
 - Provide a safe environment for pedestrians
 - Support a good location for small business
 - Property values tend to rise at a faster rate on two-way streets than one-way streets
 - It is on these slower-paced, two-way commercial streets that pedestrian shoppers, diners, and downtown visitors feel the safest and most comfortable.

Ditch & drain maintenance has already removed approximately 200,000 cubic feet of material from the Shiloh drain & Shiloh Conservation area.

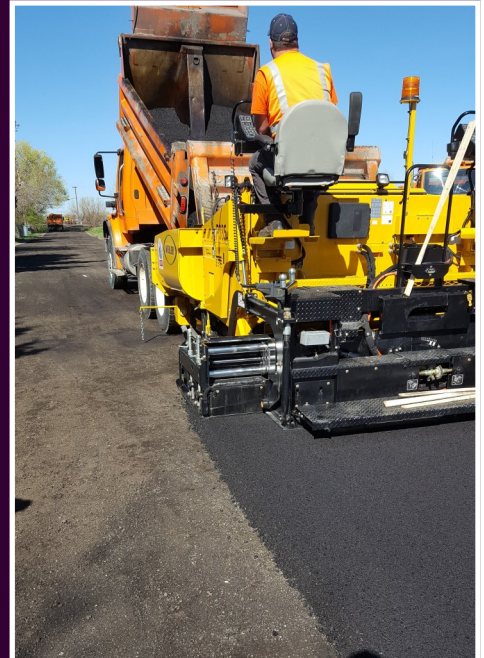
Public Works was also able to make repairs to a washout on the Hogan Slough, pictured below and right.



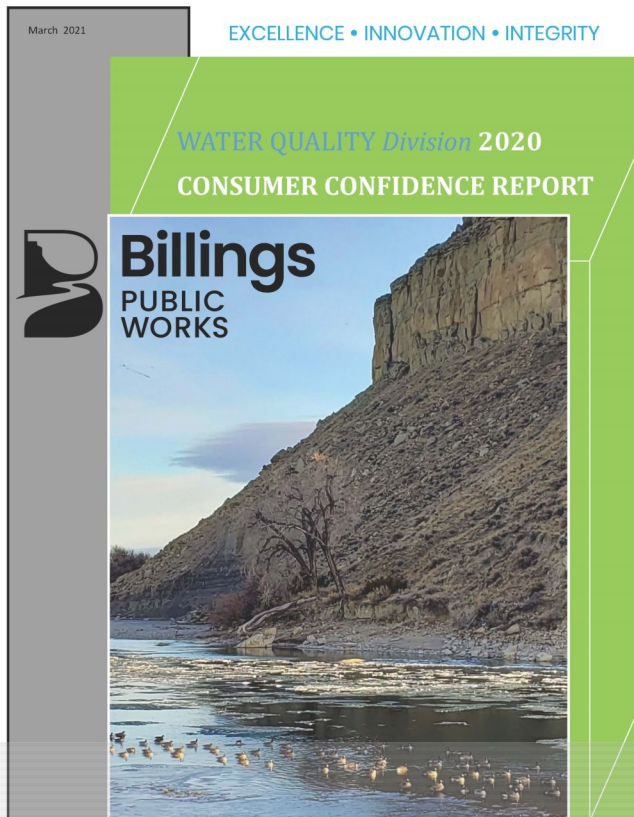

Call 406-657-8285 for more information, or to request a container. Place your yard waste out for pick-up by 7:00 AM on your collection day and remove from the street after collection has been made.

Acceptable Yard Waste

Types of yard waste to place in your container include:

- Garden waste
- Grass clippings
- Leaves
- Shrub pruning
- Smaller branches or twigs
- Weeds

Branches Code Requirements

Billings Code 21-205 requires the following for branch yard waste collection:

- Limit all pieces to 4 feet in length and 6 inches in diameter.
- Tie pieces in bundles and limit bundles to 75 pounds in weight and 2 feet in diameter.
- Place bundles near designated collection site at curb or in alley.

Non-Acceptable Yard Waste

Do not place dirt, sod, rocks, animal droppings, or any other refuse in your yard waste container. **DO NOT BAG YARD WASTE, place it directly in the container.**

Lawn Services

If you have a lawn service doing your yard work they are required to haul off the yard waste that they generate.

The new drop-off facility at the Landfill is open to the public!

Design concept pictured above and the completed building is pictured below.

The new Drop-Off Building at the Billings Landfill is a fully enclosed, 60,000 sq ft building with large overhead doors, for commercial and residential customers to enter and unload garbage and typical household waste—without having to access other areas of the landfill.

Upon entering the Landfill, customers will drive up the hill, cross the scales, and follow signs to the Drop-Off Building. Solid Waste staff will give directions to a designated area inside the building where waste can be unloaded directly onto the concrete “tipping” floor, then workers will push the waste through openings of the floor into large transfer trailers in the tunnel below. When filled, staff will haul the trailers to the active face for landfilling. This will greatly reduce the amount of potential blowing trash outside, reduce impact to neighboring properties and enhance the overall customer service experience.

There are also dedicated areas outside the building where recyclables, construction debris, branches, large bulky items, and household hazardous waste can be dropped off. The facility began operation March 16, 2021 and provides a safer environment for both workers and customers.

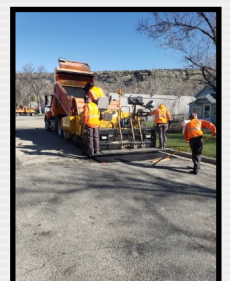

Subject: SBURA report for the period January 1, 2021 to March 31, 2021

The following is a report from the South Billings Urban Renewal Association (SBURA) related to activities in the South Billings Boulevard Urban Renewal District ("the District") for the period January 1, 2021 to March 31, 2021.

Administrative

Carolyn Rukstad's term as SBURA board President as one of three bylaw-mandated "Enterprise" directors (i.e., the board member must own a business in the District) ended on February 1, 2021. The SBURA published three weekly public notices requesting volunteers for this position during December 2020. Carolyn Rukstad was the lone applicant for this position and was voted in unanimously at the February 2, 2021 board meeting.

Expansion of South Billings Boulevard Urban Renewal District

On December 21, 2020, Wyeth Friday, City Planning Director, and I presented to City Council our initial research concerning the possible annexation of properties into the District. We identified three properties located south of I-90 along the Frontage Rd, a single property at the intersection of Jackson Ave and King Avenue East and two City-owned properties as being logical candidates for annexation. After much deliberation, the City Council voted 8-3 to authorize Wyeth and I to continue our efforts for expansion.

During the quarter ended March 31, 2021, the City withdrew its intention to annex one of its properties in the District, namely the land purchased for expansion of the Billings Operation Center. At present, the property at the intersection of Jackson Ave and King Avenue East has submitted a request for annexation into the City. One of the properties along the South Frontage Rd is expected to change ownership in May and will likely be annexed into the City shortly thereafter.

I have drafted SBURA's Statement of Position regarding expansion of the District. The board is expected to adopt the Statement at its April 6 board meeting. Following this, Wyeth and I will present the afore-mentioned Statement of Position to the City Council at a date to be determined. The Council will then decide to approve a Resolution of Intent and set a public hearing date.

CLDI Tax Increment Application

On November 10, 2020, Eric Basye of Billings Community Leadership & Development Inc. (CLDI) presented an application for \$58,100 of tax increment assistance to build a home on Viceroy Lane for resale to qualified low-income applicants. These funds effectively reduce the debt service required of CLDI-vetted home purchasers who have overcome significant adverse life events and seek home ownership. The SBURA board approved their application to move forward to City Council. After SBURA's approval, I became aware of certain aspects (e.g., sale of the property & composition of estimated project costs) of the award that would likely face

significant City Council opposition. I contacted Mr. Basye and was able to address these concerns. In addressing these concerns, I believed we had materially changed CLDI's application and would require CLDI to reapply for assistance. The SBURA board intends to re-hear CLDI's request for tax increment assistance at its April 6, 2021 board meeting.

Newman Elementary Tax Increment Application

At SBURA's March 2, 2021 board meeting, the Newman Elementary PTA presented an application for \$61,200 of tax increment assistance for improvements (e.g., trees, benches, shelter) along Newman Lane where parents pick up/drop off their children for school. These improvements will help beautify the neighborhood and provide community amenities adjacent to the open grassy areas that are used by a host of organizations. The SBURA board tabled the application pending additional information about the PTA's intentions for additional improvements beyond the ones mentioned above. The SBURA board will continue hearing the PTA's application at its April 6, 2021 meeting.

Capital Projects

- **Optimist Park** – \$304,986 of TIF funding is included in the Parks & Recreation FY21 budget for the installation of a picnic shelter, picnic tables, park benches, disc golf and lighting. Per Parks & Recreation Planner Mark Jarvis, the Parks & Recreation Department:
 1. Has picnic tables on hand and ready for installation.
 2. Will be bidding the shelter at the end of April.
 3. Has benches on order.
 4. Is coordinating with Northwestern Energy to install security lighting.
- **King Ave East** – This project is complete.
- **South Billings Recreation Center** – During the quarter, the SBURA entertained the possibility of incorporating a football/track stadium on land adjacent to Amend Park. The Yellowstone County Commissioner's decision to not build a stadium to host School District 2 athletic events at MetraPark precipitated this possibility. After discussion with School District 2 officials, the School District elected to focus their resources on redeveloping Daylis Stadium.

Concurrent with the above activity, SBURA created a separate committee consisting of three board members and myself to take ownership of developing a recreation center. This committee will use the Victus and A&E studies as well as input from prospective user groups to develop a specific concept plan for presentation to City Council.

- **Hallowell Lane** – WWC Engineering and Sanderson Stewart have finished their design works for the sewer and water main systems, respectively. Public Works has received bids which indicate approximately \$1,000,000 of unforeseen construction costs, mainly attributable to labor and concrete costs. The SBURA board believes these additional costs can be managed within its current cast forecast. Construction is planned for the period May to September.
