

Billings City Administrator Weekly Report

March 17, 2022

- 1. Yellowstone River/Water Supply Update** - You recently received information on the snowpack that affects the Yellowstone River from KC Williams. City staff is aware of the snowpack and can provide information about how our water system may or may not be affected. The City of Billings completed a drought study in 2019. The drought study revealed that even under a scenario of a 1000-year drought (99.9% exceedance), the intakes at the water plant will supply the necessary water for our city. The City of Billings has two intakes that supply water from the Yellowstone River. One of the intakes is embedded deep in the shale of the river bottom ensuring water availability even under the most dire circumstances. Water Treatment Plant capacity remains the primary limitation during hot, dry summers and is the issue we had last summer. If we see similar prolonged hot, dry weather resulting in peak demands for an extended time, we may have the same challenges with supplying water. Water plant staff has been improving capacity in the main river pump station through pump efficiency upgrades. Additionally, HVAC upgrades are being made to the High Service Pump Station to better handle extreme weather. These activities will help if we see the extended high demands this summer. As for the river level, currently, the Yellowstone River basin has 70-89% of normal snowpack so we do not expect to see the river reach the 1000-year drought level that would impact our ability to pull water from the river.
- 2. Parks and Recreation Summer 2022 Activity Guide and Redesigned Website** - Get a “Sneak Preview” of the Parks and Recreation Department’s upcoming Summer Activity Guide (attached). The Guide is currently at the printer with a scheduled release date of April 1st. Our Activity Guide will be available as an insert in the April issue of Simply Local Magazine. The Department also utilizes direct mail to reach almost 10,000 of our recent customers. In addition, the Parks and Recreation staff will also be delivering the Guide to all local elementary schools during the first week of April. Registration for summer opens on April 1st with all programs viewable on our newly redesigned website www.billingsparks.org. We anticipate another great community response to our quality summer program schedule.
- 3. Small Cell Status** - After the small cell work session last month, city staff has been working to create drafts of the necessary documents to develop a program for small cells in the public rights-of-way in Billings. The work session was intended to introduce the City Council to the small cell issue and to allow staff to hear the concerns that City Council members had with regards to the issue. After listening to the meeting again, the concerns seem to be:
 1. Do we have to allow them and if so, what are our rights? What do we have to approve and what can we deny?
 2. Aesthetics of the installations. What are the standards, can some equipment be required to be underground, what will the cabinets look like, what will the antennas look like, will they be allowed on decorative poles?
 3. Can we require collocation of the facilities?

The overarching theme of the feedback was that the City Council needed more information. The intent was to come back to the City Council with a presentation during a regular meeting to

answer questions and present the ordinance. Due to the nature of the questions and the desire from Council, staff decided we needed to develop documents that will enable the city to manage the small cell deployment in accordance with our preferences and bring those back to City Council during a work session. These documents are: the ordinance changes necessary to include small cells, a Master License Agreement (MLA) that will be required of anyone who wants to deploy small cell in the right of way, and a set of design standards. I am attaching the draft MLA and the draft design standards. The ordinance is still being drafted. It is likely the ordinance will be brief but likely require:

- MLA approved by City Council (including permits/applications as required)
- Fees in accordance with the MLA and regulations
- Constructed per design standards

We won't have all the answers we need to present at the first meeting in April and staff cannot present at the second meeting in April due to a vacation. The work sessions in May and June are generally reserved for budget so the plan is to continue working to develop the documents and then present at the first meeting in July. In discussions with industry insiders, staff does not think it is imperative that we get the small cell documents approved within the next few months. Please feel free to send any comments you may have on the MLA and design standards before the meeting in July so we can address them at the meeting. There are some good websites that discuss this issue and we've put the links to a couple of them below.

- 4. Proposed Costco Traffic Concerns** - There has been concern expressed about traffic issues that will be caused by Costco's proposed move to the Zoo and Shiloh location. Please note, the zoning request has not been approved yet nor has the site development. Also, Costco will need to do a traffic study before development and mitigate impacts through offsite improvements. We did ask MDT if they had any plans for the area and received the following message:

Yes, MDT is currently developing plans for a project called ZOO DRIVE IMPROVEMENTS – BLGS, which is tentatively scheduled for construction in 2026.

The project will improve traffic operations and safety along the Zoo Drive corridor and will include intersection improvements, striping modifications, signal upgrades, median work and other operational modifications necessary to improve traffic flows and safety in the area.

Policies & Procedures

GENERAL INFORMATION

- Non-Resident fees apply to those living outside of the City of Billings. Non-resident must include an additional \$10 per person, per class.
- Enrollment is subject to availability. Programs are filled on a first come, first served basis.
- All programs are subject to cancellation if minimum enrollment numbers are not met. Full refunds will be issued to participant in original form of payment.
- All programs are subject to change based on weather conditions, availability and enrollment numbers.
- Various programs may list activity deadlines for registration. Generally the deadline for registration is one week prior to the start of the activity, or session when there are multiple sessions being offered. This enables us to produce and distribute participant rosters to instructors as well as combine low enrollment classes rather than cancel them.

REFUND / TRANSFER POLICY

The City of Billings strives to provide quality recreation classes and programs. If you are unable to attend, we will be happy to arrange a transfer for another class (if space is available and is prior to the second class) or process a refund. Once the program begins, no refund will be issued unless the program is cancelled by the department. All refunds are reviewed on a case-by-case basis. Extenuating circumstances beyond the participants control maybe taken into account. Any refund 7 days or less will receive no refund. SCHOLARSHIP APPLICATIONS

Applications are available for low income families to apply for reduced fees for specific recreation programs. Applicants must be city residents and can receive up to a 75% discount if qualified. One application per child per season. Pick up an application in person at the Parks and Recreation Office to apply.

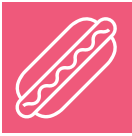

Swim Lesson Class Guide

Splash into swim lessons this summer with the American Red Cross Swimming and Water Safety Program. This course features six levels of Learn-to-Swim instruction to help swimmers of all ages and abilities to develop their swimming and water safety skills. Designed to give students a positive learning experience, American Red Cross Learn-to-Swim teaches aquatic and safety skills in a logical progression. The objective is to teach participants to swim and be safe in, on, and around water.

1

Introduction to Water Skills

Helps students feel comfortable in water. Enter and exit water safely. Submerge mouth, nose and eyes. Exhale underwater through mouth and nose. Open eyes underwater, pick up submerged object. Change direction while walking or paddling. Roll over from front to back and back to front with support. Explore floating on front and back with support. Explore swimming on front/back using arm/leg actions with support.

2

Fundamental Aquatic Skills

Gives students success w/fundamental skills. Enter water by stepping or jumping from the side. Exit water safely using ladder or side. Submerge entire head. Blow bubbles submerging head in a rhythmic pattern (bobbing). Open eyes underwater, pick up submerged object in shallow water. Float on front and back. Perform front and back glide. Change direction of travel paddling on front or back. Roll over from front to back, back to front. Tread water using arm and leg motions (chest-deep water). Swim on front, back, and side using combined arm and leg actions.

3

Stroke Development

Jump into deep water from the side. Dive from kneeling or standing position. Submerge and retrieve an object in chest deep water. Rotary breathing in horizontal position. Perform front and back glide using two different kicks. Float on front and back in deep water. Change from horizontal to vertical position on front and back. Tread water using hand and leg movements. Perform front and back crawl & butterfly kick and body motion.

4

Stroke Improvement

Develops confidence in the skills learned and improves other aquatic skills. Level 4 participants learn to: Perform a dive from a standing or stride position. Swim underwater. Perform feet-first surface dive. Perform open turns on front and back. Tread water using sculling arm motions and with different kicks. Perform Front and Back Crawl, Breaststroke, Butterfly, & Backstroke. Swim on side using scissors-like kick. Perform compact jump into water while wearing life jacket.

5

Stroke Refinement

Provides further coordination and refinement of strokes. Level 5 participants learn to perform: Standing dive & Shallow dive. Tuck surface dive & Pike surface dive. Front flip turn & Backstroke flip turn. Front and Back crawl. Butterfly, Breaststroke, Elementary backstroke, & Sidestroke. Tread water with two different kicks & learn survival swimming

6

Swimming and Skill Proficiency

Refines the strokes so students swim with ease, efficiency, power and smoothness over greater distances. Level 6 is designed with "menu" options that each focus on preparing students to participate in more advanced courses, including the Water Safety Instructor and Lifeguard Training courses. These options include, Personal Water Safety, Fundamentals of Diving, Lifeguard Readiness - GUARD START, and Fitness Swimmer.

Parkland Gleaning Project

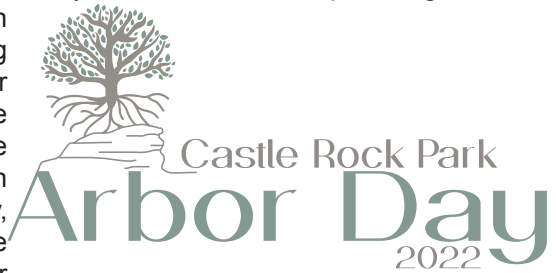

Alcohol Permits

If you plan on having alcohol at your event you must purchase an Alcohol Permit from the Parks and Recreation Department Office. This is for beer and wine only (no glass containers). Permits may be obtained in person at the Parks & Recreation office. Alcohol permits cost \$75 and are non-refundable & non-transferable. Must be 21 years or older to purchase. (No permits are issued for Coulson, Swords or Riverfront Park)

Park Use Permits

A Park Use Permit is required for any event that is open to the general public and is available for requests to reserve a specific park area for weddings, company picnics or family reunions. Events open to the public include youth sports leagues, concerts, fun runs, and special group events. A \$150 processing fee is charged on a per park basis for general permits and is non-refundable. Permits for athletic usage are per field/season and rates vary according to usage. Events open to the public require liability insurance that meets the mandatory guidelines contained in the application. Aesthetic Standards for Deployment of Small Cells

**Published By the Public Works Department
2022**

General

The City of Billings seeks to promote well-designed and non-intrusive small cell facilities and support structures to provide wireless services. In general, a small cell facility, poles and wireless support structures shall be aesthetically consistent with the materials and finish of adjacent utility poles and of the area surrounding their location. These standards are intended to provide direction when designing and constructing small cell facilities. Adherence to these standards does not relieve the owner, operator or permittee from any other local, state or federal requirements related to the design, permitting or construction of small cell facilities.

Recitals

- These standards shall not be interpreted to materially inhibit deployment of small wireless facilities or other associated infrastructure.
- To the extent any of the standards set forth herein are not reasonable, discriminatory, or technically infeasible, the City and the wireless provider shall work together in good faith to use alternative means to comply with the intent of such standard or standards.

Appearance of Structures

- Support structures may include luminaires that match the City's specifications for lighting. Any antenna equipment mounted to the support structures (antenna or other permitted equipment) shall also be matching in color to the support structure.
- New small cell facilities, poles and wireless support structures shall not be illuminated, except in accordance with local, State and Federal regulations, or unless illumination is integral to the camouflaging strategy such as a design intended to look like a streetlight pole.
- All cables, wires and connectors related to the small cell facility must be fully concealed, to the extent technically possible. There shall be no external cables and wires related to the small cell facility hanging off or otherwise exposed on the metal pole or wireless support structure.

- Where technically feasible, each small cell antenna shall be located entirely within a shroud or canister type enclosure at the top of the existing pole or wireless support structure.
- Radio equipment shall be fully enclosed within an equipment cabinet or otherwise concealed, where technically feasible.
- The diameter of the antenna enclosure, at its widest point, should not be wider than the diameter of the top of the wireless support structure. If technically infeasible, the owner shall provide measurements and documentation with the application.

Antenna, Wires and Equipment Placement

- The City desires to maintain the beauty of its community. Where technically possible, applicants shall place the antennas inside the pole when erecting a new metal pole or replacing a current pole.
- Other antennas, if not concealed within the metal pole or wireless support structure, shall either be
 - Mounted to the top of the pole or wireless support structure and aligned with the centerline of the pole or wireless support structure, or
 - Mounted to the side of the pole or wireless support structure such that the vertical centerline of the antenna shall be parallel with the pole or wireless support structure, and with the height of the side mounted antenna being at a location on the pole or wireless support structure noted in the application and approved by the City, at least 20 feet above ground level.
- Pole mounted equipment must be flush mounted to the pole, to the extent technically feasible, and must be on the side of the pole facing away from the roadway or street.
- All conduit, wiring and fiber shall be buried between structures and ground mounted cabinets. All service lines (e.g., electric lines) to the support structure must also be buried unless service lines in the area of the support structure are aerial. Then service lines to the support structure can also be aerial, except for any service drop crossing a street or roadway which would need to be bored and placed under such street or roadway.
- All equipment or cabinets located at the base of a small wireless facility shall be located or placed underground where technically feasible. If that alternative is not available, then the equipment shall be located and placed in a cabinet that is:
 1. Designed to blend in with existing surroundings, using architecturally compatible construction and colors; and
 2. Located so as to be unobtrusive as reasonably possible consistent with the proper functioning of the facilities.
- Surface-mounted cabinets (which cannot be placed underground) must be on a concrete slab and, where possible, must be placed next to existing pedestals and

cabinets (for example, near a traffic signal) and must also be the same color as other nearby pedestals or cabinets.

- A small cell pole must not be installed within sixty (60) feet of a single-family or two-family dwelling unit.

Identification

- A distinct marker (tag) shall be placed on support structures for wireless facilities that will allow for ready identification of the type of attachment, its owner and provider, and contact information for the network operations center. The marker shall be limited in size to a 3-inch by 2-inch plate placed no higher than 6 feet above grade.

Painting Requirements

- Small cell facilities shall be painted to blend or match with the pole to which they are attached or the surrounding environment. The facility shall be of a single color, having a flat, matte, non-gloss, non-florescent finish.
- Small cell facilities, poles, wireless support structures and ground mounted equipment enclosures shall not include advertisements or signage and may only display information required by a Federal, State or local agency. The small cell facility owner, operator or permittee shall utilize a visible Radio Frequency (RF) warning sticker required by government regulations. Placement of the RF sticker shall be as close to the antenna(s) as possible.
- All hardware, including antenna mounting brackets, mounting posts, cables, shrouds and other equipment, shall be painted a color designated by the City for the particular district or zoned area of the city and the color shall match the other facilities. The City may require the facilities owner, operator or permittee to use a different, non-matching color on a case-by-case basis when the City determines a non-matching color would better fulfill the purposes of these Aesthetic Standards.
- Small cell facilities proposed on new streetlights or poles should match the color of the City streetlight infrastructure and pole and blend in as much as possible. When wireless equipment cannot be supported on existing infrastructure due to structural concerns, the replacement of City infrastructure should be done per the specifications provided by the City and be uniform in both color and appearance with surrounding City streetlight infrastructure.
- Any equipment cabinet must be painted or screened to be the same color as the other adjacent small cell facilities, pole or wireless support structure.

Stealth Requirements

- All small cell facilities shall utilize stealth and camouflaging methods to limit their visual impact where feasible. Stealthing features should include blending with the environment and surrounding infrastructure and being similar in overall size to surrounding poles including the height. The City also prefers the use of stealth design elements, such as shapes and colors that match surrounding infrastructure and minimize adverse visual impacts.
- Small cell facilities shall be camouflaged using existing landforms, vegetation, and structures to screen the facilities from view and to blend in with the surrounding built and natural environment whenever feasible.

Code Interpretation

- Small cell facilities, poles and wireless support structures shall be deployed in a manner that does not impede, obstruct, or hinder usual public pedestrian or vehicular travel or public safety.
- Small cell facilities, poles and wireless support structures shall be deployed in a manner that does not obstruct other legal uses of a ROW including those by a utility or other provider.
- Small cell facilities, poles and wireless support structures shall be deployed in a manner that does not violate any provision of the Federal Americans with Disabilities Act.
- Small cell facilities, poles and wireless support structures shall not create a visual obstruction within sight triangles at street intersections.
- Small cell facilities and equipment shall be located with the appropriate clearance from existing utilities.
- Small cell facilities, poles and wireless support structures shall not be located along the frontage adjacent to any building deemed to be of historic significance on a Federal, State, or local level.
- Small cell facilities shall not be installed on City poles containing controls for fire alarms, warning sirens or police signals.
- New poles or wireless support structures shall not interfere with any metered parking space.
- Small cell facilities shall not have any flashing lights, sirens or regular noise.

Other Items

- Providers shall comply with all nondiscriminatory fall-zone requirements for the associated wireless support structure or utility pole that are imposed on other types of similar structures in the right-of-way.

- Small cell facilities, poles and wireless support structures shall be deployed in alignment with existing trees (where technically feasible), utility poles, and streetlights.
- Small cell facilities, poles and wireless support structures shall be deployed equal distances between trees, when possible, with adequate separation from the trees such that no proposed disturbance shall occur within the critical root zone of any tree in conformance with current safety guidance for arborists as published in ANSI Z133.
- Small cell facilities, poles and wireless support structures shall not interfere with existing or planned street trees.
- There shall be at least three hundred (300) feet between new small cell facilities and any other poles or wireless support structures primarily used for small cell facilities, measured in any direction, and not necessarily a dimension measured parallel to a road ROW.
- Freestanding small cell facilities, poles and wireless support structures shall be located on an arterial or collector street wherever feasible.
- Providers are encouraged to locate small cell facilities in accordance with the following standards, which are listed in order of importance:
 - Small cell facilities, poles and wireless support structures shall not be deployed in front of residential driveways, building entrances or exits, or walkways.
 - A new pole or wireless support structure for small cell facilities shall not be deployed directly in front of a homeowner's or apartment owner's window(s).
 - Small cell facilities, poles and wireless support structures shall not be deployed directly in front of any existing residential or office structures so as to unreasonably obstruct views from the buildings.
 - Freestanding small cell facilities, poles and wireless support structures shall be deployed at intersecting property lines wherever feasible.
 - Providers are encouraged to provide proposed designs of each of their poles, antennas, wireless support structures, equipment and facilities and desired site locations to the City in advance of filing their actual applications.
 - Pre-application meetings with the City are highly desirable to add efficiencies to the process.

Encouraged guidelines

- The City encourages at least five hundred (500) feet between new small cell facilities and any other poles or wireless support structures primarily used for small cell facilities, measured in any direction, and not necessarily a dimension measured parallel to a road ROW.
- The City encourages small cell facilities, poles and wireless support structures to be installed at least fifty (50) feet of distance from commercial buildings, and two

hundred (200) feet from schools and parks, and beyond any federally mandated separation distance from the airport.

MASTER LICENSE AGREEMENT

This Master License Agreement ("Agreement") is made this ____ day of _____, 202_, between the City of Billings, Montana, with its principal offices located at 210 North 27th Street, Billings, MT 59101, hereinafter designated as "City" or "Licensor", and _____, with its principal offices located at _____, hereinafter designated as "Licensee". Licensor and Licensee are at times collectively referred to hereinafter as the "Parties" or individually as the "Party".

WITNESSETH

WHEREAS, Licensor is the owner of certain streetlights and poles located within public rights-of-way within the boundaries of the City, all within the geographic area of a license held by Licensee to provide wireless services issued by the Federal Communications Commission ("FCC"); and

WHEREAS, Licensee desires to install, maintain, upgrade and operate communications and related equipment, conduit, utilities, and appurtenances in or upon certain of Licensor's streetlights and poles, on its own poles and on third-party poles; and

WHEREAS, Licensor and Licensee desire to enter into this Agreement to define the terms and conditions which govern their relationship with respect to particular Sites (as defined herein) at which Licensor may wish to permit Licensee to install, maintain, and operate its Equipment on said streetlights and poles as hereinafter set forth; and

WHEREAS, Licensor and Licensee acknowledge that they will enter into a license supplement ("Supplement"), a copy of which is attached hereto as Exhibit A, with respect to each particular streetlight and pole and Site approved by the Licensor, as provided herein.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the adequacy and sufficiency of which are hereby acknowledged, the Parties hereto, for themselves, their successors and assigns, do hereby covenant and agree as follows:

DEFINITIONS

CITY PARKS. "City Parks" shall mean the public parks, administered by Licensor's Parks and Recreation Department.

COLLOCATION. "Collocation" shall mean the mounting or installation of equipment on a tower, pole, building or other structure for the purpose of transmitting and receiving radio frequency signals for communications purposes.

ENGINEERING DESIGN STANDARDS. "Engineering Design Standards" shall mean those standards approved by the Public Works Engineering Division.

EQUIPMENT. “Equipment” shall mean communications equipment owned by the Licensee, including, but not limited to, poles, antennas, conduit, utilities, fiber and appurtenances.

MAKE-READY COSTS. “Make-ready costs” shall mean materials, labor, engineering, supervision, site work, and tree trimming costs required in connection with Licensee’s installation or modification of Equipment on streetlights and poles. Make-Ready Costs shall include the actual costs of changing out streetlights and poles (to the extent Licensor will be required to change out streetlights and poles under this Agreement), including the cost of installation, temporary construction, and all other necessary construction in accordance with applicable industry and safety standards. In addition, Make-Ready Costs include reimbursement to Licensor for its removal of lights and lighting equipment and Licensor-owned communications and security equipment, if any, from existing streetlights and poles not being used jointly by Licensor and Licensee and reinstalling them on replacement streetlights and poles installed by Licensee for joint use by Licensor and Licensee. Make-Ready Costs shall not include fees which may be separately charged to Licensee pursuant to the City Code or City policies for plan review, permits, and inspections required in connection with any work to be performed by Licensee in the City.

NON-STANDARD STREETLIGHT. “Non-standard streetlight” shall mean any decorative streetlight, whether or not such decorative streetlight is located within a Historic District.

OTHER AREAS. “Other Areas” shall mean property owned and managed by Licensor, other than Right-of-Way, that could be used for collocation or new poles, such as, for example, streetlights and poles outside of the Right-of-Way or in City-owned parking lots, on City-owned buildings, water tanks or unique areas requiring detailed review for which applications, annual fees and separate agreements are warranted and required by Licensor.

POLE. “Pole” shall mean a legally constructed pole, such as a utility, lighting or similar pole made of wood, concrete, metal or other material located within or outside of the Right-of-Way.

PROPERTY. “Property” shall mean City Right-of-Way within the City.

RIGHT-OF-WAY. For purposes of this Agreement, “Right-of-Way” or “ROW” shall mean Right-of-Way dedicated to the public and accepted by the Licensor in trust for public use or acquired in fee by the Licensor for purposes of maintaining streets and street improvements, including utility easements which are permitted for use by utilities if so permitted. However, the term Right-of-Way does not include any easements acquired by the Licensor that are limited to municipal uses only, such as sewer, water, drainage, or other municipal purposes, regardless of whether such easements are acquired through the platting process or any other acquisition (and regardless of whether such easements are referred to elsewhere as Right-of-Way) and shall not include any place or Property that does not contain or will not contain Streetlights owned and maintained by the Licensor.

SITE. “Site” shall mean Licensor’s streetlights and poles or third-party poles in the Right-of-Way as may be approved by Licensor pursuant to a fully executed Supplement licensed to Licensee on a non-exclusive basis, and such areas as necessary to provide access for utilities, ingress and egress, and to maintain Licensee’s Equipment (to the extent Licensor owns and holds control over the property to be used for ingress and egress), as approved in each Supplement to this Agreement.

SPARES INVENTORY. "Spares Inventory" shall mean the spare lighting poles that are used for replacement of lighting poles, and the right size and weight is available for the appropriate correlating equipment.

STREETLIGHTS. "Streetlights" shall mean poles used or to be used for Licensor's lighting in the Right-of-Way and Streetlights in as may be approved by Licensor in a Supplement. Streetlights do not include Non-Standard streetlights, traffic signal lights or other signal lights, traffic poles, power poles, traffic devices, or light poles for sports fields or arenas, stadium lighting or other lighting of any kind, and do not pertain to poles or other structures owned by others regardless of whether maintained by the Licensor for lighting or any other purpose.

SUPPLEMENT. "Supplement" shall mean a Site License in the form shown in Exhibit A to this Agreement and signed by the Parties.

I. SCOPE

a. By entering into this Agreement, Licensor agrees that Licensee may install and maintain its Equipment under the terms and conditions in this Agreement and each applicable Supplement to be entered into from time to time in connection with each attachment of Equipment to a streetlight or pole.

b. Licensee may install, upgrade and maintain Equipment on Licensor's property or third-party poles, with such installations to be limited to, when feasible or available, replacement of existing streetlights or poles or the use of existing streetlights or poles (with all such streetlights or poles to be used jointly by Licensor and Licensee). However, if existing streetlights or poles are not available for use or replacement, the Parties acknowledge that this Agreement does not limit any rights Licensee may have to install and maintain Licensee-owned poles ("Licensee poles") at other locations within Licensor's Right-of-Way, with the design, location, and placement as approved by Licensor pursuant to Licensor's Design Standards, the City Code and other regulations then in effect. With respect to Licensee poles to be installed and maintained in Parks and Other Areas, the Parties may enter into a, a separate mutually acceptable agreement. In the case of Licensee poles in City Parks, approval shall be at the sole discretion of the Parks and Recreation Department. In the case of Other Areas, any such approval (regardless of whether it involves replacement of streetlights or poles, use of existing streetlights or poles, Licensee poles, or otherwise) shall be at the sole discretion of Licensor. Licensor makes no representation or warranty as to the condition of its existing streetlights or poles.

c. Applications for Other Areas and City Parks will be subject to separate negotiations for a separate agreement, including specific application fees, rental fees, and/or reimbursement for consulting fees and Make-Ready Costs.

d. The City makes no representation or warranty as to whether any additional consents, approvals or permits are necessary or required from any other governmental entity or any third party with respect to Licensee's Equipment outside of the Right-of-Way in order for Licensee to lawfully occupy property outside of the Right-of-Way and to operate its Equipment. Licensee is responsible at its cost and expense to obtain any necessary easements or other authorizations from the City and to secure all additional consents, approvals and

permits necessary with respect to the construction, installation and operation of its Equipment outside of the Right-of-Way.

II. LICENSEE'S REQUESTS

a. Before Licensee shall replace or make use of any of Licensor's existing streetlights or poles within any property, the Site licensed to Licensee shall be as described in the applicable Supplement, as executed by the Parties. Licensee shall request permission in writing for placement of its Equipment, which writing shall be made by means of a completed application submitted in compliance with the procedures set forth in this Agreement. Licensee may request to use Licensor's conduits, at Licensee's expense and with Licensor's prior written consent. Such consent may be withheld by Licensor in its sole discretion. Any use of City conduit by Licensee shall require a separate mutually approved agreement with fees and rates and terms between the City and Licensee.

b. Licensee may, without submitting an application for a new site, modify or replace all or a portion of Site that is subject to an existing Supplement by making a permit request limited to such modification or replacement, provided: (i) such modification or replacement results in the installation of Equipment within the spaces designated or depicted in the applicable Supplement; (ii) the resulting installation does not increase the load on the applicable streetlight or pole so as to make that streetlight or pole structurally unsound; (iii) the new or additional equipment would not be of the type and frequency which would cause harmful interference which is measurable in accordance with then-existing Industry standards; (iv) such would not interfere with the existence and operation of equipment of Licensor or other higher priority users or cause the Site to exceed FCC Radio Frequency ("RF") emission limits; and (v) the new or additional equipment is substantially similar in design, height, width and color. Any request for such permit shall be accompanied by: (i) a certification by a structural engineer licensed in the State that the proposal meets Industry standards and (ii) current fees for permits and plan review.

c. Each application for installment of a new Licensee pole inside or outside of the Right-of-Way, replacement streetlight, and attachment of Equipment on streetlights must be complete and must include the applicable application fee. After the application fee has been paid, the Licensor shall review the plans and application. An application for the installation of a new Licensee pole or attachment of Licensee's Equipment to a replacement or existing streetlight or pole inside or outside of the Right-of-Way may be denied for reasons reasonably related to capacity, safety, reliability, or engineering concerns, or if the Licensee pole or proposed attachment would violate Licensor's Ordinances (including Engineering Design Standards) or other laws of general applicability related to building codes, electrical codes, City Codes or related standards, including, but not limited to, height, size, traffic concerns, aesthetics, including color, and the ability to blend in with historic features in Historic Districts, or the other requirements of this Agreement. Any applications pertaining to Other Areas may be denied at the sole discretion of Licensor, and, further, applications for Licensee poles in City Parks may be denied at the sole discretion of the Parks and Recreation Department. Within the time frames provided by the FCC, after submission of an application, Licensor will notify Licensee in writing, within 10 days, whether the application and the plans submitted with the application are incomplete. If the timeline by the FCC is modified, then the parties shall adhere to the revised timelines specified by the FCC

for application review and approval or denial of an application, unless the parties otherwise mutually agree to extend the timelines in writing.

d. Licensee may submit up to ten (10) Sites with each application. The information must be identified by Site, so that the Licensor can readily determine whether additional information is required for an individual Site. If approved, the Parties shall execute a Supplement for such individual Site. Upon execution of the Supplement, Licensee shall have the right to use the Site, and its contractors shall obtain required building permits and proceed with the installation work in accordance with the terms of the Supplement and this Agreement.

e. Along with each application for use of the Right-of-Way, Licensee shall submit a non-refundable application fee in the amount of \$500 for up to five (5) Sites and \$100 for each additional small wireless facility per Site, or in the event of a new pole, \$1,000 per pole (or such higher rates as set forth by the FCC). The application fee is in addition to any other applicable fees required by the City to install, maintain, or replace equipment or facilities in the Right-of-Way.

The application fees may be increased from time to time, based upon cost studies conducted by Licensor to determine the actual, reasonable and non-discriminatory costs incurred by Licensor. Licensor shall provide written notice to Licensee of any adjustment of such fees. Notwithstanding the above, any changes to the application fees shall be in compliance with FCC requirements.

f. After an application is approved and construction commences, Licensee will be responsible for any inspection fees as required by the City so long as such inspection fees are comparable to those imposed on other similarly situated businesses in the City.

III. SITES

a. Licensor agrees to license to Licensee each Site on a non-exclusive basis for the installation, operation, upgrade and maintenance of Equipment, together with the non-exclusive right of physical ingress and egress seven (7) days a week, twenty-four (24) hours a day, to and from the Sites; provided, however, if traffic or sidewalks shall be impacted or if there will be road closures, Licensee provides at least forty-eight (48) hours advance notice to Licensor to coordinate access.

b. Licensee shall have the right, at its sole cost and expense, to use each Site, as identified in each individual Supplement, for the purpose of constructing, maintaining, repairing, upgrading and operating wireless facilities and communications equipment in a manner consistent with the applicable Supplement.

c. Licensor reserves and Licensee agrees to the right of Licensor, its authorized officers, employees, agents or contractors, to enter into and access any Site at any time for the purpose of conducting Licensor inspections, maintenance and repairs (including permitting other parties to use the Site to provide services). Without limiting the foregoing, Licensor and Licensee agree that Licensor may: (i) inspect any property, Site and equipment for Licensee's compliance with the terms of this Agreement and applicable Supplement; and (ii) make repairs, alterations or additions to any Site or maintain or use any Site in any manner not prohibited by the terms of this Agreement or applicable Supplement, all without a claim by Licensee for any loss of occupation

or use of, or any abatement of the fee for use of the applicable Site. Except in case of an emergency, Licensors will provide no less than ten (10) days' notice to Licensee prior to commencing any work described in clause (ii) above. In addition to the foregoing and notwithstanding anything in this Agreement to the contrary, Licensors may access the Site at any time if it is necessary to protect the safety, health or welfare of the public.

d. The primary use and purpose of the Right-of-Way is to provide for maintaining streets, drainage, sidewalks and street lighting, Licensors' operations take priority over Licensee's use. In the event Rights-of-Way are expanded or changed, such that the placement of streetlights or poles must be changed, then Licensee shall have the option to either (i) move or install the streetlight or pole with its equipment to a new, mutually agreed upon location on City property (at the same rental rate), or (ii) terminate the Supplement for said Site. Licensors shall inform Licensee at the earliest possible date of its plan to eliminate or change the location of a streetlight or pole, but in any event (other than emergencies), no less than ninety (90) calendar days.

e. While performing any construction, installation, maintenance, or repair of its Equipment, Licensee shall employ protective measures and devices conforming with Licensors' policies and regulations.

f. Licensee shall ensure that its employees, agents and contractors which perform work in furtherance of this Agreement are adequately trained and skilled to access structures and infrastructure in accordance with all applicable industry and governmental standards and regulations.

g. Licensee agrees that the following priorities of use, in descending order, shall apply in the event of communications interference, emergency public safety needs, Site repair or reconditioning, or any conflict while this Agreement is in effect, and Licensee's approved use shall be subordinate accordingly:

- i. Licensors, its employees, agents, and contractors;
- ii. Public safety agencies, including law enforcement, fire, and ambulance services, that are not related to Licensors;
- iii. Other governmental agencies where use is not related to public safety;
- iv. Pre-existing licensees (if any);
- v. Licensee referenced in this Agreement.

h. In the event of any occurrence that poses an immediate threat of substantial harm or damage to the health, safety, and welfare of the public or the property or Sites, as solely determined by Licensors (an "Emergency Event"), Licensors may take actions that Licensors determines are required to address such Emergency Event; provided that promptly after such actions that affect the Sites, and in no event later than seventy-two (72) hours after such actions, Licensors gives written notice to Licensee of Licensors' emergency actions.

i. If Licensors determines that the conditions of the Emergency Event would be benefited by cessation of Licensee's operations, Licensors shall notify Licensee's Network Operations Center ("NOC") at _____, and Licensee shall immediately cease its operations on the affected Sites until Licensors notifies Licensee that the Emergency Event has been resolved

and that Licensee can resume its approved use. Licensee shall ensure Licensor has updated contact information throughout the term of this Agreement.

j. If Licensee intends to install (or have a third party install) above ground or underground electric, telephone, cable or fiber optic lines, or utility equipment, it shall request approval from the Licensor by submitting to Licensor a detailed written plan including such information that is available to Licensee at the time of application for such installation, and the installation of any meter pedestals on, over or under the property and to the Sites as necessary for Licensee's approved use. Licensor shall, in its reasonable discretion, notify Licensee that it approves, denies, or modifies the plan within sixty (60) days for collocations and ninety (90) days for new poles, and in the case of any denial or modification, Licensor shall state the reasons therefor. Licensee is required to arrange and pay for all such installations.

k. Licensee must, at the time of application, when any permit request is made, or when a pole is damaged, obtain and submit to Licensor a structural engineering study carried out by either an independent structural engineer licensed in Montana or an in-house structural engineer licensed in Montana, showing that the streetlight(s) or pole(s) is/are able to support the Equipment as well as the street lighting equipment used by Licensor. If the study finds that any proposed or existing streetlight(s) or pole(s) is/are inadequate to support the proposed loads, and the streetlight(s) or pole(s) is/are not required to be replaced by Licensor, Licensee shall either replace the streetlight(s) or pole(s), at its cost or may withdraw the application. Additionally, Licensee must, at the time of application also provide the following [Debi to provide a list to add here]

l. Licensee's use of the Sites and property, and its design and installation of its Equipment must be in accordance with all applicable laws including, but not limited to, the Americans with Disabilities Act.

IV. INSTALLATION OF EQUIPMENT

a. Construction Plans. Prior to the approval of the Supplement and initial installation of all streetlights, poles or Equipment, and for any and all subsequent revisions or modifications thereof, or additions thereto, Licensee shall provide Licensor with construction plans for the Site area which shall be submitted to the Licensor through its Public Works Engineering Division and consist of the following:

- i. Line or CAD drawings showing the location and materials of all planned installations and construction methods, with locations to be shown using project coordinates;
- ii. Construction Specifications and Manufacturers' Specifications for all planned Equipment and installations;
- iii. Diagrams of proposed Equipment, fiber, electric lines and existing, new or replacement streetlights and poles within Licensee's Site area;
- iv. Site maps, along with drawings showing elevations of the proposed Equipment to be installed, with distance to adjacent properties and nearby features

via the scale on the site map drawing (and, when requested by Licensor, photo simulations); and

v. A complete and detailed inventory of all Equipment and property of Licensee to be actually placed on the Site.

Should the construction plans need to be revised based on the comments provided by Licensor, no construction shall commence until final approval is granted by Licensor. Final construction plans shall have affixed to them the signature of Licensee's engineer who shall be licensed in the State. Licensee must also make timely payment of make-ready costs related to work to be performed by Licensor.

b. No Small Wireless Facilities on Non-Standard Streetlights. Licensee shall not install any small wireless facilities on non-Standard streetlights, unless the City otherwise agrees in writing for a particular Site.

c. Construction Inspection. All construction activity shall be subject to inspection and approval by Licensor. Inspection may be performed at any time during the course of the construction activity reasonably determined by Licensor, at Licensee's expense. Construction work performed without approval of Licensor will not be accepted and shall be removed or uninstalled at Licensee's sole expense.

d. Exposed Equipment. All Equipment affixed to a streetlight or pole which has exterior exposure shall be as close to the color of the streetlight or pole as is commercially available to the Licensee but shall not be contrasting or brightly colored. For exposed cables, wires, or appurtenances, Licensor reserves the right to require Licensee to provide cables, wires, or appurtenances in manufactured colors which are commercially available, in lieu of painting.

e. Damage by Licensee. Any damage to the property, the Sites or Licensor's equipment or structures thereon caused by Licensee in any manner shall be repaired or replaced at Licensee's expense and to Licensor's satisfaction. At its option, Licensor may repair or replace such items and bill Licensee for such repair or replacement.

f. As-Built Drawings. Within forty-five (45) days after Licensee activates the Equipment, Licensee shall provide Licensor with As-Built drawings in electronic file format compatible with Licensor's record filing system consisting of the Equipment installed at the Site and on any of the property, which shall show the actual location of all Equipment. Said drawings shall be accompanied by a complete and detailed Site survey of the property on which the Equipment is located and an inventory of all Equipment.

g. Permits. Prior to performing any work in or on any property, Licensee or its contractors shall pay for and obtain any and all permits required for a complete installation of Licensee's Equipment, or any new or replacement streetlight or pole at the applicable location. Licensee shall require each of its contractors to obtain and comply with all applicable permits.

h. Locating and Protecting Other Underground Facilities. Licensee or its contractors shall notify Montana 811 prior to any excavation or digging.

In areas where the excavation or construction of Licensee or its contractors will be adjacent to other underground facilities or equipment, the contractor shall make arrangements with the respective operators or owners of such items, if known, to support, sustain, and protect existing underground facilities, personal property, structures, fixtures, pipes, conduits, poles, wires and other apparatus located under, over, along, across or adjacent to the work site. If damage occurs, the cost of such repairs or replacement shall be paid or reimbursed by the Licensee or its contractors, as applicable.

i. Liens. Licensee shall not do, nor allow, or cause anything to be done whereby Licensor's Property may be encumbered by a construction lien or any other type of lien. Within forty-five (45) days after any lien is filed against Licensor's Property purporting to be for labor or materials furnished to Licensee, Licensee shall discharge or bond against such lien of record. Failure to remove any lien recorded against the Property within forty-five (45) days of receipt of notice of recordation shall be considered a material breach of the applicable Supplement, and Licensor shall have all available remedies.

j. Compliance with Laws. Licensee shall construct, install, operate and maintain its Equipment at each Site in accordance with all applicable federal, State and local laws, rules and regulations.

V. MAINTENANCE AND REPAIR OF EQUIPMENT

a. Maintenance of Licensee Equipment. Licensee shall, at its own cost and expense, maintain the Equipment in a good and safe condition, and in compliance with applicable fire, health, building, and safety codes and other City Standards and applicable laws. Licensee shall obtain from Licensor any and all permits required for the purposes of maintaining the Equipment, under the terms generally applicable for such permits. Applicable fees for any permits shall be borne by Licensee, and Licensee shall be bound by the requirements of said permits.

b. Routine Maintenance and Outages.

i. Licensee shall perform all emergency, preventative, and routine maintenance of its facilities and Equipment.

ii. The fiber optic cabling and other facilities shall be maintained consistent with industry standards. Licensee shall provide continuous service on its facilities and Equipment, including any necessary repair or replacement, within the standards for network availability and reliability parameters.

iii. The facilities and Equipment shall be considered as experiencing an "outage" for a user when that user cannot, because of a problem resulting from the failure of any network component provided by Licensee, transmit or receive video, voice, or data communications on the facilities and Equipment for more than two (2) hours. "Outage" conditions shall not include scheduled preventive maintenance as long as the City is notified in advance or in the case of an emergency as soon as practicable.

iv. Upon determination of an outage, the City shall immediately notify the Licensee's Network Operations Center by telephone at _____ or through such other notification procedure as the parties may mutually establish in writing. Upon notice from the City of an outage, or from Licensee's internal network monitoring systems, the Licensee shall immediately commence to investigate and resolve the outage. Licensee shall complete all necessary repairs in the shortest time possible.

v. All maintenance and repair work shall be performed in a manner consistent with good engineering practices using qualified personnel.

c. Structure Reconditioning and Repair.

i. From time to time, Licenser paints, reconditions, or otherwise improves or repairs the property, streetlights, poles, Sites, or structures or improvements thereon ("Reconditioning Work"). Licenser shall reasonably cooperate with Licensee to carry out Reconditioning Work in a manner that minimizes interference with Licensee's approved use, and Licensee shall reasonably cooperate with Licenser in a manner that minimizes interference with the Reconditioning Work.

ii. Except in cases of emergency, prior to commencing Reconditioning Work, Licenser shall provide Licensee with not less than sixty (60) calendar days' prior written notice thereof; provided, however, where sixty (60) calendar days' prior notice is not practicable, Licenser shall provide as much prior notice as possible under the circumstances. Upon receiving such notice, it shall be the sole responsibility of Licensee to provide adequate measures to cover or otherwise protect the Equipment from the consequences of such activities including, but not limited to, paint and debris fallout. Licenser reserves the right to require Licensee at Licensee's expense to remove all Equipment during Reconditioning Work.

iii. During Licenser's Reconditioning Work, and after approval by Licenser in its sole discretion, Licensee may maintain, at its own expense, a temporary communications facility on the applicable property, or on any land owned and controlled by Licenser in the immediate area of the applicable Site, so long as such use does not violate an existing lease, easement, permit or contractual obligation applying to such alternate property and such temporary facility does not interfere with construction or repairs on the applicable property, impair traffic, impede sight lines, cause a nuisance or violate generally applicable City Ordinances or Code Standards of the Licenser then in effect. If the Property, or alternate property in the immediate area of the Site, will not accommodate the temporary communications facility, it shall be Licensee's responsibility to locate auxiliary sites and secure any permits or permissions for such other property, at its sole cost and expense. Licenser shall notify Licensee when the Reconditioning Work has been completed, and Licensee shall reinstall its Equipment within thirty (30) calendar days. Also, Licensee shall remove any temporary equipment or facilities within ten (10) calendar days after the Reconditioning Work is completed (regardless of whether Licensee has reinstalled its Equipment or Facilities in its prior location), unless Licenser agrees in writing to an extension of the applicable time period.

iv. Licensee may request a modification of Licensor's procedures for carrying out Reconditioning Work in order to reduce the interference with Licensee's approved use. If Licensor agrees to the modification, Licensee shall be responsible for all incremental costs and expenses related to the modification.

v. With regard to streetlights or poles that are no longer useable or need to be replaced, and to which Licensee's Equipment is attached ("Replacement Work"), the responsibility of the respective Parties for such replacement is as provided in this Agreement. Except for emergency situations, Licensor shall provide Licensee with at least sixty (60) calendar days' prior written notice of the required Replacement Work and the need for Licensee to remove its Equipment; provided, however, where sixty (60) calendar days' prior notice is not practicable, Licensor shall provide as much prior notice as possible under the circumstances. During Replacement Work, Licensee may maintain a temporary communications facility on the property, or on any land owned or controlled by Licensor in the immediate area of the Site, under the same conditions as for Reconditioning Work above. Licensor shall notify Licensee when the Replacement Work has been completed and Licensee shall reinstall its Equipment within thirty (30) calendar days. Also, Licensee shall remove any temporary equipment or facilities within ten (10) calendar days after the Replacement Work is performed (regardless of whether Licensee has reinstalled its Equipment or Facilities in its prior location), unless Licensor agrees in writing to an extension of the applicable time period.

vi. If any streetlights or poles containing Licensee's Equipment need to be repaired due to storm or other damage requiring immediate work ("Repair Work"), Licensor shall notify Licensee to remove its Equipment as soon as possible. In the event of an emergency, Licensor shall contact Licensee by telephone at Licensee's NOC as provided herein prior to removing Licensee's Equipment. For any streetlights or poles previously replaced or installed by Licensee, but only to the extent Licensor does not have sufficient spare replacement streetlights or poles available for emergency use, Licensee will supply, at its own cost, the replacement streetlights or poles to Licensor following the emergency, and installation of such streetlights or poles will be at Licensor's expense. Once the streetlights or poles have been replaced or repaired, Licensor will promptly notify Licensee that it can reinstall its Equipment. During Licensor's Repair Work, and after approval by Licensor, Licensee may maintain a temporary communications facility on the property, or on any land owned and controlled by Licensor in the immediate area of the Site, subject to the same terms as alternate sites for Reconditioning Work. Licensor shall notify Licensee when the Repair Work has been completed and Licensee shall reinstall its Equipment within thirty (30) calendar days. Also, Licensee shall remove any temporary equipment or facilities within ten (10) calendar days after the Repair Work is performed (regardless of whether Licensee has reinstalled its Equipment or Facilities in its prior location), unless Licensor agrees in writing to an extension of the applicable time period.

vii. If Licensee is unable to locate and operate a temporary communications facility during any Licensor Replacement Work, Reconditioning Work or Repair

Work for a period of more than thirty (30) days, the Licensee, at its sole option, shall have the right to terminate the applicable Supplement upon written notice to Licensor. However, if Licensee seeks approval of a new Supplement in a nearby location to replace the terminated Supplement, Licensor will employ good faith efforts to review and enter into a new Supplement on substantially equivalent terms and conditions as expeditiously as practicable.

VI. CONDITION OF STREETLIGHTS AND POLES

Licensor makes no guarantee or warranty as to the condition of any Site with regard to Licensee's approved use.

VII. STREETLIGHTS, POLES AND RELATED EQUIPMENT/SERVICES

a. In connection with Licensee's initial installation or subsequent modifications, Licensee shall replace streetlights or poles, where required, purchase Equipment, have electric, fiber and communications service lines installed, and otherwise perform all work at its own expense and in such manner as to not interfere with Licensor's use of the Property or the Site. Installation and maintenance shall be scheduled so as to accommodate ongoing or newly completed work in or near the applicable Licensor property, such as protection of newly planted turf or other vegetation, newly installed asphalt or sidewalks in the Right-of-Way or other municipal work. In order to avoid adverse situations, Licensee shall provide notice of the planned work at least forty-eight (48) hours in advance and coordinate with the Licensor to develop a mutually acceptable schedule for such work. For each existing streetlight or pole replaced by Licensee, Licensee shall provide the replacement streetlight or pole at Licensee's expense. If Licensor confirms, upon inspection, that installation is complete and meets the requirements set forth in this Agreement and the applicable Supplement, Licensor will thereafter maintain ownership and responsibility for maintenance of the replacement streetlight or pole.

b. Licensee shall also furnish, after the approval of an application, and make arrangements for, at Licensee's sole expense:

i. All necessary, separate electrical meter(s) at the Site for the measurement of electrical power used by Licensee at the Site; and

ii. All necessary communications service lines, including without limitation, fiber optic lines, telephone, and cable, at the Site; and

iii. All other necessary utility equipment.

c. Licensee shall be solely responsible for arrangement and payment for electric service necessary in connection with Licensee's Equipment.

d. Licensee shall request written approval from Licensor prior to the installation of any underground telephone, cable or fiber optic lines, which approval shall not be unreasonably withheld, conditioned or delayed.

e. In all instances pertaining to the placement of electric or other utility services equipment for Licensee, Licensee shall be in compliance with the Americans with Disabilities Act.

f. Licensee will use poles generally available in the commercial market as approved by Licensor. Licensee will not use poles with a proprietary design or a design not otherwise available to the City. Licensee shall use poles and Equipment which are similar in design, height, width, color, style, and appearance and comparable to those used in close proximity in the same zoning district in which such poles are deployed by Licensee.

g. All streetlights or poles used by Licensee under this Agreement, designated as a Licensor-owned streetlight or pole in the applicable Supplement or pole constructed or installed by Licensee (but not other third party owned poles) shall remain or become the property of Licensor without further necessary action or documentation by Licensor or Licensee. Any payments made by Licensee for installation or replacement of, or changes to, existing streetlights or poles and facilities, conduits, conductor pull boxes, facilities, or appurtenances which are the property of Licensor shall not entitle Licensee to ownership of any of said equipment and title thereto shall be vested in Licensor without further necessary action or documentation by Licensor or Licensee.

h. All Equipment and conduits, conductors and fiber, cabinets, meter pedestals, facilities, or appurtenances shall be designed and installed within, adjacent to, or on the streetlight or poles (except upon decorative poles), and only in accordance with the construction drawings as approved by Licensor. To the extent technically feasible, design and installation of streetlights and poles must provide for secure access to both Licensee and Licensor equipment.

i. Licensee shall not authorize third parties to use Licensor's streetlights or poles in any manner, and Licensor reserves the sole right to authorize use of Licensor's streetlights and poles by any third parties; provided, however, such use shall not encroach on Licensee's Equipment or other portions of the Site licensed to Licensee, or otherwise interfere with Licensee's approved use in violation of this Agreement. Both parties acknowledge that Licensor favors and encourages a policy of collocation to minimize the number of new poles in the City.

j. Licensee shall not allow third parties to place signs, flags, advertising, or other similar items on the streetlights or poles or on its Equipment. Licensee's own signage shall be limited to signs, decals, tags, or labels as required by applicable laws or the FCC.

k. Licensee will provide, at its own cost, streetlights and poles (the "Spares Inventory") as follows: at least one (1) streetlight and pole for every increment of twenty (20) streetlights and poles of each type and height utilized by Licensee, as often as needed. If an inadequate number of spares have been provided for Licensor to replace such streetlights or poles, then the City may use other streetlights or poles available to the City and Licensee will reimburse the City.

l. When a streetlight or pole with Licensee's Equipment needs to be replaced: (i) Licensee will be notified to remove its Equipment; (ii) Licensor shall reinstall its own lights and lighting equipment at its own cost, unless otherwise agreed by the parties; and (iii) Licensee shall reinstall its own Equipment at its own cost. If the Parties agree that Licensee or its contractor will reinstall Licensor's lights and equipment, such installation must be completed to the reasonable

satisfaction of Licensor. Also, when Licensee installs a new streetlight or pole, to replace an existing Licensor streetlight or pole (with no Licensee Equipment previously attached), Licensee shall install Licensor's lights and lighting equipment at Licensee's cost or reimburse Licensor for such installation as a make-ready cost.

m. Upon receiving written notice from Licensor, Licensee shall replace streetlights and poles for good cause (for example, structural damage) whether they are owned by Licensor or Licensee within thirty (30) days unless Licensor agrees to a longer period of time. In the event of catastrophic damage to a streetlight or pole requiring immediate replacement, Licensor shall also have the right to replace the damaged streetlight or pole with a pole from the Spares Inventory, and Licensee shall have the right to attach Equipment to such pole at a later date. If Licensee fails to complete such replacement to the satisfaction of Licensor, Licensor may after written notice to Licensee cause the work to be done, and Licensee shall reimburse Licensor for the reasonable costs incurred within fifteen (15) days after receipt of an itemized list of Licensor's expenses and costs, or Licensor may recover its expenses and costs from any security or pursue any other judicial remedies for the collection thereof.

VIII. PROPERTY AND SITE MAINTENANCE

a. Property. Licensor reserves the right to take any action it deems necessary, in its sole discretion, to repair, maintain, alter, or improve the property and Sites.

b. Site Maintenance. Licensee agrees to and shall: (i) keep each and every Site in a neat, clean and orderly condition at all times; (ii) not cause or permit rubbish, garbage, debris or graffiti to accumulate or remain on or around any Site or property at any time; and (iii) not commit, suffer or allow any acts to be done at or around any Site in violation of any law, regulation or rule.

IX. TERM AND RENTAL AMOUNT

a. This Agreement shall be for an initial term of ten (10) years commencing upon the date of execution of this Agreement by both parties ("Initial Term"). Each Supplement shall be effective as of the date of execution by both parties. The term of each Supplement shall be for ten (10) years; provided, however, in no event shall the duration of the Supplement be for a term longer than the time frame remaining on the Agreement. On the effective date of each Supplement, rental payments for Equipment placement shall commence at an annual rate of \$270 (or such higher rate as set forth by the FCC) for use of a Licensor streetlight or pole or third-party pole or Licensee pole in the Right-of-Way or such other amount as determined by a cost study. The cost study shall include actual and reasonable costs to Licensor which shall be in compliance with the FCC guidelines. Licensor shall provide Licensee with at least ninety (90) calendar days' prior written notice of any adjustment to the annual rental. In the event the Parks and Recreation Department authorizes use of property in City Parks for Licensee's poles or Equipment or the City authorizes use of Other Areas, the annual rental rate shall be as provided in a separate agreement.

b. On all Supplements with a commencement date other than January 1st, the first year's rent shall be prorated to the end of the calendar year in which the commencement date occurs. Similarly, for all Supplements that expire or otherwise terminate on a date other than December 31st, the rent shall be prorated from the beginning of the year to the end of the month in which the Supplement expires or otherwise terminates. Subsequent to the initial payment of

pro-rated rents in the year of the commencement date, the rent due hereunder for all subsequent years shall be paid in annual installments prior to January 1st of each succeeding year. In the event Licensee fails to remit any annual rental payment due to Licensors for any amount due under this Agreement within thirty (30) calendar days from the date such payment is due, Licensee shall pay to Licensors interest equal to one percent (1%) per month of the outstanding annual rental amount until it is paid in full.

X. EXTENSION OF AGREEMENT

Licensee will have the option of extending this Agreement for an additional five (5) years, if Licensee provides Licensors written notice at least ninety (90) days prior to the expiration of the Initial Term and subject to the following performance review. During the last year of the Initial Term, the City will review Licensee's performance under this Agreement to determine whether Licensee has substantially performed in accordance with the terms of this Agreement. Both Parties shall work together to resolve any performance issues. If, after City review, it is determined that Licensee has substantially performed in accordance with this Agreement, then this Agreement may be extended by the City for a renewal term of five (5) years.

XI. GOVERNMENTAL APPROVALS

a. It is understood and agreed that Licensee's use of the Sites is contingent upon its obtaining and maintaining all of the permits and other approvals that may be required by any federal, State or other governmental authority, as well as a satisfactory structural analysis and a Radio Frequency analysis (which demonstrates FCC compliance).

b. Licensors shall not be responsible for any fees or costs associated with such approvals and shall not be responsible for preparing or filing applications, conducting tests or surveys, or compliance with other specific license application requirements such as compliance, where required, with the National Environmental Policy Act, the National Historic Preservation Act, or any other requirements specific to governmental approvals. In the event that: (i) any application for such governmental approvals should be finally rejected; (ii) any governmental approval issued to Licensee is canceled, expires, lapses or is otherwise withdrawn or terminated; or (iii) Licensee determines that such governmental approvals may not be obtained in a timely manner, Licensee shall have the right to terminate the applicable Supplement. Notice of Licensee's exercise of its right to terminate shall be given to Licensors in accordance with the "Notice" provisions below, and shall be effective upon the later of: (a) the receipt of such notice; (b) upon such later date as designated by Licensee; or (c) upon Licensee's removal of the Equipment as required herein. All rentals paid prior to said termination date shall be retained by Licensors. Otherwise, the Licensee shall have no further obligations for the payment of rent to Licensors for the terminated Supplement.

XII. SECURITY

a. Licensee shall provide a performance bond in the amount of two hundred fifty thousand dollars (\$250,000) to ensure the faithful performance of its responsibilities under this Agreement, including, by way of example and not limitation, its obligations to relocate and remove its facilities and to restore City Right-of-Way and other property. Licensee may be required to obtain additional bonds, such as generally applicable construction bonds, in accordance with the

City's ordinary practices. The bonds shall be in a form reasonably acceptable to the City. Licensee shall pay all premiums and costs associated with maintaining the bonds and shall keep the same in full force and effect at all times.

b. If there is an uncured breach of a material provision of this Agreement or pattern of repeated violations of any provision of this Agreement, then the City may request and Licensee shall establish and provide, within thirty (30) days from receiving written notice from the City, a letter of credit from a local financial institution satisfactory to the City in the amount of twenty-five thousand dollars (\$25,000).

c. Additionally, after the giving of notice by the City to Licensee, and expiration of any applicable cure period, the letter of credit may be drawn upon by the City for purposes that include, but are not limited to the following:

- i. Failure of Licensee to pay the City sums due under the terms of this Agreement;
- ii. Reimbursement of costs borne by the City to correct Agreement violations not corrected by Licensee; and
- iii. Monetary remedies or damages assessed against Licensee or Licensor.

d. The City shall give Licensee written notice of any withdrawal under this subsection. Within fifteen (15) days following receipt of such notice, Licensee shall restore the letter of credit to the amount required under this Agreement. Licensee's maintenance of the letter of credit shall not be construed to excuse unfaithful performance by Licensee or limit the liability of Licensee to the amount of the letter of credit or otherwise limit the City's recourse to any other remedy available at law or in equity.

e. Licensee agrees to maintain a continuous uninterrupted letter of credit and bonds in the amounts required for the duration of this Agreement and thereafter if specified in this Agreement.

f. Licensee shall have the right to appeal to the City Administrator and then to City Council for reimbursement in the event Licensee believes that the letter of credit was drawn upon improperly. After a determination by the City Administrator and then the City Council, Licensee shall also have the right of judicial appeal if Licensee believes the letter of credit has not been properly drawn upon in accordance with this Agreement. Any funds the City erroneously or wrongfully withdraws from the letter of credit shall be returned to Licensee with interest from the date of withdrawal at a rate equal to the then applicable prime rate of interest as quoted in The Wall Street Journal.

XIII. UNAUTHORIZED USE

In the event Licensee installs Equipment on Licensor's streetlights or poles or third-party poles or Licensee's poles prior to receiving written authorization from the City, Licensee shall be responsible for removal, if required by Licensor, and all damages and expenses resulting from such unauthorized attachment.

XIV. INDEMNIFICATION

a. Licensee shall indemnify, hold harmless and defend Licensor, its officers, officials, employees, contractors and agents from and against any and all liabilities, damages or claims, including but not limited to all actual and reasonable costs, attorneys' fees, and other charges and expenses that Licensor, its officers, officials, employees, contractors and agents may incur, by reason of the construction, installation, operation, maintenance, use, repair, upgrade or removal of Licensee's Equipment or any other use of a Site by Licensee, or by the breach of the terms of this Agreement by Licensee, including acts or omissions by its agents, contractors, or subcontractors, except to the extent that such liabilities, damages or claims are a result of the sole negligence or willful misconduct of Licensor.

b. Licensee shall also defend, indemnify and hold harmless Licensor, its officers, officials, employees, contractors and agents from and against any fines, fees or penalties, whether regulatory, administrative, criminal or civil and attorneys' fees and expenses arising from Licensee's failure to comply with, or violation of applicable Federal, State or local laws except to the extent that such fines, fees or penalties are a result of the sole negligence or willful misconduct of Licensor.

XV. TAXES

Licensee shall pay before delinquency any and all taxes, assessments or other public charges which may be levied, assessed or imposed upon any of Licensee's interests herein, upon Licensee's businesses or upon any Equipment of Licensee at a Site.

XVI. INSURANCE

a. Licensee, at its cost and expense, shall carry and maintain, at all times during this Agreement, the following types of insurance in the following amounts: (i) Commercial General Liability insurance of \$5,000,000 per occurrence for bodily injury and property damage and \$5,000,000 general aggregate including premises-operations, contractual liability, personal injury and products completed operations; (ii) Commercial Automobile Liability insurance covering all owned, non-owned and hired vehicles with a combined single limit of \$3,000,000 each accident or occurrence for bodily injury and property damage; and (iii) Workers Compensation Insurance in accordance with State law requirements. The Commercial General Liability insurance policy shall include the Licensor, its elected and appointed officials, officers and employees as additional insureds by endorsement as their interests may appear under this Agreement for any covered liability caused, in whole or in part, by Licensee's performance or non-performance of work under this Agreement. Licensee shall provide Licensor with thirty (30) days prior written notice of cancellation or non-renewal of any required coverage that is not replaced. Coverage under this provision shall be reviewed once every two (2) years by Licensor and additional types of coverage or limits may be required, upon sixty (60) days written notice to Licensee.

b. Within thirty (30) days after both parties have signed this Agreement, and prior to each anniversary date thereafter, Licensee shall deliver to Licensor certificates of insurance evidencing the required coverage.

c. Licensee shall obtain and always maintain during this Agreement Workers Compensation and Employer's Liability Insurance in an amount of \$1,000,000 for each accident/disease/policy limit and shall furnish the Licensor with an annual certificate of insurance showing proof of such coverage.

d. In addition, Licensee shall obtain and maintain at all times during this Agreement Umbrella/Excess liability insurance in an amount of \$3,000,000 per occurrence and in the aggregate. Licensee may use any combination of primary and excess insurance to meet the total limits required.

e. Any insurance provider of Licensee must be eligible to do business in Montana and carry a minimum rating assigned by AM Best of "A-" Overall and a Financial Size Category of "VII."

XVII. LIMITATION OF LIABILITY

Neither party shall be liable to the other party, or any of its respective agents, representatives or employees, for any lost revenue, lost profits, loss of technology, punitive, special, exemplary or consequential damages, loss of data, or interruption or loss of use of service suffered by the other party or by any customer of such other party or any other person, even if advised of the possibility of such damages, whether under theory of contract, tort (including negligence), strict liability or otherwise.

XVIII. RF EMISSIONS

Licensee's operation of its Equipment will comply with all FCC regulations regarding RF emissions and exposure limitations. Licensee is allowed to install signage and other mitigation, such as a power cut-off switch on structures, to allow workers and third parties to avoid excess exposure to RF emissions. Except in an emergency, Licensor's authorized field personnel will contact Licensee's designated point of contact with reasonable advance notice, but in no event less than one (1) business day in advance, to inform Licensee of the need for a temporary power-shut-down. In the event of an unplanned outage or cut-off of power or an emergency, the power-down will be performed with such advance notice as soon as practicable. Once the work has been completed and the worker(s) have departed the exposure area, the party who accomplished the power-down shall restore power and inform Licensee as soon as possible that power has been restored. The parties acknowledge that they understand the vital nature of Licensee's Equipment and agree to limit the frequency of power-downs and to have power restored as soon as reasonably possible.

XIX. INTERFERENCE

a. Licensee, in the performance and exercise of its rights and obligations under this Agreement and any Supplement, agrees to install Equipment of the type and frequency which will not cause harmful interference which is measurable in accordance with then-existing Industry standards, or otherwise physically interfere in any manner with the equipment of any higher priority users. In the event any Licensee Equipment causes such signal interference, and after Licensor has notified Licensee of such interference by a written communication or a call to Licensee's NOC at _____, Licensee will take all commercially reasonable steps necessary

to correct and eliminate the interference including, but not limited to, at Licensee's option, powering down the interfering Equipment and later powering up the Equipment for intermittent testing. The Licensee agrees to cooperate with users of the property to resolve issues of signal or physical interference.

b. Licensors does not warrant that Licensee's use of the Site will be free from interference caused by third parties. However, Licensors will not grant after the date of this Agreement, a permit, license or any other right to any third party if, at the time such third party applies to use a Site, that Licensors knows or has reason to know may cause physical interference with the Licensee's operations.

XX. ABANDONMENT

If Licensors determines to abandon any structure or infrastructure and Licensors so determines that the structure or infrastructure does not need to be permanently removed for reasons of public safety or security, then Licensors shall give Licensee ninety (90) days' prior written notice of Licensors's intent to abandon the structure or infrastructure, as the case may be. Within such time, Licensee shall remove or otherwise dispose of its small wireless facilities, at which time the Supplement shall automatically terminate without further liability to Licensee.

XXI. REMOVAL AT END OF SUPPLEMENT

Licensee shall, upon expiration of the term of a Supplement, or within sixty (60) calendar days after any earlier termination, remove its Equipment, conduits, fixtures and all personal property and restore the Site to its original condition, reasonable wear and tear excepted. Additionally, the Licensee shall, at its sole cost and expense, restore, repair and replace to as near a condition as possible any portion of the Right-of-Way that is damaged or disturbed by the Licensee's Equipment or work in or adjacent to the Right-of-Way.

XXII. NO REPRESENTATIONS OR WARRANTIES

a. Licensors makes no representation or warranty regarding the condition of its title to the property or its right to grant to Licensee use or occupation thereof under this Agreement. The license granted herein is "AS IS, WHERE IS." Licensee is entering into this Agreement, and Licensee's use of the property is subject to Licensee's own investigation and acceptance. Licensee's rights pursuant to this Agreement are subject and subordinate to all limitations, restrictions and encumbrances relating to Licensors's interest in the property.

b. It is Licensee's election to install and maintain Equipment at each Site, and Licensee does so solely at its own risk. Licensors makes no representations or warranties regarding the suitability, condition or fitness of any streetlight, pole or Site for the installation, maintenance or use of Licensee's Equipment.

XXIII. ASSIGNMENT

This Agreement and each Supplement under it may be sold, assigned, or transferred by Licensee without any approval or consent of Licensors to Licensee's affiliates or to any entity which acquires all or substantially all of Licensee's assets in the market defined by the FCC in which the

Sites are located by reason of a merger or acquisition. Licensee shall provide written notice of any such sale, assignment, or transfer within thirty (30) calendar days thereof. As to other circumstances, this Agreement and each Supplement may not be sold, assigned or transferred without the prior written consent of Licensor, which consent shall not be unreasonably withheld.

XXIV. NOTICES

All notices hereunder must be in writing and shall be deemed validly given if sent by certified mail, postage prepaid, return receipt requested, or by commercial courier, addressed as follows:

XXV. DEFAULT

In the event there is a breach by a party with respect to any of the provisions of this Agreement or a Supplement, or its obligations hereunder or thereunder, the non-breaching party shall give the breaching party written notice of such breach. After receipt of such written notice, the breaching party shall have thirty (30) days in which to cure any breach; provided the breaching party shall have such extended period of time as may be required beyond the thirty (30) days if the breaching party commences the cure within the thirty (30) day period and thereafter continuously and diligently pursues the cure to completion. A party's failure to cure a breach within the time period set forth herein shall constitute a default.

XXVI. REMEDIES

In the event of a default by either party, without limiting the non-defaulting party in the exercise of any right or remedy which the non-defaulting party may have by reason of such default, the non-defaulting party may terminate this Agreement or the applicable Supplement and pursue any legal or equitable remedy now or hereafter available to the non-defaulting Party under applicable laws. Further, upon a default, the non-defaulting Party may, at its option (but without an obligation to do so), perform the defaulting party's duty or obligation (including but not limited to removal or restoration) on the defaulting party's behalf. The costs and expenses of any such performance by the non-defaulting party shall be due and payable by the defaulting party within fifteen (15) days of invoice therefor.

XXVII. ENVIRONMENTAL

Licensee shall conduct its business in compliance with all applicable laws governing the protection of the environment. The parties recognize that neither party shall be responsible to the other party for any environmental condition or issue except to the extent resulting from that party's specific activities and responsibilities. In the event that Licensee encounters any hazardous substances that do not result from its activities, it shall immediately provide written notice to Licensors of such condition, and may relocate its facilities to avoid such hazardous substances to a mutually-agreeable location.

XXVIII. FORCE MAJEURE

Neither Licensors nor Licensee shall be liable for delay in performance of, or failure to perform, in whole or in part, its obligations pursuant to this Agreement or any Supplement, due to an event or events reasonably beyond the ability of Licensee or Licensors to anticipate and control. "Force majeure" includes, but is not limited to, acts of God, incidences of terrorism, war or riots, labor strikes or civil disturbances, earthquakes, fires, windstorms, floods, explosions or tornadoes.

XXIX. LICENSE INTEREST ONLY

Nothing herein shall be deemed to create a lease, or grant an easement, or grant any ownership or other interest in any Site or pole, other than a license to use the applicable Site or pole, revocable as set forth herein.

XXX. NOT AGENT OF LICENSOR

Nothing in this Agreement or any acts of Licensors shall authorize Licensee or any of its employees, agents or contractors to act as an agent, contractor, joint venturer or employee of Licensors for any purpose.

XXXI. RESERVATION OF RIGHTS

Licensee understands, acknowledges and agrees that any and all authorizations granted to Licensee under this Agreement and individual Supplements are non-exclusive and shall remain subject to all prior and continuing regulatory and proprietary rights and powers of Licensors to regulate, govern and use Licensors property, as well as any existing encumbrances, deeds, covenants, restrictions, easements, dedications and other claims of title that may affect Licensors property. Licensors and Licensee agree that nothing contained in, or contemplated by, this Agreement or individual Supplement is intended to confer, convey, create or grant to Licensee any perpetual interest in any Site or in any Right-of-Way or in any pole.

XXXII. REIMBURSEMENT

Licensee agrees to reimburse Licensors, within thirty (30) days of receipt of an invoice from Licensors, for all of Licensors's costs and expenses (including outside consultants' fees and expenses) in drafting, developing, negotiating and finalizing this Agreement.

XXXIII. MISCELLANEOUS

a. Approval of this Agreement by Licensor shall be in a form approved by the City Attorney and executed by an authorized representative on behalf of the City. Following said approval of this Agreement, each individual Supplement may be executed by the Director of Public Works or her/his designee after approval of Licensee's application by all applicable City Departments.

b. This Agreement and Supplements that may be executed from time to time contain all of the agreements, promises and understandings between Licensor and Licensee relating to the subject matter hereof, and no oral agreement shall be binding upon Licensor or Licensee in any dispute, controversy or proceeding. This Agreement and Supplements may not be amended or varied except in writing signed by both parties. This Agreement and Supplements shall extend to and bind the permitted successors and assigns of the Parties hereto. The failure of either party to insist upon strict performance of any of the terms or conditions of this Agreement or Supplement, or to exercise any of its rights hereunder, shall not waive such rights, and such party shall have the right to enforce such rights at any time.

c. The performance of this Agreement and each Supplement shall be governed, interpreted and construed under the laws of Montana without reference to its choice of law rules.

d. In the event of a conflict between this Agreement and a Supplement, the Agreement shall control.

e. This Agreement does not waive Licensor's sovereign immunity, and Licensor reserves the right to rely on sovereign immunity to the extent provided by federal and State law.

f. Venue and jurisdiction for disputes arising under this Agreement shall be in the _____ Court in Yellowstone County or the United States District Court for the District of Montana in Billings.

g. This Agreement may be executed in multiple counterparts, each of which shall be deemed an original, and all such counterparts taken together shall constitute one and the same Agreement.

Licensee may access a Site to inspect, repair and maintain its Equipment located within an unlocked or unsecured Site, provided that such access does not interfere with traffic and site lines, public safety or public health or unreasonably disturb Licensor's business or operations conducted on the Site. Licensee shall provide Licensor with at least forty-eight (48) hours prior written notice that Licensee intends to access a Site (which written notice may be delivered by email or other electronic means to the person designated by Licensor). Notwithstanding any of the foregoing to the contrary, Licensor may deny Licensee access for a reasonable time if Licensor, in its sole discretion, determines that such access will interfere with the health, safety or welfare of the public or Licensor's employees.

5. Term. The commencement date shall be the date set forth above and the term of this Supplement shall be for _____ (____) years. In no event shall the duration of the Supplement be for a term longer than that time frame remaining on the term of the Agreement. If a default arises with respect to one or more Sites which are included within a Supplement and if such default is not cured in accordance with the terms of the Agreement, such Site will be deemed removed from the Supplement and the Supplement shall otherwise remain in full force and effect.

6. Consideration. Rent for each Site for a City streetlight or pole in the Right-of-Way for this Supplement shall be \$270 payable annually (or such higher rate as set forth by the FCC) or such other amount as determined by a cost study. Rent for the placement of Licensee Equipment on any other pole or facility which is owned by Licensee or a third party and located in the Right-of-Way shall be \$270 payable annually (or such higher rate as set forth by the FCC) or such other amount as determined by a cost study.

7. Inspection of Records. Licensee agrees to make information available to Licensor regarding the Equipment used in the operation of the Site, including, without limitation, information regarding FCC approvals, power consumption, signal strength and RF emissions. Licensee shall deliver such information within ten (10) days after a written request therefore. Licensor may request that such information be delivered in a summary fashion in electronic format.

9. Streetlights or Poles. Licensee agrees to construct and install, at its cost and expense, streetlights, poles and Equipment on the Site according to the location, size, and specifications contained within the final construction plans as approved in writing by Licensor. Licensee agrees that the streetlights, poles and Equipment will be constructed in a good and workmanlike manner.

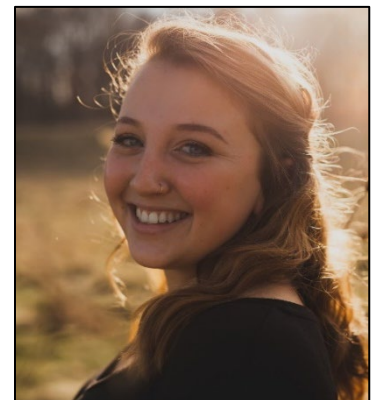
