II. PRESENTATION OF ORDINANCE FOR CIRCUS ANIMALS IN BILLINGS

Cara Chamberlain leads the discussion

A. PUBLIC COMMENTS

(Renee Stone baker) talks about a public petition that they have that has Over 250 signatures to ban animals in the circus & also raises the issue Of animal cruelty. Also presents a copy of Missoula's Ordinance

(Blake Fulton) discusses the issue of whether the City of Billings has the Means to deal with circus animals getting loose, tigers, lions, elephants...etc.

And feels that there is better option for the circus than using animals

(Ryan Ulrich) talks about how he does not feel that animals in the circus Is not what Billings needs

B. PUBLIC SAFETY

1. Do circuses have a contingency plan in case an animal were to Escape and were running loose
2. Is there a certification process that the circus goes through on how? They are required to keep and contain their animals
 - a. Certification varies from State to State
 - b. Do circuses have to pass a USDA inspection
3. Billings Police Dept\Animal Control are not trained to handle This type of situation

Discussion about whether anybody has had a chance to research Any laws within the State of Montana as it relates to circuses and Whether anybody has ever spoken with the Shrine about excluding Animals in the circuses they sponsor

1. STATE CRUELTY LAW

People that commit the offense of cruel or mistreatment of animals In the City of Billings can be issued a citation under the Montana State Cruelty Law, **45-8-211**

- a.** A stringent ordinance could make it difficult to enforce
So the City of Billings prefers to use the State Law as it gives
A lot of latitude

IV. WILDLIFE

- A.** Animal Control for the City of Billings does respond on injured wildlife calls
- B.** Police Department Officers respond on large game animals that may require Being dispatched to prevent suffering
- C.** Fish and Game are technically responsible for all wildlife
