If required by code, depending on final occupancy, the tenant improvement plans will need to correct any required fire separations, restroom requirements , etc. By others. the demising walls are intended to be left open on one side for ease of future electrical component installation, to be finished out during tenant improvement phase of project. notes: The new walls are intended to be demising walls only. note: no fire ratings necessary for M occupancy businesses (former tenant in Suites 1,2, and 3 was M and wouldn't be a change of use) Full tenant improvement plans will be submitted for review and approval under separate cover, by others prior to occupancy of the space. A new electrical service is planned for Suite 3, but will be a under separate permit by the Electrical Contractor.
