2. **PRPL Billings Community and Senior Center News** – The Billings Community and Senior Center is currently wrapping up the summer sessions for our Recreation and Wellness programs. While many places that offer wellness programming find a decline during the summer months our programming tends to stay steady in participation. For seniors having a place to stay fit inside with temperature-controlled environment can help elevate the tendency to get heat related illness which many seniors have lower threshold for.

Group wellness programs also offer many of our seniors a community of peers who are all focusing on staying healthy and helping with decreasing social isolation. Our community Tai Chi Class started a beginner class and is averaging 20-30 each week. Like many of our other classes this helps senior work on balance and stability.

On average we have around 350 plus seniors a week come through to utilize the facility along with another 120 participating every week in our programming hosted at the ARA, Adult Resource Alliance facilities. Overall, we have around 100 seniors daily participating in our wellness programming. In our congregate meal site, we have around 60 plus seniors receiving meals every week. Our Recreation and Wellness Specialist has been working with the ARA, to bring more programming out to the west end location as there is a significant need for wellness programming that meets the needs of Seniors. This expansion was put on hold as the facility who was willing to host had flooding issues. We are tentatively looking to expand in the fall/winter sessions.

During the summer months we also had several kids' camps, keyboarding camp, rocket camp, aviation camp and character design camp. Being able to have kids camps while our seniors also have their wellness programs is a great way to promote intergenerational programming. Many of our seniors were excited to see what the kids were doing in their camps, some wishing they could attend as well. It truly was a great way to continue to activate our Community and Senior Center with all ages and stages.

4. **Park & Recreation News** – The Parks and Recreation Department is holding its annual Dog Days of



Summer event at Rose Park Pool on Sunday, August 20th from 12-3 PM! Admission fee is \$4 per dog. Pet owners are required to supervise their dogs but will not be charged an entrance fee. We ask that all owners be responsible for cleaning up after their dogs on the pool deck and grass areas. Water-friendly toys and life jackets are allowed, and lifeguards will be on duty. All dogs must be up to date with rabies shots and vaccinations.

With school back in session next week, all summer camps and activities have ended for the season. Due to the loss of seasonal aquatic staff, South Pool closed for the summer on Thursday, August 17th.

Season passes from South Pool are excepted at Rose Pool through the end of the swim season on Saturday the 19th.

NFL Flag Football registration is being accepted through the start of practice on August 28th. Practice locations include Optimist, Castle Rock, Veteran's, and Country Manor Parks. Games will be held on Saturday mornings beginning September 16th at Centennial Park.

5. New City Hall Update - It was a good productive week at the new city hall project. Wall framing continued on the 2nd floor. Backing for cabinets and other wall mounted equipment was being installed on the 4th and 5th floors. Started hanging sheetrock at the north and west walls of council chambers where additional framing must take place. Electrical wall rough in on 5th and 4th floors continues and looks good. VAV's on the 5th floor are all in and have started to be installed on the 4th floor. Duct work is being put up on the 4th floor as well. Fire sprinkler rough in on the 4th floor wrapped up today and 2nd floor will start next week. Plumbing wall rough in on the 5th floor made good progress this week. The 4" main hydronic lines are being welded and placed. Finished installing the first shipment of hollow metal door frames.

Major Board or Commission accomplishments of the preceding year: The airport is continuing to move forward with the terminal construction project. Long-term land use planning for increased aeronautical and non-aeronautical development continues. The BIL has begun an aggressive air service development effort to increase flights.

Major Board or Commission challenges of the preceding year: January 2023, Kevin Ploehn retired leading to an executive search for a new Director, Jeff Roach, A.A.E began on January 16, 2023. Jeff came to BIL from Nashville, TN after four years with the Metropolitan Nashville Airport Authority (MNAA) as the Assistant Vice President for strategic planning and the Executive Director of the John C. Tune Airport (JWN). Prior to that Jeff was the airport manager at Fairbanks International Airport (FAI) when he retired from the State of Alaska DOT&PF in July 2018.

Major Board or Commission goals for the upcoming year: Planning an event to commemorate the final project completion of the airport terminal, expected in the Spring of 2024, (with the opening of the B Concourse, which will allow four new jet bridge gates for large commercial service aircraft.) Initiating the MET Transit's Transit Development Plan for FY'23. MET Transit ordered four electric buses, the buses are expected to arrive in late FY'24 and the new systems will need to be integrated into the fleet and utilized effectively.
