

## **Billings airport gears up for second busiest year-end holiday travel rush**

The Billings Logan International Airport is on track to top off 2023 with the second busiest year-end holiday travel rush on record.

Passenger projections estimate the airport will serve 78,430 travelers this month.

Although the passenger counts have yet to return to pre-pandemic levels, they're steadily climbing back from the low of 45,405 in December 2020. But, they've yet to top the 87,032 travelers in the last month of 2019.

"It's looking like we'll end the year close to 2019 but we're not quite there," Billings Aviation and Transit Director Jeff Roach said.

The airlines will report actual passenger counts for this month in mid-January. Estimates for the peak holiday travel period from Dec. 20 to 31, show BIL will serve 1,944 to 2,704 passengers a day.

During last week's Christmas travel rush, the terminal parking and overflow lots filled up. Airport staff opened the gravel lots along Overlook Drive just west of the control tower and ran a shuttle to take passengers to the terminal.

Overflow parking lots at the Billings airport have filled to capacity and some vehicles are parked along Overlook Drive as residents travel for the holidays.

"We do it as a courtesy as long as staffing allows," Roach said.

However, he said, not all drivers followed signs and directions to the designated parking area and a few vehicles had to be moved to a safe location. Parking on the grass or along the road is never allowed.

Roach said the airport's overflow lots rarely fill up but it is a possibility travelers should plan ahead for. He suggests arriving at least two hours before a scheduled flight.

He also encourages passengers to avoid delays by double checking their checked and carry-on bags to make sure they do not have prohibited items.

Lorie Dankers with TSA Public Affairs demonstrates how to properly prepare a firearm for air travel. In 2022, the Billings Logan International Airport had a record number of firearms recovered from carry-on luggage, with 17 guns found in luggage at the TSA screening checkpoint.

Roach said his operations team will continue to work hard to accommodate travelers' parking needs, running the shuttle as long as staffing allows.

They plan to look into expanding terminal parking during the airport master plan update, which is expected to begin in early 2024.



# Update on Grant Funding Received by the City of Billings

## December 2023

### Rose Park Trail Phases I & II



At 20 acres, Rose Park extends from 22nd Street West and Avenue B to the BBWA Canal and Rose Park Elementary School. The Park includes ballfields, pool, water slide, playground, and more. New trails will connect neighborhoods on the west side of the park to Rose Park School.

The 2022 Safe Routes to Schools update lists Rose Park Elementary as a location needing both trail construction to connect the school with its surrounding neighborhoods, especially to the apartment complexes located on and around Avenue C on the west side of Rose Park.

City planning received grant funding in FY23 to construct a segment of trail from Rose Park Elementary to the northeastern edge of Rose Park (red line, above). That section will be built this summer (2024). A grant application will be submitted this month to fund a trail segment connecting the new trail to the Rose Park trail system (yellow line, above) and to the Canal Connection Trail that was built in 2022 on the north side of the BBWA Canal. The new grant application would also repair existing concrete in the park (light blue dotted line, above). The new projects would be built in 2025.

### More About This Project

The Rose Park Trail as currently planned will:

- connect Rose Park Elementary School with neighborhoods – most notably the apartment complexes on and around Avenue C west of Rose Park.
- provide recreational walking, riding, rolling, and running for more than half a mile parallel to the BBWA Canal.
- allow residents north of the Canal to access Rose Park (via a pedestrian bridge) without needing to cross streets.
- provide residents and visitors with access to the northern section of Rose Park.
