

## Billings City Administrator Weekly Report

January 19, 2024

- 1. Montana Opioid Abatement Trust Fund** – the committee held its first meeting to discuss priorities and how best to use these critical resources to deal with the effects of addiction. The implementation of an agreed upon plan is the preferred path forward. Billings is expected to receive \$65,000 annually for 18 years.
- 2. Budget Launch** – Andy and I worked through improvements for this year's budget process. The most visible change is that the Council and public will see what each department has requested. This will allow everyone to better understand what each department director and their team believes should be invested to best meet the current and future needs and opportunities for the organization. This will be followed by the customary balanced budget and ultimately the budget the Council adopts.

## 8. New City Hall Update –

### **5<sup>th</sup> Floor**

Install radius ceiling panels in the council chambers.  
Install linear light fixtures on radius ceiling panels.  
Set sprinkler head in radius ceiling panels.  
Metal stud framing at exterior walls.  
Finish wall and floor tile in main restroom group.  
Run data cables and trim outlets.  
Start installing plumbing fixtures.  
Tape acoustic panel ceiling in council chambers.  
Insulation and vapor barrier at exterior walls.  
Welding heat exchanger piping in fan room.

### **4<sup>th</sup> Floor**


Install ceiling wires for light fixtures.

Plumbing tie in between 2<sup>nd</sup> and 3<sup>rd</sup> floor.  
Hard lid and soffit framing.  
Electrical rough in at hard lids.  
Lighting controls and light fixture box make up.  
Prep, prime and paint hollow metal frames on the north end.  
Paint wall accent color south end.

### **1<sup>st</sup> Floor**

HVAC overhead rough in and VAV's.  
Hydronic piping.  
Overhead waste and vent tie in.  
Box walk electrical rough in.  
Air handler delivery and stored on west side.  
Demo existing mixing boxes under windows.





- 7 Key Positive Childhood Experiences
  - Ability to talk openly with family about feelings
  - Feel supported by family during difficult times
  - Feeling safe and protected by an adult in the home
  - Feeling supported by friends
  - Sense of belonging and connection to a larger group
  - Enjoyment of participation in community traditions
  - Relationship w/at least two non-parent adult who takes genuine interest in the child





# Household Challenges – Mental Health

24% have considered suicide at some point in their lifetime

26 people died by suicide each year per 100,000 population in Yellowstone County

- Higher than MT (25.7) and **nearly 2x the US (13.9)**





# Challenges Facing Youth

- **41% were so sad or hopeless almost every day for 2 weeks or more to the point that they stopped doing activities (depressed)**
- **23% seriously considered suicide**
- **19% made a plan to suicide**




Degree to Which Life Has Been Negatively



# Youth Injury and Violence

---

**In 2021, Yellowstone County youth reported that in the last year they:**

- Carried a weapon on school property: 8.53%
- Carried gun for a use other than hunting/sport: 8.67%
- Were threatened or injured with a weapon: 6.42%
- Skipped school due to perceived lack of safety: 7.8%
- Were in a physical fight: 20.37%
- Were forced into sexual “things” against their will: 13.28%

# Injury and Safety

Unintentional injuries were 4<sup>th</sup> leading cause of death in Yellowstone County from 2018 – 2020, and include:

1. Falls (31%)
2. Poisoning/Drug Overdoses (26%)
3. Motor Vehicle Crashes (22%)
4. Suffocation (5%)
5. Other (17%)






# Prevalence of PSEs in Yellowstone County



# Belonging and Support - Youth

## According to the 2022 Yellowstone County Prevention Needs Assessment:

- 69% say their parents often or always notice when they are doing a good job and let them know about it
- 63% say their parents tell them they are proud of them often or all the time
- 78% can share their thoughts and feelings with their mother, 77% with their father
- 45% of YC report that they have several adults in their neighborhood they could talk to about something important
- 70% participated in at least one club, organization, or activity at school in past year
- 45 % volunteered to do community service at least 1x in past year

## Adverse Experiences and Health Concerns

### Intimate Partner Violence

- 23.5% of residents have been slapped, punched, or kicked by an intimate partner vs. 13.7% in US
- Approx. 60% of reported crime in Billings is relational/ intimate partner violence related

### Mental Health and Suicide

- 24.1% considered suicide at some point in their lifetime, up from 1 in 5 in 2020. While suicide is felt by all, our young adults, low-income residents, and residents of color are at greatest risk.
  - Notable worsening over time
  - Most at risk: 18-39 year olds, low-income residents, people of color
- 24% considered suicide at some point in their lifetime

  - 15% were teased or name called for being perceived as gay, lesbian, bisexual

### Substance Misuse

- 43% of residents' lives have been negatively impacted by substance abuse vs 36% in US
  - Most at risk: women, adults ages 18 – 39, mid/high income residents, and people of color
- 35% of youth report using marijuana by their 18<sup>th</sup> birthday
- 23% of adults report excessively drinking
  - 20% of youth reported riding in a vehicle with a driver who had consumed alcohol
  - 7% drove after drinking in past month

    - Note: Firearms (62%), suffocation (20%), and poisoning (9%) are the most common means of suicide in Montana. Other means include carbon monoxide, overdose, motor vehicles accidents, and jumping from heights – may be classified as unintentional due to stigma

## Adverse Childhood Experiences Scale Questionnaire

Every "yes" answer = 1 point

Before your 18<sup>th</sup> birthday:

- 1) Did a parent or other adult in the household often or very often swear at you, insult you, put you down, or humiliate you OR act in a way that made you afraid that you might be physically hurt?
- 2) Did a parent or other adult in the household often or very often push, grab, slap, or throw something at you OR ever hit you so hard that you had marks or were injured?
- 3) Did an adult or person at least 5 years older than you ever touch or fondle you or have you touch their body in a sexual way OR attempt to actually have oral, anal, or vaginal intercourse with you?
- 4) Did you often or very often feel that no one in your family loved you or thought you were important or special OR your family didn't look out for each other, feel close to each other, or support each other?
- 5) Did you often or very often feel that you didn't have enough to eat, had to wear dirty clothes, and had no one to protect you OR your parents were too drunk or high to take care of you or take you to the doctor if you needed it?
- 6) Was a biological parent ever lost to you through divorce, abandonment, or other reason?
- 7) Was your mother or stepmother often or very often pushed, grabbed, slapped, or had something thrown at her OR sometimes, often, or very often kicked, bitten, hit with a fist, or hit with something hard OR ever repeatedly hit over at least a few minutes or threatened with a gun or knife?
- 8) Did you live with anyone who was a problem drinker or alcoholic, or who used street drugs?
- 9) Was a household member depressed or mentally ill, or did a household member attempt suicide?
- 10) Did a household member go to prison?

Every "yes" answer = 1 point

Thinking back to your childhood, before your 18<sup>th</sup> birthday:

- 1) You were able to talk to your family about feelings.
- 2) You had the sense that your family is supportive during difficult times.
- 3) You had the enjoyment of participation in community traditions.
- 4) You had the feeling of a sense of belonging in high school.
- 5) You felt supported by friends.
- 6) You had at least two non-parent adults who genuinely cared.
- 7) You had the feeling of being safe and protected by at least one adult in the home.

This coalition brings together mental health professionals, community volunteers, and various organizations to create a network of resources and support for individuals at risk of suicide. Their efforts focus on providing training, outreach programs, and public awareness campaigns to address the mental health needs of the Yellowstone Valley and promote life-affirming solutions.



### Billings Continuum of Care (CoC)

The Billings CoC is a comprehensive program designed to address homelessness through a coordinated community effort. It encompasses a range of services including emergency shelter, transitional housing, and permanent supportive housing, along with necessary support services. This initiative involves collaboration among local government, non-profit organizations, and community members, aiming to provide holistic solutions and sustainable support to individuals and families experiencing homelessness in the Billings area.



### Yellowstone County DUI Task Force

The YC DUI Task force is an initiative focused on reducing the incidence and impact of driving under the influence (DUI). Through a combination of education, enforcement, and community engagement, the task force aims to raise awareness about the dangers of impaired driving. Their efforts include coordinating with law enforcement agencies, conducting public awareness campaigns, and promoting policy changes to ensure safer roads for the residents.
