

## Billings City Administrator Weekly Report

February 16, 2024

1. **Airport News** – Alaska Airlines announces extension of direct service from Billings to Portland through the end of the year. Allegiant Airlines announces schedule extension for direct service from Billings to Las Vegas and Phoenix-Mesa. (See attached press releases.)
2. **City/County/School Meeting** – Dr. Garcia summarized SD2's public safety levy. Ballots will be mailed in April and due in May. In the area of prevention, the levy will hire 20 individuals working in gang, dropout prevention and safety specialists, counselors, nurses, mental health, and school resources officers. It will also fund a mobile clinic partnership with RiverStone. On the resource side SD2 will install camera and intercom systems in each school along with critical repairs to fire alarms. The total cost to a homeowner with a \$300,000 will be ~\$63/year (\$34.41 for the elementary district and \$28.34 for the high school district). SD2 also presented their plans for the Washington Innovation Center.

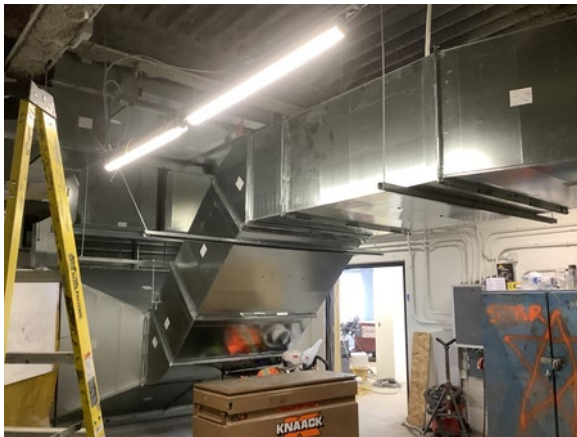

## ALLEGiant AIRLINES ANNOUNCES SCHEDULE EXTENSION FOR DIRECT SERVICE FROM BILLINGS TO LAS VEGAS AND PHOENIX-MESA

**BILLINGS, MT:** The City of Billings, Billings Logan International Airport (BIL), in partnership with Visit Billings, the Billings Chamber of Commerce, and Big Sky Economic Development are thrilled to announce the extension of direct service to Las Vegas (LAS) and Phoenix-Mesa (IWA) through the 2024 fall season. This strategic air service extension increases capacity for two favored destinations for our tourism, business, and leisure travelers in Billings.

Flight extensions will include four weekly flights from Billings to Phoenix-Mesa from August 14<sup>th</sup> through November 6<sup>th</sup>, followed by three weekly flights the week of November 6<sup>th</sup>.

The Billings Fire Department received a \$20,000 grant from Phillips 66. The grant will fund equipment of another rescue unit that will help the department provide better large response rescue support.

The City of Billings Fire Department received a grant from Phillips 66 to fund the equipment for a second rescue unit, allowing the department to augment its rescue team to support mutual aid partners in Yellowstone County and the refinery.

#### More About This Project

The second rescue apparatus includes:

- technical rescue gear, including 11 mm rope and hardware personal protective equipment (PPE) for high-angle, industrial, confined space, and water rescue.

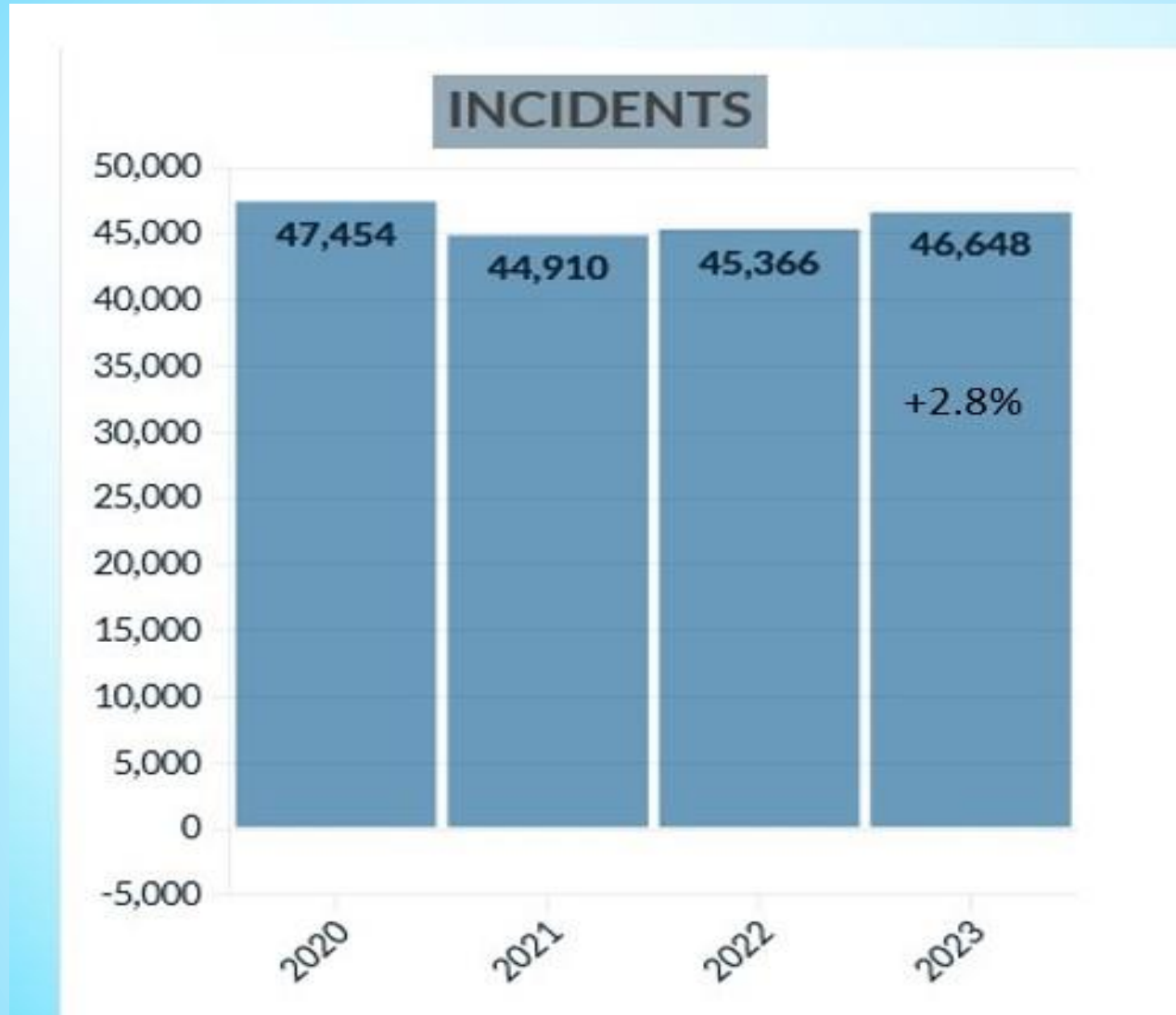

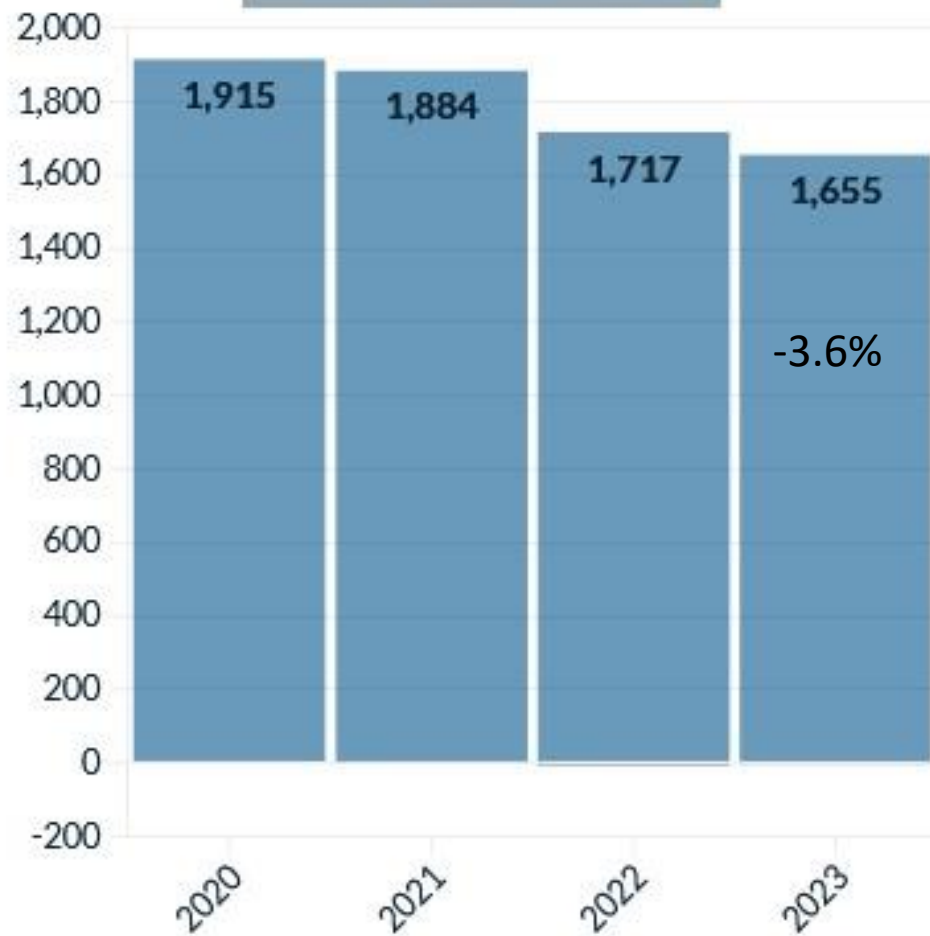




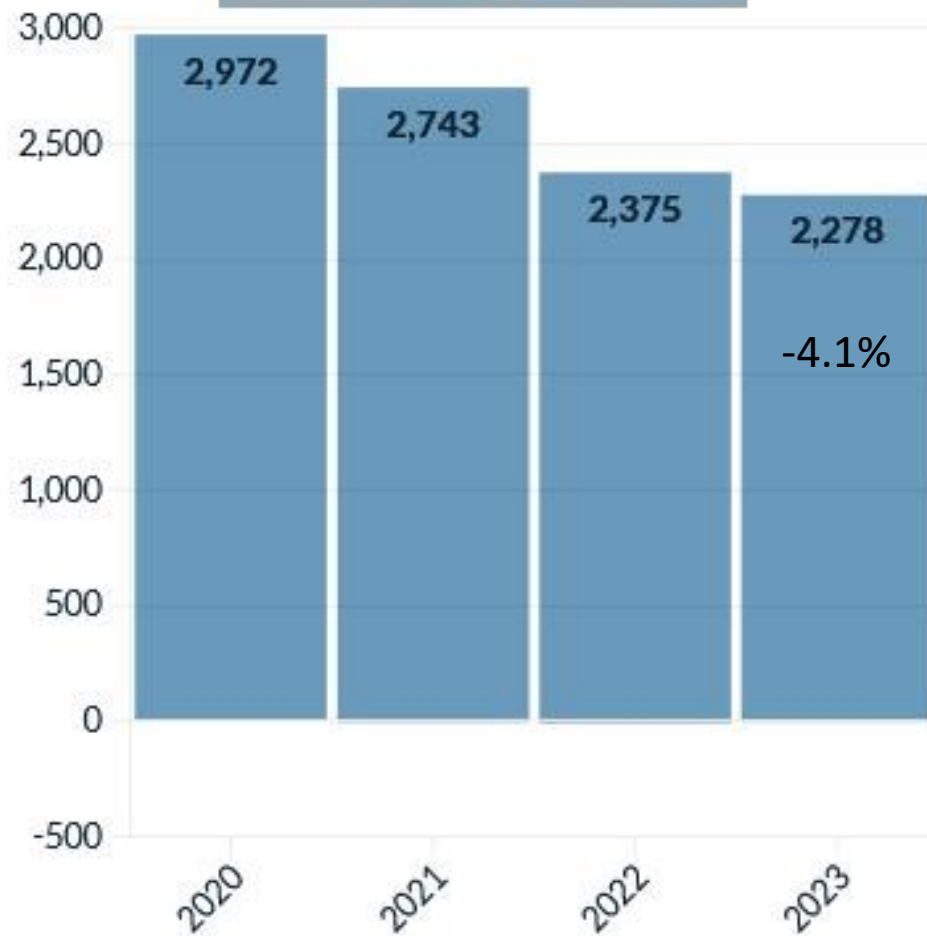

## VIOLENT CRIMES

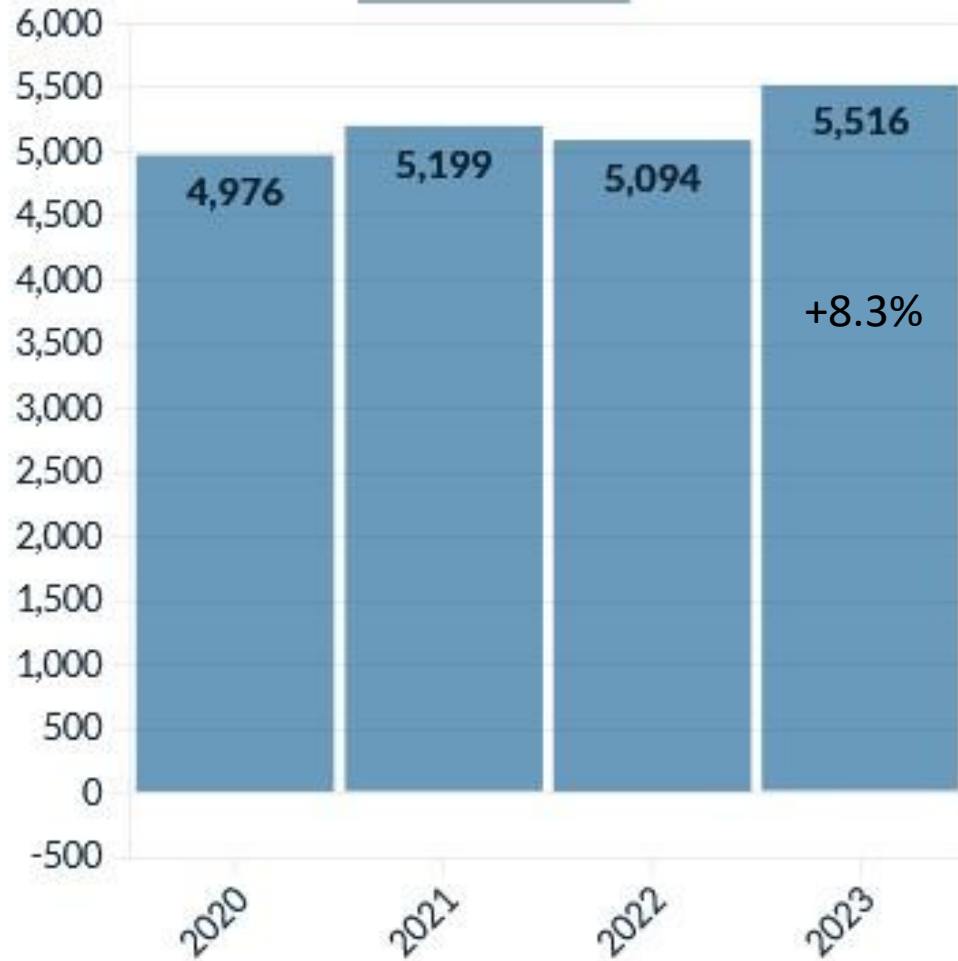

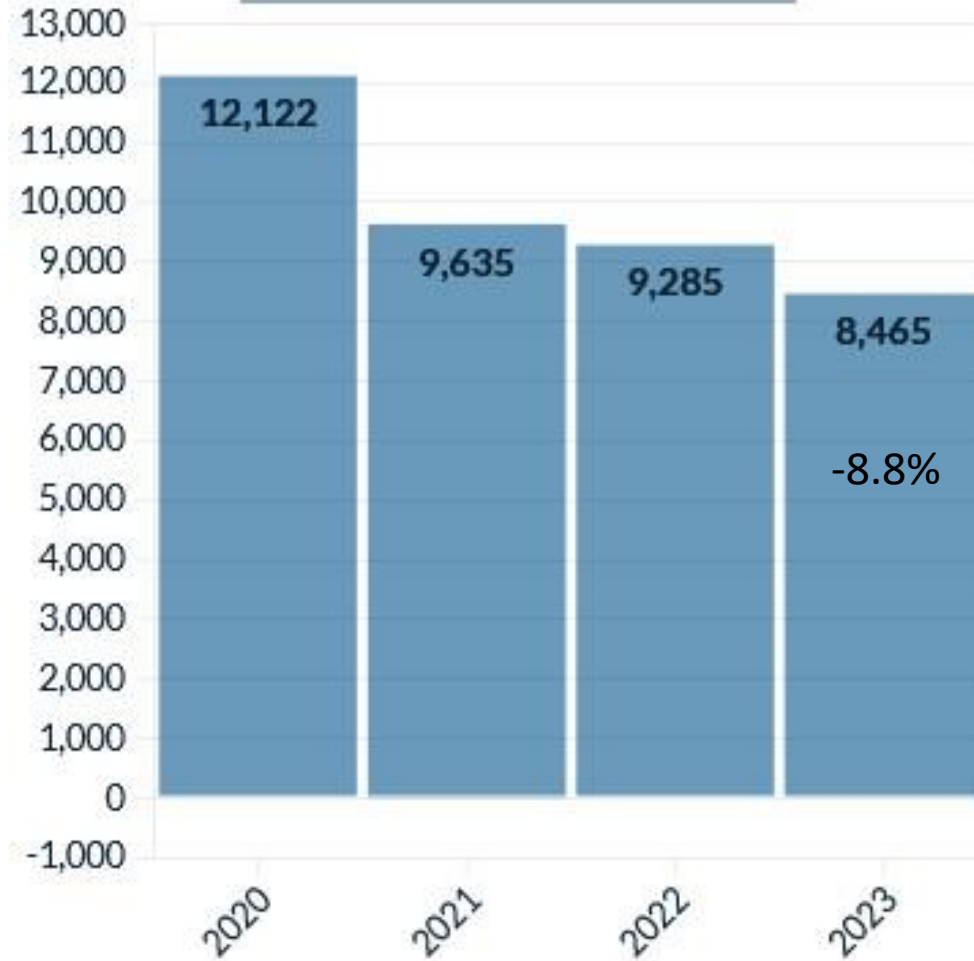
