

## Billings City Administrator Weekly Report

February 21, 2025

- 1. Flooding Concerns** – Several press releases and interviews are getting the word out that we will need help from our citizens clearing the 10,000 storm water inlets as warmer temps arrive. With cold nights and warm days, this will likely be a daily activity during this warm spell. Please help us get the word out. Thanks.
- 2. Legislative and Local Affairs Committee** – Committee attendees request the full council take a position on HB 482. An act revising local government elections; requiring local government elections to be held on a partisan basis: <https://fastdemocracy.com/bill-search/mt/2025/bills/MTB00015964/>.
- 3. Council Orientation** – To date, CM TJ Rogers has met with Administration, Legal, Finance, Library, Planning, Code Enforcement and Community Development.
- 4. Executive Forum** – Next week Mayor Cole, ACA Iffland, Jessica Fust and I will be in Helena for the MLCT Executive Forum. We will also be meeting with our lobbying team of Aimee, Brad, and Maddison and several local representatives to get up to speed on the session.
- 5. Planning News** – The city begins outreach to bring Short Term Rental properties into compliance. The City has identified more than 300 properties that are not in compliance with its 4-year-old short-term rental regulations (STR). The STR ordinance was adopted in 2021 to minimize the negative impacts of STRs on neighborhoods, maintain neighborhood zoning requirements, and provide equity among lodging options. The STR permit application also requires a local contact that can respond to complaints or issues involving the property. A City business license for a first-time STR currently costs \$55, and a STR permit costs \$300. Both must be renewed annually. Courtesy letters are scheduled to go out the week of March 10th. Property owners will have 60 days to come into compliance before they will be referred to Code Enforcement for further action. A media release is also being sent out Monday, February 24 and the City will be posting more information about this effort on its website.

Over 150 community members attended a sold-out Air Service Breakfast at the Northern Hotel in Billings. Attendees learned about industry trends, plans for airport infrastructure and building improvements, and a comprehensive overview of air service developments at BIL.



[Here are three takeaways from the event:](#)

- 1) BIL is updating their master plan, an 18–24-month long process with robust public involvement. This plan will guide two decades worth of development and new airport layout planning.
- 2) BIL is currently classified as a non-hub airport but is on the cusp of becoming a small-hub airport, a classification that has connectivity and funding benefits.
- 3) 15 of BIL's top 20 markets had increased passengers, with 7 of the markets increasing by double-digit percentages.
