Dear Mayor Cole and City Council Members,

I am writing to formally report an instance of administrative obstruction by the City Attorney's Office regarding my search for the truth in the death of my brother, Cole Stump (Case #20-76444).

While the City claims to value transparency, my recent experience proves otherwise:

- Manual Communication Block: My primary email address was manually blocked by the City Attorney's Office. The error code "550 User Entry" confirms this was a deliberate action by a staff member, not a system glitch.
- Restoration After Pressure: Access was only restored after I provided technical proof that the office was misrepresenting a manual block as a "system error".
- Right to Know Violations: This block intentionally delayed my ability to dispute a 100% increase in public records fees (from \$10 to \$20/hour) and my request for missing GPS data for Unit 1428.
- Destruction of Evidence: I am currently seeking the policies that allowed the Department to prioritize ballistics testing over DNA swabbing, an "order of operations" that effectively destroyed biological evidence on the firearm in question.

Under Article II, Section 9 of the Montana Constitution, the public has an onto-logical Right to Know. It is unacceptable for city staff to use "block" buttons to avoid difficult questions regarding a homicide investigation.

I am requesting that the Council intervene to ensure:

1. Accountability: An inquiry into why a grieving family member was manually blocked from contacting the City Attorney.
2. Fee Waiver: A waiver of the new \$20/hour fees for this corrective request.
3. Transparency: The immediate production of the missing GPS data and forensic sequencing policies.

I look forward to your response and will be attending the upcoming January 12th meeting to discuss this further during public comment.

- **Flexible Schedule.** Classes run Tuesday and Thursday evenings (6–10 pm), with shorter work shifts on class days and afternoon instruction. ☘



Each year, Sudden Cardiac Arrest (SCA) takes the lives of hundreds of thousands of Americans. To increase the survival rate, it's important to educate individuals on what SCA is, what the warning signs are, and how to respond if someone around you goes into cardiac arrest. Studies show survival from SCA can double or triple if CPR is administered until emergency medical services arrive.

If you find someone unresponsive and not breathing normally, take the following steps:

- Send someone for an Automated External Defibrillator (AED)
- Check for responsiveness
- Call 911
- Push hard and fast, center of the chest
- Keep going until help arrives



## Utility Billing Talking Points

1. Over 95% of our utility customers have paid their utility bills.
2. As of January 6, 2026, 1,853 customers have delinquent accounts that meet the “turn off criteria”. This is ~4.4% of our billed customers.
  - a. Turn-off criteria is defined as a customer who have not paid for two months, have a balance that exceeds \$100 and are NOT on a payment plan.
  - b. Since December 12, 2025 - the number of customers meeting the turn off criteria has dropped by 1,106 (~37%).
  - c. Of the 1,853; 1,597 are more than 120 days past due.
  - d. Of the 1,853; 1,100 are residential and 500 are commercial accounts.
  - e. Historically, the city has ~750 customers each month who meet the turn off criteria. ~200 are tuned off and ~95% then pay their bill and have water tuned back on within 5 days?
3. Brief History of Utility Billing issue: In June 2024, we converted the utility billing software. Note, this did not include the meter software. The conversion worked as expected and bills went out for all of the cycles. The software did flag about 6,000 accounts that had potential data issues. Staff had to manually review all 6,000 accounts to ensure accuracy of the bills. By the time that was completed, the next month's bills went out 30 days late which resulted in 60 day bills for the majority of customers. The delay caused concern about the accuracy of the bills due to the high amounts from the longer service period. Staff and a 3<sup>rd</sup> party auditor ensured there were no systemic errors in the process. With human involvement, there always has been and will continue to be a potential for errors however, we have complete confidence in the accuracy of the billing system.

**City of Billings Restores Late Fees and Shutoffs with Support Options for Customers**

The City of Billings resumed late fees in December for accounts with delinquent balances. Utility service shut offs begin next week for customers who have not set up a payment plan.

In June 2024, the city transitioned to a new utility billing system. Data issues from the prior system caused billing delays for some customers during the summer and fall of 2024. In response to the confusion those delays created, the city suspended late fees and service shutoffs while the system was reviewed.

Over the past 18 months, City staff and an independent third-party auditor conducted extensive reviews of the billing system, including auditing meter equipment and software. While a limited number of human billing errors were identified and corrected, the reviews found no systemic or software-related issues.

The city believes suspending late fees and shutoffs during the review period was appropriate. However, the suspension resulted in many customers not paying utility bills for an extended period, leaving some accounts with significant balances. To avoid shifting costs to other ratepayers, utility services must be paid for by all users.

The city recognizes that catching up on past-due balances may be difficult for some customers. Service shutoffs are not the desired outcome, and payment plans are available to help customers avoid service interruption. Customers should contact Utility Billing at **406-657-8315, ext. 3** to discuss options. Customers on approved payment plans will not be shut off.

The City of Billings remains committed to serving the community with integrity, consistency, and compassion as it resumes standard utility billing practices.
