Dear City Counselors and Mayor Nelson,

My name is Anne Ross and I reside in the Southwest Corridor of Billings and was born and raised in this city.

It is devastating to watch the chaos and brutality unfolding in the US right now in regards to the activities of ICE agents in Minneapolis and elsewhere. ICE is NOT law enforcement and they show that by disregarding all rules and standards that our police force follows in their interactions with the public. It is unlawful to shoot into a car, even when there's a chance that an officer may be hit by that car. It is unlawful to use deadly force to shoot people when they are fleeing from agents, but we see that ICE is employing these tactics. They are breaking car windows without any cause and violently pulling people from them. They are arresting people without warrants or just cause, many for simply being present at the scene of an ICE operation. ICE is preventing the service of people's rights to due process and forcefully preventing injured people from receiving emergency and potentially life saving medical care. All of this is meant to terrorize residents and prevent them from exercising their 1st amendment rights to free speech. They are abusing, arresting and threatening people by arriving at their homes and threatening their families via running license plates when citizens lawfully follow ICE and record their actions as non-obstructive observers.

All of this is to say that not only am I asking you to forbid any partnership with ICE, the masked secret police demanding to see people's papers and murdering them if they try to escape a gun pointed in their face; I am also asking that you publicly, and through any possible policy actions commit to directing our city police officers to immediately apprehend and arrest any ICE agents who violate the rights of people in our Billings community. I encourage our police force to approach the ICE forces with safety in mind, utilizing any safety equipment necessary to preserve the lives of our officers in the event one of these erratic and unhinged ICE agents might turn their guns on police. The police have signed on to serve and protect the citizens and residents of Billings, and I fully expect that our tax dollars and city resources are used to do just that and mitigate the horrific violence that will inevitably come for our town when they have finished in other places.

The Gestapo is coming, and we desperately need you to hold the line, even if that brings fear to your heart. We need the love in our hearts for our shared humanity and commitment to democracy to prevail over all things. They will not stop at people with brown skin, the LGBTQ+ community, Jews, Muslims and people with disabilities. They will come for each and every one of us.

I will mention that I have heard rumors of certain members laughing or smirking when being pressed on this issue. I expect that it is deeply uncomfortable to govern in this time, and sometimes these types of reactions are not intentional, but people are dying and we need to hold onto reverence for life, and respect the calls for true law and order, true public safety and the relentless protection of our human rights.

Hi, my name is Rebecca Harrington and I'm a Billings resident. I have heard that city Council has been receiving emails encouraging cooperation with ICE, and I am very concerned about this issue. Even if I were too set aside my beliefs about ICE as a general tool of propaganda, there are issues going on with ICE That go beyond what is political and enter into the realm of irresponsibility and civil rights violations.

The irresponsibility and civil rights violations of ICE are bipartisan concerns. Firstly, several unnecessary deaths have taken place as a result of this federal enforcement agency, and it seems that our federal government is trying to sweep these under the rug as unpreventable and appropriate, and if we have the opportunity on a city or state level to deny this lie and egregious use of force, we should.

I think so much of the problem with ICE going way outside the bounds of the law is because there is VERY little accountability or opportunity for recourse in the case that they break laws and violate civil rights. I also find their recruiting strategies appalling as they market the opportunity to wield a gun and "play cops" while making great money and simultaneously not undergoing the training to be a cop or anything remotely close to law enforcement before they are put on the job. Their training is between four and eight weeks, and those who are put on the job are not properly vetted. These are not the right people and they are not trained appropriately to do their job safely. That is the best case scenario. The best case scenario is if I trust their intentions and believe they just want to make money at a government job, and generally speaking I do not trust their intentions because of the beliefs being dispersed among this agency via Kristy Noem. I do not trust an agency that does public facing work, but refuses to show their faces in public so that they can avoid accountability. I do not trust an agency that does not have a structure to hold its agents accountable via badge numbers and body cams. I do not trust an agency that is willing to put failed cops and power hungry men on the street and risk harming US citizens. I do not want to be shot or assaulted in my own town and have my parents hear about it on the news well our head of homeland security says that it was necessary. I do not want to live in a town like this.

Even if you are concerned about the illegal immigrants, please hear my concerns about the quality and validity of this agency and the problematic potential of cooperative work with them. This is a risk to billing citizens.

As a Billings resident, active community member, and mother, I am writing to formally express my strong dissent to ICE operations in Billings.

ICE has caused chaos and violence in every city they've stepped foot in, and it's only seeming to progress. Following the deaths of Keith Porter and Renee Nicole Good, as well as the multitude of deaths, injuries, and violations of civil and human rights that have occurred during detainments and within ICE custody, it is blatantly obvious that ICE is undertrained and will cause disruption and destruction if they come to our city.

The fear they cause is palpable. As a mother, I'm scared. My son does not deserve to witness the atrocities that are being committed by this lawless group of agents.

I recently saw this report: a family was in their car trying to get away from the violence of the raids going on. There was 6 children inside including a 6mo baby. ICE threw tear gas into & underneath of their car, sending 3 of the 6 children to the hospital and causing the 6mo baby to stop breathing. I have not seen an update on whether or not the baby survived. There have also been reports of animal neglect by agents. I read about a dog adoption that took place, unfortunately the location went unmentioned, but agents left behind the pets of a family they'd taken. They left behind nursing dog and its litter of puppies. Nobody knew what happened until neighbors heard the screams of the dogs and finally broke into the house to free them.

There are an innumerable amount of cases like this... people being hurt, lives being endangered, rights being ignored. ICE's violence does not only affect criminals and immigrants. Women, children, men, infants, animals, disabled folks, citizens and noncitizens alike... every single demographic of people has been targeted by ICE. They instill fear, cause harm and destruction, and kill.

I urge you to decline any cooperation or compliance with federal immigration enforcement, and I urge you to prohibit the use of city resources to aid in their efforts.

We must ensure the safety and wellbeing of all of our residents, and keeping ICE off of our streets is a vital part of doing so.

What we are witnessing now is a slow but unmistakable shift away from constitutional norms under the Trump administration—one that has already caused lasting damage to America's moral standing and international credibility.

The United States has long claimed leadership through adherence to the rule of law, due process, and human rights. Aggressive ICE actions—particularly those involving family separation, detention without adequate legal access, workplace raids, and cooperation pressure placed on local governments—directly contradict those principles. They also undermine community trust, making cities less safe by discouraging residents from reporting crimes or seeking emergency services.

Local governments are not powerless in this moment. Cities and counties across the country have chosen to:

- Refuse voluntary cooperation with ICE beyond what is legally required
- Decline participation in detention or transfer agreements
- Prioritize community safety and constitutional protections over political pressure

I urge Billings officials to take a clear and public stand against ICE overreach and to affirm that our city will not be complicit in actions that undermine due process, civil liberties, or human dignity.

This is not a partisan issue. It is a constitutional one. Silence or neutrality in the face of authoritarian drift is itself a choice—and history is not kind to those who stood by while democratic norms were dismantled.

I ask you to publicly clarify Billings' position, limit cooperation with ICE to what is strictly required by law, and affirm your commitment to protecting the rights and safety of all residents.

**INCIDENT DESCRIPTION**

A fire occurred in the bathroom of this apartment. The fire was caused by combustible materials coming into contact with a wall-mounted heating unit. No injuries were reported. The fire was discovered by the occupant and extinguished with an ABC fire extinguisher located in the hallway outside of the apartment. The structure sustained minor fire damage in the bathroom and some minor smoke damage throughout. A full structure fire response was dispatched, consisting of four engine companies, one truck company, one Battalion Chief, a Safety Officer and an ambulance. Engine 4, Engine 3, and AMR made it on scene before cancelling the rest of the incoming units.

This fire serves as a reminder of the importance of Fire Extinguishers. All commercial buildings, including apartment complexes are required to have mounted and inspected fire extinguishers available within 75 feet of travel from anywhere within the structure. The presence of a working and accessible extinguisher in the hallway of this residence along with the quick action of the occupant likely significantly reduced the amount of damage that this fire would have otherwise caused.

Dear City Counselors and Mayor Nelson,

My name is Anne Ross and I reside in the Southwest Corridor of Billings and was born and raised in this city.

It is devastating to watch the chaos and brutality unfolding in the US right now in regards to the activities of ICE agents in Minneapolis and elsewhere. ICE is NOT law enforcement and they show that by disregarding all rules and standards that our police force follows in their interactions with the public. It is unlawful to shoot into a car, even when there's a chance that an officer may be hit by that car. It is unlawful to use deadly force to shoot people when they are fleeing from agents, but we see that ICE is employing these tactics. They are breaking car windows without any cause and violently pulling people from them. They are arresting people without warrants or just cause, many for simply being present at the scene of an ICE operation. ICE

is preventing the service of people's rights to due process and forcefully preventing injured people from receiving emergency and potentially life saving medical care. All of this is meant to terrorize residents and prevent them from exercising their 1st amendment rights to free speech. They are abusing, arresting and threatening people by arriving at their homes and threatening their families via running license plates when citizens lawfully follow ICE and record their actions as non-obstructive observers.

All of this is to say that not only am I asking you to forbid any partnership with ICE, the masked secret police demanding to see people's papers and murdering them if they try to escape a gun pointed in their face; I am also asking that you publicly, and through any possible policy actions commit to directing our city police officers to immediately apprehend and arrest any ICE agents who violate the rights of people in our Billings community. I encourage our police force to approach the ICE forces with safety in mind, utilizing any safety equipment necessary to preserve the lives of our officers in the event one of these erratic and unhinged ICE agents might turn their guns on police. The police have signed on to serve and protect the citizens and residents of Billings, and I fully expect that our tax dollars and city resources are used to do just that and mitigate the horrific violence that will inevitably come for our town when they have finished in other places.

Hi, my name is Rebecca Harrington and I'm a Billings resident. I have heard that city Council has been receiving emails encouraging cooperation with ICE, and I am very concerned about this issue. Even if I were too set aside my beliefs about ICE as a general tool of propaganda, there are issues going on with ICE That go beyond what is political and enter into the realm of irresponsibility and civil rights violations.

The irresponsibility and civil rights violations of ICE are bipartisan concerns. Firstly, several unnecessary deaths have taken place as a result of this federal enforcement agency, and it seems that our federal government is trying to sweep these under the rug as unpreventable and appropriate, and if we have the opportunity on a city or state level to deny this lie and egregious use of force, we should.

I think so much of the problem with ICE going way outside the bounds of the law is because there is VERY little accountability or opportunity for recourse in the case that they break laws and violate civil rights. I also find their recruiting strategies appalling as they market the opportunity to wield a gun and "play cops" while making great money and simultaneously not undergoing the training to be a cop or anything remotely close to law enforcement before they are put on the job. Their training is between four and eight weeks, and those who are put on the job are not properly vetted. These are not the right people and they are not trained appropriately to do their job safely. That is the best case scenario. The best case scenario is if I trust their intentions and believe they just want to make money at a government job, and generally speaking I do not trust their intentions because of the beliefs being dispersed among this agency via Kristy Noem. I do not trust an agency that does public facing work, but refuses to show their faces in public so that they can avoid accountability. I do not trust an agency that does not have a structure to hold its agents accountable via badge numbers and body cams. I do not trust an agency that is willing to put failed cops and power hungry men on the street and risk harming US citizens. Welcome to a new year. A year ago, I wrote to our congressional delegation. "Show courage and protect the future of every Montanan" was my message to our Montana congressional representatives on January 31, 2025. Our congressional leaders have abdicated their responsibility to contain executive overreach and protect "We the People". We may be spared armed domination displays unlike our good neighbors because our congressional leaders are complicit and our population mostly white, but we should be supporting our neighboring cities and states and preparing for demands of obedience and more federal dysfunction.

Dear Mayor and Members of the Billings City Council,

I am writing as a Billings resident to respectfully urge the City Council to ensure that the City of Billings and the Billings Police Department do not cooperate with ICE enforcement activities.

Over many years, the Billings Police Department has worked to build positive, trust-based relationships with the people it serves. That trust is essential to public safety. When community members feel safe interacting with local law enforcement—reporting crimes, serving as witnesses, and seeking help—our entire city is safer. Cooperation with ICE risks undermining that trust and undoing years of progress.

In addition, city and police resources are already stretched to the limit. Our officers and municipal services should be focused on addressing local public safety needs, responding to emergencies, and serving the community—not diverting limited time, staffing, and funding to federal immigration enforcement. Such diversion would place unnecessary strain on an already overburdened system and reduce the effectiveness of local services.

I am deeply concerned about the social disruption and community harm we are seeing in other cities, including Minneapolis. The chaos, fear, and damage that follow aggressive

immigration enforcement are not outcomes Billings should invite. Our city has worked hard to foster stability and cooperation, and those efforts should be protected.

I am also particularly troubled by the targeting of Native American citizens in immigration enforcement actions. Billings has a large Native population, and any policies or practices that result in racial profiling or the harassment of Indigenous people are unacceptable. No resident should be made to feel unsafe or questioned about their right to be here based on appearance or heritage.

Local law enforcement exists to serve and protect the community—not to carry out federal immigration enforcement. I urge the City Council to take a clear stand in support of community trust, public safety, responsible use of resources, and the rights and dignity of all Billings residents by refusing cooperation with ICE.
