INCIDENT DESCRIPTION

A structure fire occurred in a mobile home at 1926 Mullowney Lane. The structure sustained significant fire damage throughout the building. A nearby vehicle also sustained significant damage. The responding companies prevented extension of the fire to other trailer units. The initial response included a full structure fire response, including the Battalion Chief, four engines, and a truck company. As the incident was brought under control, units were released back into service.

INCIDENT DESCRIPTION

A fire occurred in a chicken coop behind the garage at 6 Jefferson St. The chicken coop was consumed by fire, which extended to the exterior of the nearby garage. Fire extension was limited to the garage, primarily on the exterior. The initial response included a full structure fire response, including the Battalion Chief, four engines, and a truck company. As the incident was brought under control, units were released back into service. No injuries were reported. The cause of this fire is under investigation.
