February 15, 2011

The minutes of the January meeting were approved on a motion by Julie, seconded by Nancy. Minutes approved.

Agenda Amendment – Lora asked the board permission to add an agenda item to the list. The deadline for the Eugene Carroll and Best Practices nominations were due yesterday, Lora would like to discuss.

Eugene Carroll/Best Practices Nominations – Lora stated that the board received 2 Best Practices Award Nominations yesterday, one for the Oliver Building submitted by High Plains Architects, and the other from Bill Haynes of Collaborative Design Architects, Inc. for MSU-Billings McMullen Hall. Mr. Haynes submitted the award papers but due to the size, photos and narrative will be dropped off to Lora on Tuesday, February 15th. Lora will distribute the information to the board for discussion and decision. Lora suggested that since the board did not receive any Eugene Carroll Award nominations this year that the YHPB might want to honor someone. Lora will send out an email to the entire board to gage interest and potential awardees. There is a phone conference set for Thursday, February 24th; this item could be discussed further at that time.

2011-12 CLG Grant – Lora brought forward to the board the annual CLG grant for 2011-12. The budget remains similar to past years. Lora asked if there were any questions or concerns with submitting the grant, there were none. On a motion by Monica, seconded by Kyle, the board unanimously approved submitting the CLG grant this year.

2011 Work Plan – This was just a reminder that the board in the next month or so will work on updating the YHPB Work Plan. No new projects are identified at this time for addition; it will mainly be an administrative update concerning dates and project status.
