## Summer Construction

It will soon be time for construction to start up again, and you are probably wondering if your area will be affected. Here is a list of the some of the projects that will be going on in the City this summer:

- Calhoun Lane will be reconstructed between King Ave East and Underpass Avenue. The project will start early this spring and run through most of the summer. Local traffic will be allowed, but if you are just going through the area, please try to use an alternate route such as Orchard Lane.
- Poly Drive will be reconstructed between 32nd and 38th. This project is anticipated to begin in June and be finished in the late fall. Local traffic will be allowed.
- The Exposition Gateway area (between 1st Avenue North and 4th Avenue North, east of North 11th Street) will be under construction for most of the summer and fall. The project includes all utilities and street improvements.
- The missing portion of Colton Boulevard between 38th Street West and Avalon will be constructed beginning in the late spring and running through summer.
- Intersection improvements will be done at 32nd Street West and Gabel and at Poly and Virginia.
- Three streets will get a pavement overlay this year: Broadwater Avenue from 16th to 24th, 19th Street West from Broadwater to Lewis, and Poly Drive from Virginia to 13th Street West.
- The annual program to replace ADA ramps is primarily on Grand Avenue and Nutter Boulevard. There will be brief, minimal lane restrictions to accomplish this work.
- Treasure Drive and Shawnee Drive will be constructed.
- A 72" storm drain interceptor will be installed in the East End Industrial Area. The line will be located on 4th Avenue North between North 23rd Street and North 15th Street and then south on North 15th Street to the railroad tracks.
- Water and sanitary sewer lines will be installed on Elysian Road.
- The water line on 17th Street West from Avenue D to Poly Drive will be replaced. Local traffic will be allowed on 17th, but commuter traffic should try to find an alternate route on either 19th or 13th.
- Water line replacements are planned in the local streets east of Will James from Broadwater up to Grand.
- Sanitary sewer replacements will take place in the alleys north of 6th Avenue North and east of North 24th Street to North 12th Street.
- Several trail projects will be constructed this summer. Most will not impact traffic but will add a few new, good connections in our trail system. They are:
  - Arrowhead School Trail
  - Swords Park/6th Avenue Bypass
  - Poly Drive Elementary School Crossing at Arvin Road
  - 19th Street West and Colton Boulevard
  - 44th Street West south of King Ave W.
  - Wicks Lane – far west end to connect to the new Skyway Drive
  - King Avenue West from the BBWA to 32nd Street West
  - Jackson Street Sidewalks



# News from the Parks, Recreation & Public Lands Department



## What is Arbor Day?

Arbor Day is a holiday where individuals and groups are encouraged to plant and care for trees.

It was founded in 1872 by Julius Sterling Morton in Nebraska City, Nebraska. On the first Arbor Day, April 10, 1872, thousands of people participated and an estimated one million trees were planted throughout Nebraska. By the 1920's, each state had passed laws that established a specific date as Arbor Day.

By the turn of the century, President Theodore Roosevelt had become a huge promotor and advocate of conservation, and in 1907 he issued an "Arbor Day Proclamation to the School Children of the United States" about the importance of trees and that forestry deserves to be taught in U.S. schools.

In the spring of 1909, the Billings Gazette reported on a large Arbor Day celebration that was held in Billings. That year, banks, schools, city and county governments, and many private businesses closed for the day to plant trees throughout Billings. At the center of activity that day was

South Park, where over 200 poplar trees were planted. Some of those poplars are still growing in South Park to this day, having reached a great size and age.

On April 25, 2014, Arbor Day was celebrated in Pioneer Park. Over three hundred 4th grade students attended and visited 19 environmental booths hosted by Billings professionals. More than one hundred volunteers helped beautify Pioneer Park; pruning, removing hazardous trees, mulching, revamping planting beds, painting buildings, and planting trees (twenty-one in all). Montana Governor Steve Bullock attended the formal ceremony, telling students that "Arbor Day is about making sure that Billings, Montana, and the country are better tomorrow than they are today."

Billings was presented with the 2014 Gold Leaf Award from the International Society of Arboriculture for the Arbor Day event in Pioneer Park. The award recognized Billings for holding the best Arbor Day event in a four state region consisting of Montana, Wyoming, Colorado and New Mexico.

Arbor Day 2015 will be held in Riverfront Park on May 1, 2015. This year's theme is "Trees — Pathways to Preservation".

Billings will celebrate its 31st year as a Tree City USA. Activities will include park cleanup, tree planting, pruning, mulching and landscaping, environmental education booths for 4th grade students, and the Arbor Day Tree Planting Ceremony.

## Park Planning

Over the winter, Park Planning staff has been very busy preparing for the upcoming construction season. There are a number of exciting projects to be constructed starting this spring. They include:

- **South Park Playground Replacement.** New playground equipment will be installed late spring/early summer that will include a giant climber and a 15 foot slide, among other exciting play features.
- **Pioneer Park Playground Replacement.** Similar to South Park, Pioneer Park will also receive new playground equipment upgrades. It too will have a signature play feature, along with age-appropriate play equipment for children of all abilities.
- **Tennis Court Replacement at Pioneer and Castle Rock Parks.** Four courts at Castle Rock and three courts at Pioneer will be reconstructed with state-of-the-art techniques to provide tournament quality playing surfaces.

Plans are being finalized in order to go out for bidding the end of February, with the goal to be under construction as soon as the weather permits.

- **South Park Spray Ground.** To replace the wading pool removed in 2010, a new spray ground will be constructed this coming summer. Staff is currently working with a consulting group to determine the scope of the work to be done and to secure a contract for design services. The spray ground will be comprised of spray and splashing features for children to play and cool off during hot summer months.

## 2014 Annual Awards Recipients & Nominations

### Officer of the Year: Ben Milam

Officer Ben Milam has been a patrol officer for nearly six years and is frequently sought after by other officers and agencies to assist with investigations and high-risk calls. His "team first" attitude, tactical knowledge, and ability to diagnose potentially unsafe circumstances have made him a recognized leader on his shift. Officer Milam continuously downplays his involvement in day-to-day operations and often gives credit to other officers. He currently serves as a Field Training Officer and is a member of the BPD SWAT Team. Officer Milam epitomizes the caliber of officer that we want patrolling our streets and protecting our citizens.

### Supervisor of the Year: Sergeant Shawn Finnegan

Sergeant Shawn Finnegan has worked for the Billings Police Department for nearly 17 years and has been a Sergeant since June 2008. He leads by example and spends a great deal of his supervisory time being a great role model to other officers. Sergeant Finnegan is the Field Training Officer Supervisor and lead hostage negotiator. He also serves as a member of the Yellowstone Valley Gang Task Force and West End Neighborhood Task Force. He is a solid and dependable sergeant, leader, and investigator. Sergeant Finnegan is a true mentor to all the members of the BPD and a great representation of what a leader should strive to be.

### Employee of the Year: Crime Analyst, Becky Shay

Becky Shay has been the Department's Crime Analyst since November 2011 and has demonstrated that she is an invaluable asset to not only the BPD, but to her community. She sets the standard for enthusiasm and professionalism. Becky approaches her duties as a team player with the mind-set of solving problems to combat the criminal element that exists in Billings. She can be counted on at any time to gather intelligence for an officer to assist him/her with a case and is a valuable resource for the command staff in compiling crime data. Becky takes a pro-active approach in helping others fight crime in Billings. She is a credit, not only to herself, but to the BPD.

### Respect for Law: Officers, Jerry Smidt and Chris Simpson

Officers Jerry Smidt and Chris Simpson have been nominated to the Billings Optimist Club for their Respect for Law Community Award. Officers Smidt and Simpson serve as School Resource Officers to West and Skyview High Schools respectively. Each officer makes an effort to know the members of their student bodies, as well as the staff, in order to foster an environment that allows students and staff to feel comfortable approaching the officers on a variety of topics. Both of these officers have set up in-service training for their school's staff and administrators on gang activity, drugs, graffiti, bullying, and any other con-

cerns unique to their schools. They also do a vast amount of public speaking, educating the community on these topics. Officers Smidt and Simpson are making a huge difference in the lives of the students they serve and are worthy of this award.

### American Legion National Law Enforcement Award: Officer Richard Gilmore

Officer Richard Gilmore has been nominated to the American Legion for its National Law Enforcement Officer Award. He has served as an officer for just over six years and is currently a STEP (Selective Traffic Enforcement Patrol) Officer. His drive and dedication to this program and traffic enforcement has resulted in 713 traffic citations, 776 traffic warnings, 195 arrests, and 55 DUI drivers removed from our streets. Officer Gilmore has conducted 39 school zone traffic details this year and has worked successfully with the Billings City Court to increase the fines for speeding in school zones. He is an active member of the Yellowstone County DUI Task Force and was awarded the Yellowstone County DUI Task Force Award of Merit for aggressively targeting DUI drivers. In addition to his duties as a STEP Officer, he is an active member of the BPD's Downtown Bike Program. Officer Gilmore is always willing to put in the extra hours needed and is an asset to the department.

# From Our Readers

## Comments from an anonymous Billings reader:

I liked all of the newsletter. What do the schools do with the left over money as shown in the Billings Gazette?

### Answer:

The CityLink staff thought this might be a great time to reiterate what the City is responsible for and what we can and cannot address in this publication. The City is responsible for many departments and services, but cannot provide answers to questions that pertain to County, State or Federal agencies. The City also cannot address questions regarding the school district and their policies. The School District is a separate governmental division, so your question should more appropriately be addressed to the District. Thank you for reading!

## Comments and questions from an anonymous Billings reader:

What is the subsidy that taxpayers pay for each rider on the transit system (including the cost of benefits for the drivers)? Also, I think the roughest streets in Billings are — Grand, between Rehberg and 32nd, and the new construction on Rimrock Road and Broadwater Avenue.

### Answers:

A recent study identifies MET's fully allocated cost per ride (wages, benefits, fuel etc.) at \$6.28. The revenue breakout includes:

- 48% - Federal/State Subsidy
- 39% - Local Subsidy
- 10% - Fares
- 2% - Other

Broadwater Avenue is going to be re-surfaced this summer. The City has always planned the re-surfacing project, but wanted to wait until the utility project was completed. During the summer of 2016, Grand Avenue will be re-surfaced in conjunction with the project to widen Grand Avenue from Zimmerman Trail to Shiloh Road. There was some settlement around manholes on Rimrock Road. The City has been working with the contractor to have the settlements corrected through the project's warranty. The City will continue to monitor Rimrock Road.

## Comments and questions from an anonymous Billings reader:

I like to be kept informed through this newsletter. I like knowing what the City is working on and what is coming up. I liked the water report in the most recent issue. I would like to know why utilities have to be placed in the driving lanes instead of the least-used turn lane in the middle of the road?

### Answer:

Regulations require separation between utilities. For instance, a water main must be separated by at least 10 feet from a sanitary sewer main and a storm drain. Taking into account that there are typically other utilities within a street (i.e. gas and communication lines); there is simply not enough room within a turn lane to fit all of the utilities. We also have situations where manholes or water valves were in the center of a driving lane when it was a 2-lane or a 4-lane street, but when the street is widened to 3-lanes or 5-lanes they end up in the wheel path. In these situations, it is not feasible to relocate the underground utilities just because the lane layout is changed. While we agree that it is desirable to keep manholes and water valves outside of the wheel path, it is not always possible to do so.

## Comments and questions from Edeen Linsky of Billings:

I find the entire newsletter to be informative. It keeps me informed on what is happening in the City. I'd like to see the in-depth code on snow removal. What are the business responsibilities (i.e. the public sidewalks in front of businesses)?

### Answers:

To answer your specific question regarding business owner responsibilities for snow removal — if an owner refuses to remove snow/ice from the public sidewalk or pushes snow onto public property, then the recourse for enforcement is a Municipal Infraction citation. For more information, please contact Code Enforcement at (406) 237-6146.

Here is the entire section of City code, as you requested: Sec. 22-406. Removal of snow, ice, etc., from sidewalks by abutting property owners. (a) It shall be the duty of the occupant of any premises within the city limits, or in case such premises are unoccupied, then the owner or his or her agent, to keep the sidewalks in front of and adjoining his or her premises clean and safe for pedestrians, and to

repair the same from time to time; and such occupant, owner or agent shall remove snow, ice, mud, slush and other impediments for safe and convenient foot travel, within twenty-four (24) hours after such snow, ice, slush or other impediment accumulates thereon, and prevent the continuance and accumulation of the same. Accumulations of snow and ice upon sidewalks fronting property owned by persons not residing in the city, shall be removed under the direction of the city which shall keep a record of the cost of such removal with a description of the property adjacent to which such snow and ice are removed. Each year, the city clerk shall prepare and present to the council, on or before the second regular meeting in September, a resolution containing a list of all lots and parcels of land in the city from the sidewalks adjacent to and fronting on which snow and ice have been removed, with the names of the owners thereof, and the cost of removal of such snow and ice. When such resolution is passed by the council and approved by the mayor, the assessments therein provided for shall constitute a lien upon and against such lots and parcels of land. A copy of such resolution shall be certified by the city clerk to the county treasurer for collection in the same manner as other taxes. (b) It is unlawful for any person to dispose of or move snow from private property onto a public street, alley or sidewalk. (Code 1967, § 10.84.080)

## Comments and questions from Carole Baumann of Billings:

I liked the Parks articles, the Library news and the Solid Waste articles with bullets and chart of schedules and costs. I'd like to see more information about hazardous waste disposal: What to do with pills, paint, etc. I'd also like to see information about savings from improvements, like updates on natural gas collected from the Landfill. What food garbage should go in the trash? Isn't that better than going down the garbage disposal? Would food waste help to make natural gas?

### Answers:

Thank you for your suggestion. Staff has included some information regarding hazardous waste and medication disposal in this issue of City Link. Watch for more information in the issue this summer.

# Billings Crime Prevention Center

Housed at 2910 3rd Ave. North in downtown Billings, the Crime Prevention Center has several different teams to choose from, including: Volunteer Patrol Unit, Report Writing Center, and in the spring and summer months — Volunteer Bike Patrol.

“It involves a real purpose since the City can’t afford to perform the duties we need to perform,” is how Jim Keeling describes volunteering with the Volunteer Patrol Unit. “It also involves a lot of fun and a sense of pride interacting

with my fellow volunteers and citizens who appreciate what we do.”

The group patrols the City in teams of two or more, giving parking tickets, tagging/towing abandoned vehicles, documenting graffiti, and assisting with traffic control at local events.

The Report Writing Center volunteers contact victims of crimes, such as vandalism and theft (home, auto, and graffiti), and lost/found property. This contact allows officers on duty to attend to urgent issues while volunteers give victims their undivided attention gathering statements and important crime details. Tina Walker describes her work as, “A great way to help people around town, while you hear what’s going on and where.”

Riders for the Volunteer Bike Patrol participate in a training course to learn riding techniques, along with observation and reporting skills. “It’s just plain fun,” states Lon Woodbury of his volunteer experience as an ambassador of the Billings Police Department. Riders are often greeted with smiles and sincere expressions of thanks from citizens while on patrol.

Each group also participates in different functions at local events such as: Heart & Sole Run, Relay for Life, Strawberry Festival, Harvest Festival, and many more!

## Hazardous Waste & Medication Disposal

The Billings Solid Waste Division is no longer sponsoring an annual Toxic Trash Round-Up. However, residents living within Yellowstone, Carbon, Treasure, Musselshell and Stillwater counties, as well as residents of the towns of Pryor and Big Timber, can bring **household** hazardous waste directly to the Billings Regional Landfill, 5240 Jellison Road, where it will be sorted, bulked and shipped to appropriate disposal sites.

As with the Toxic Trash Round-Up, acceptable wastes include latex and oil-based paint, garden chemicals, household cleaners, and used oil and antifreeze.

The landfill does not accept business-generated hazardous waste at this time. Businesses in need of hazardous waste disposal can contact Beartooth Environmental at (406) 373-2220 or Mountain States Environmental Services at (406) 248-4777, for local assistance.

The Billings Police Department has five medication drop-off sites for over-the-counter and prescription medications (NO liquids or needles) at the following locations:

In addition to contributing methane to a Montana Dakota Utilities (MDU) pipeline located next to the landfill, the primary benefit of the MDU landfill gas facility is keeping the landfill in compliance with state and federal air quality regulations.

The facility will play an even greater role when newly proposed federal regulations are enacted requiring control of landfill greenhouse gas emissions. And yes, food waste decomposition contributes to methane production at the landfill.

## Building Codes & Standards

After several years of fine-tuning the International Residential Building Codes, the State of Montana adopted the 2012 International Building Codes. As per City Code, the Building Division must adopt the Codes as well. The last residential edition that was adopted was the 2006 Edition. The 2009 IRC edition was not adopted because fire sprinklers were required in all new single-family construction. This requirement was not included in the 2012 edition.

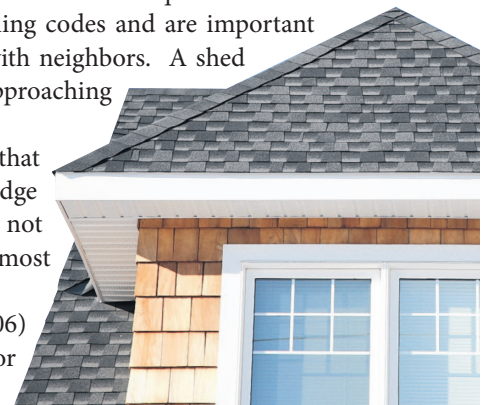
The following is a list of Building Construction Codes that are used in the City of Billings. They went into effect on February 7, 2015 (all 2012 Editions unless otherwise noted):

- Uniform Plumbing Code
- International Mechanical Code
- International Fuel Gas Code
- International Existing Building Code
- International Energy Conservation Code
- National Electrical Code
- 2014 Edition
- International Fire Code

How do the 2012 codes affect the citizens of Billings? Not too much, however, to those in the building trades, it affects their business in many ways. The most notable change to the everyday citizen is that a building permit is no longer needed to build a storage shed that is less than 200 square feet in size. This could be complicated however, as there are other restrictions such as lot coverage and set-back requirements that must be met regardless. These are Planning and Zoning codes and are important to adhere to in order to avoid conflict with neighbors. A shed could also block clear vision zones for approaching vehicles in alleys or streets.

Another residential building code that has changed is the requirement of drip edge on new roofing projects. Drip edge was not required in the 2006 IRC, although most roofing companies install it.

This year, the Veterans Memorial Service will start about 9 a.m. on Memorial Day. It will follow a Veterans Parade that will start in the southern part of the Cemetery about 8:45 a.m., and will head north to the main veterans area near front entrance.

# Reporting a Crime

Many citizens have the misconception that reporting a crime at the downtown Police Department will get them faster service. This is not necessarily the case.

Police Officers are assigned to a "beat" or section of the City in which to patrol. When a person walks into the Police Station to report a crime, the officer from the beat in which they live has to be called in to take their report.

Requests for an officer to report to the Police Station to take a report from a citizen are considered "cold" calls, as opposed to an "in-progress" call, and take much longer for the officer to respond to.

In some cases, a citizen will end up waiting for hours for the officer to get a break from "in-progress" calls in order to respond to their "cold" call.

For the citizen's comfort and convenience, Police Department staff recommends that calls to dispatch to report any crime ("in-progress" or "cold") be done from their home or, if necessary, their work location. That way, a citizen can wait for the officer to respond while continuing on with their day.

Please be aware that "in-progress" calls will always take priority over a "cold" call.

Many calls do not require an officer to take the call. If a citizen needs to report a minor crime (such as theft of a purse or an item from your vehicle) and does not have suspect information, those calls can be reported to the Crime Prevention Center by calling (406) 247-8590. A volunteer will take the information and the report will be filed with the Police Department.
