**A RESOLUTION ALLOCATING TAX INCREMENT FUNDS FOR HOUSING  
FEASIBILITY STUDY.**

WHEREAS, The City Council of the City of Billings adopted the Downtown Billings Framework Plan as a modification to the Billings, Montana Downtown Redevelopment Plan and

WHEREAS, The Downtown Billings Framework Plan includes housing development as a major goal and

WHEREAS, The Downtown Billings Partnership (DBP) Board of Directors has recommended that up to \$50,000 be allocated for Housing Feasibility Studies,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BILLINGS, MONTANA, AS FOLLOWS:

1. The DBP is hereby authorized to spend up to \$50,000 for Housing Feasibility Studies within the Billings Downtown Redevelopment District.
2. That the expenditure of funds is approved from the City's Tax Increment Financing Fund and the City Administrator is authorized to release those funds upon receipt of appropriate documentation.
4. EFFECTIVE DATE. This Resolution shall be effective upon adoption.
