A RESOLUTION OF THE CITY COUNCIL AUTHORIZING THE CITY ADMINISTRATOR, ASSISTANT CITY ADMINISTRATOR OR DEPUTY CITY ADMINISTRATOR TO SIGN DOCUMENTS ON BEHALF OF THE CITY IN LIEU OF THE DIRECTOR OF ADMINISTRATIVE SERVICES

BE IT RESOLVED By the City Council (the "Council") of the City of Billings, Montana (the "City") as follows:

Section 1. Recitals.

1.01. Pursuant to Resolution No. 03-18043, adopted by the Council on November 24, 2003, the Mayor, City Clerk and Director of Administrative Services are the officers of the City authorized to sign documents related to the City's \$10,200,000 Higher Education Revenue Note (Rocky Mountain College Project), Series 2004 (the "Series 2004 Note"), on behalf of the City.

1.02. The City is currently in the process of issuing the Series 2004 Note as well as working on several other bond issues.

1.03. The position of the Director of Administrative Services has been retitled "Deputy City Administrator" and is currently vacant.

Section 2. Authorization to Sign Documents. The City Administrator, Assistant City Administrator or Deputy City Administrator is authorized to execute and deliver documents or certificates on behalf of the City in lieu of the Director of Administrative Services relating to the Series 2004 Note and any other on-going bond issues of the City.
