

RESOLUTION 04-18207

A RESOLUTION OF THE CITY OF BILLINGS AMENDING RESOLUTION NO. 04-18065, A RESOLUTION CREATING EXTENDED SPECIAL IMPROVEMENT MAINTENANCE DISTRICT NO. 4024 IN J & E SUBDIVISION FOR THE PURPOSE OF MAINTENANCE OF PARK IMPROVEMENTS AND REDESIGNATING THE DISTRICT AS PARK MAINTENANCE DISTRICT (PMD) NO. 4024.

WHEREAS, on January 12, 2004, the Billings City Council approved Resolution No. 04-18065 creating Extended Special Improvement Maintenance District No. 4024 after appropriate legal notice and public hearing was conducted; and

WHEREAS, the Resolution No. 04-18065 contained an incomplete exhibit containing the ownership records of all properties within the Park Maintenance District; and

WHEREAS, the Extended Special Improvement Maintenance District is more appropriately designated as Park Maintenance District (PMD) No. 4024; and

WHEREAS, these amendments to Resolution No. 04-18065 do not affect the previously provided due process and public hearing participation rights of all owners of properties within the District; and

WHEREAS, it is the desire of the City Council and the intent of this Resolution to correct the ownership records described as Exhibit "C" attached to Resolution No. 04-18065; and

WHEREAS, it is the desire of the City Council and the intent of this Resolution to re-designate Extended Special Improvement Maintenance District No. 0424 as Park Maintenance District (PMD) No. 4024; and

WHEREAS, no other sections or portions of Resolution No. 04-18065 are being amended.

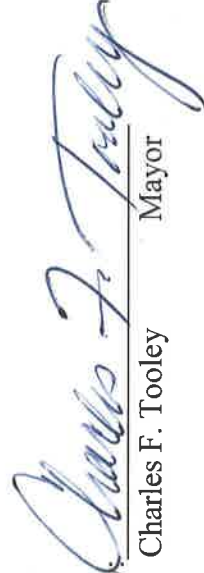

3. No other sections or portions of Resolution No. 04-18065 are intended to be amended and therefore all other provisions of Resolution No. 04-18065 remain in effect subject to the amendments contained herein.
